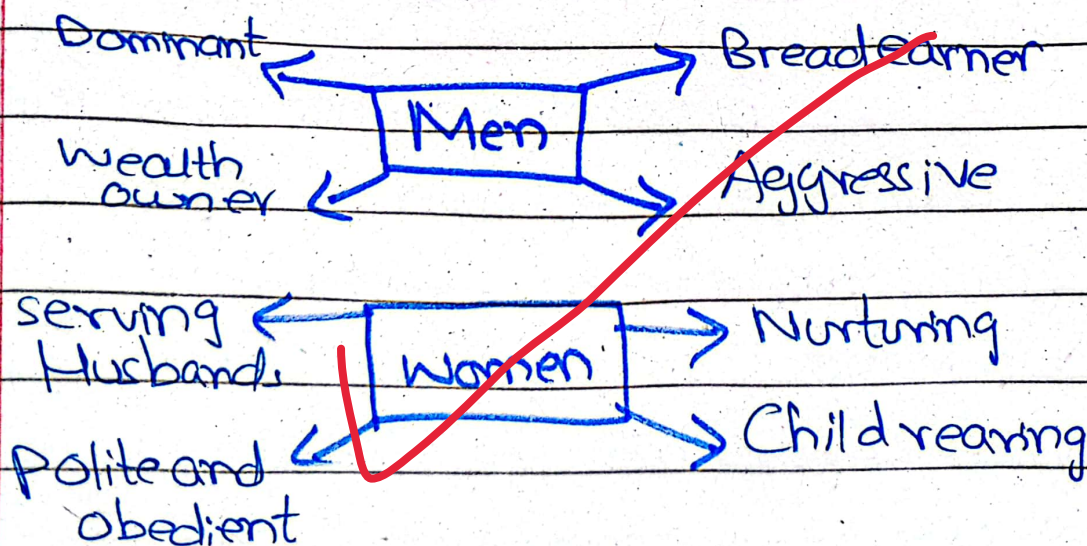


## Political Participation

Men were the slave of capitalist men. While, women were treated as slave by the slave men. Women were doubly subjugated.

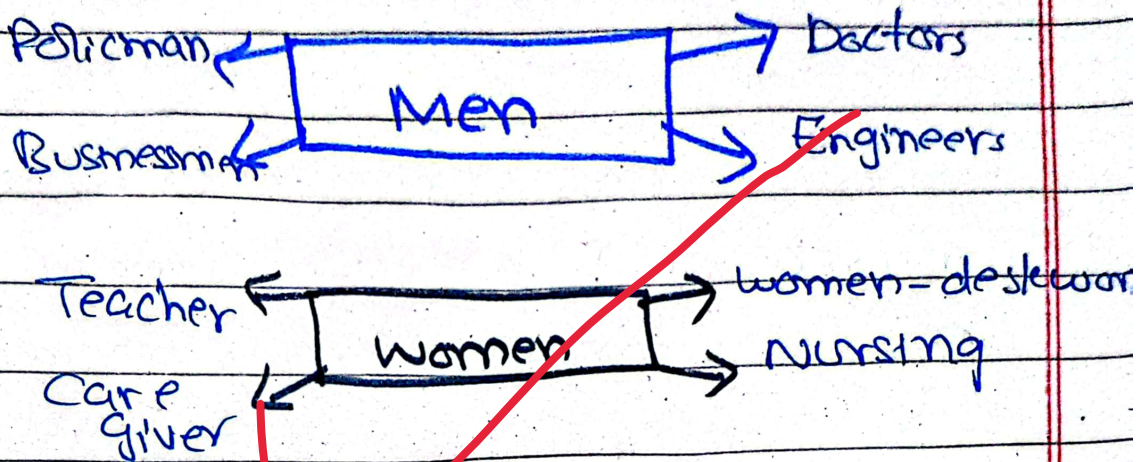
## Domestic Violence

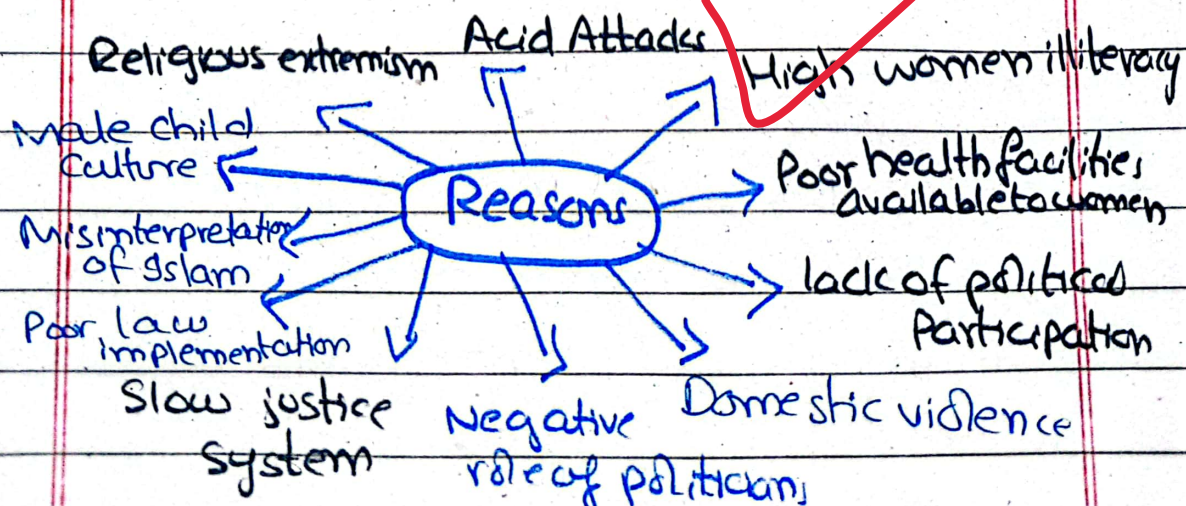

## High Women Illiteracy

High women illiteracy in Pakistan is one of the major hurdle in achieving gender equality in Pakistan, It unable women to become economically independent.

According to the Economic Survey of Pakistan 2023-24, male literacy level is 71.5% while female literacy is at 58.1%. This gap highlights the negative situation of Pakistan.

## Poor Health facilities for women

In Pakistan, women are deprived of basic health facilities. It is resulting in numerous illness in the women of Pakistan.

## Lack of Political Participation

There is a lack of women's political participation in Pakistan. It restricts them to reach parliament and do pro-woman legislation. In the 77 years history of Pakistan, only one woman "Benazir Bhutto" has become prime minister.

## Domestic Violence

In the presence of domestic violence, it is difficult for Pakistan to achieve gender equality. According to UN Commission for Human Rights, 40% women in Pakistan are victims of domestic violence.

## Negative role of Politician:

Pakistani politicians biased attitudes towards women is another hurdle of achieving

gender equality. The parliamentarian Khwaja Asif called Shireen Muzari "Tractor Trdi" in Parliament. Such harsh comments of politicians represent their constricted mindsets.

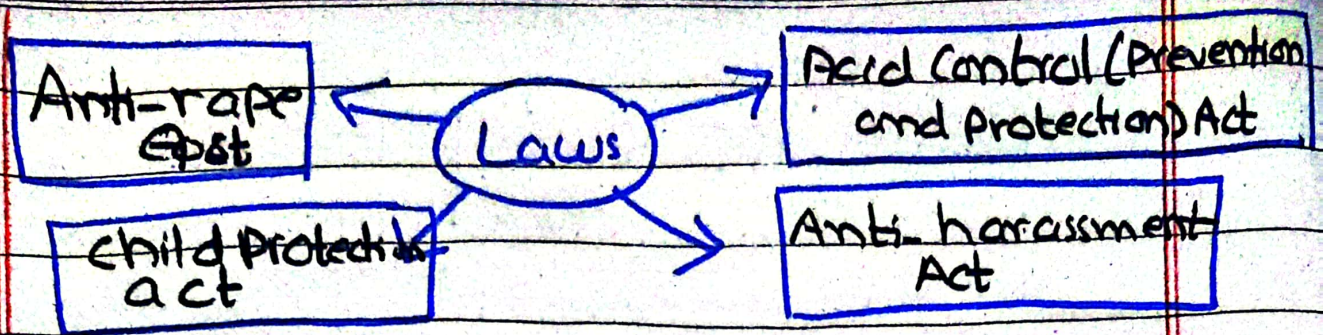
### Slow Justice System

## Religious Extremism

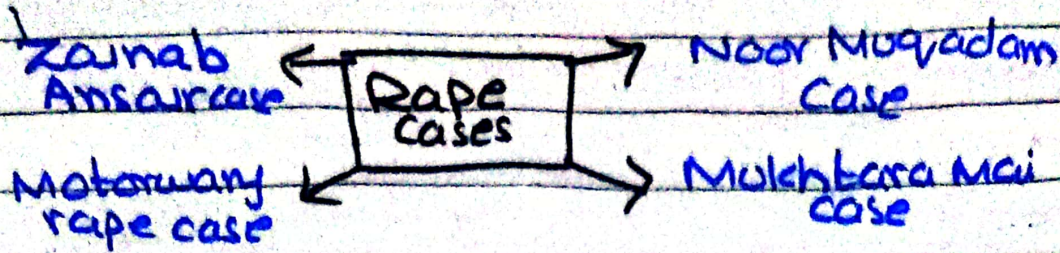
Religious extremism

Seneca falls convention were held in 1848 in which declaration of sentiments was passed that raised the issues faced by women.

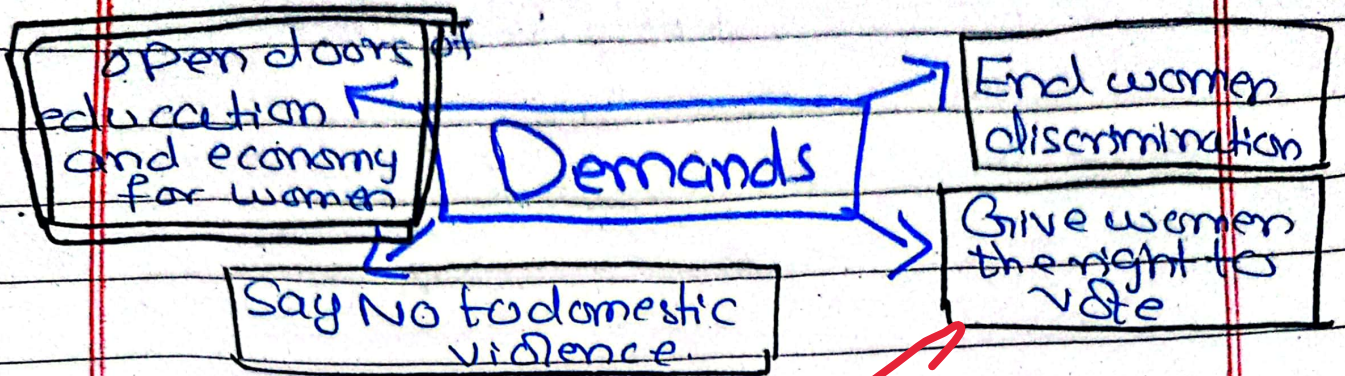
2) Vindication of The Rights of women
