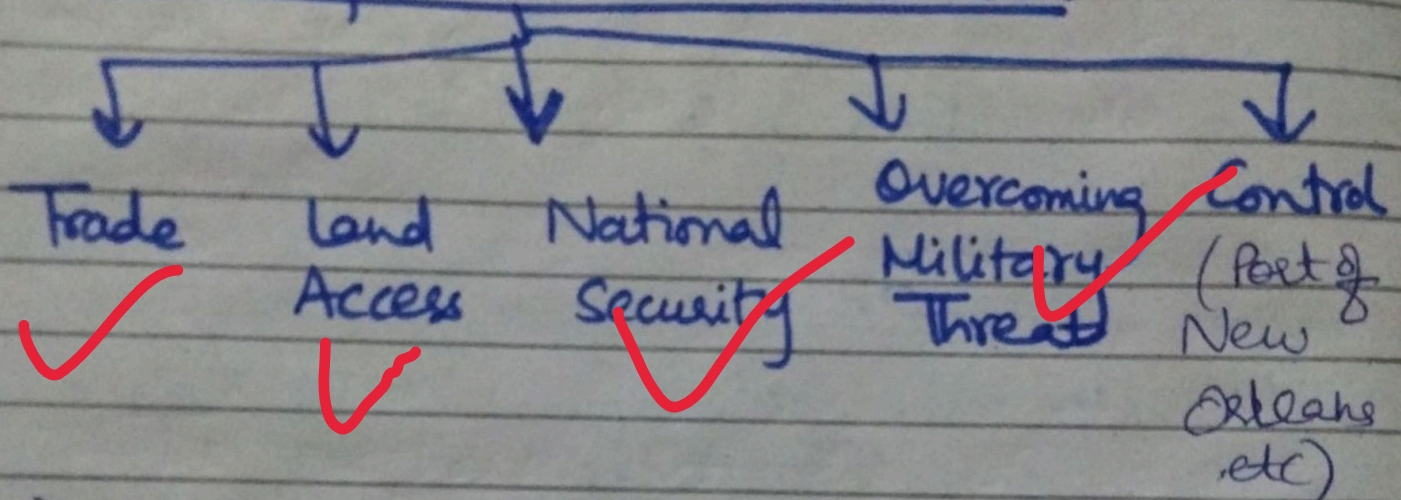
### Background of Louisiana Purchase:-

In 1800, France acquired Louisiana from Spain and in 1802 took its possession. Napoleon Bonaparte's plans to revive the French empire in the New World threatened the situation, so he offered to sell the territory to the US for \$15 million. At that time, President Thomas Jefferson sent Robert R. Livingston and James Monroe to France in order to negotiate



the purchase. There were several reasons that motivated US to purchase it:-

### Causes of Louisiana Purchase:-



Due to the above factors, Louisiana Purchase occurred. The treaty was signed in Paris on May 2, 1803. The senate ratified it on Oct 20, 1803.

### Role of Louisiana Purchase in shaping US:-

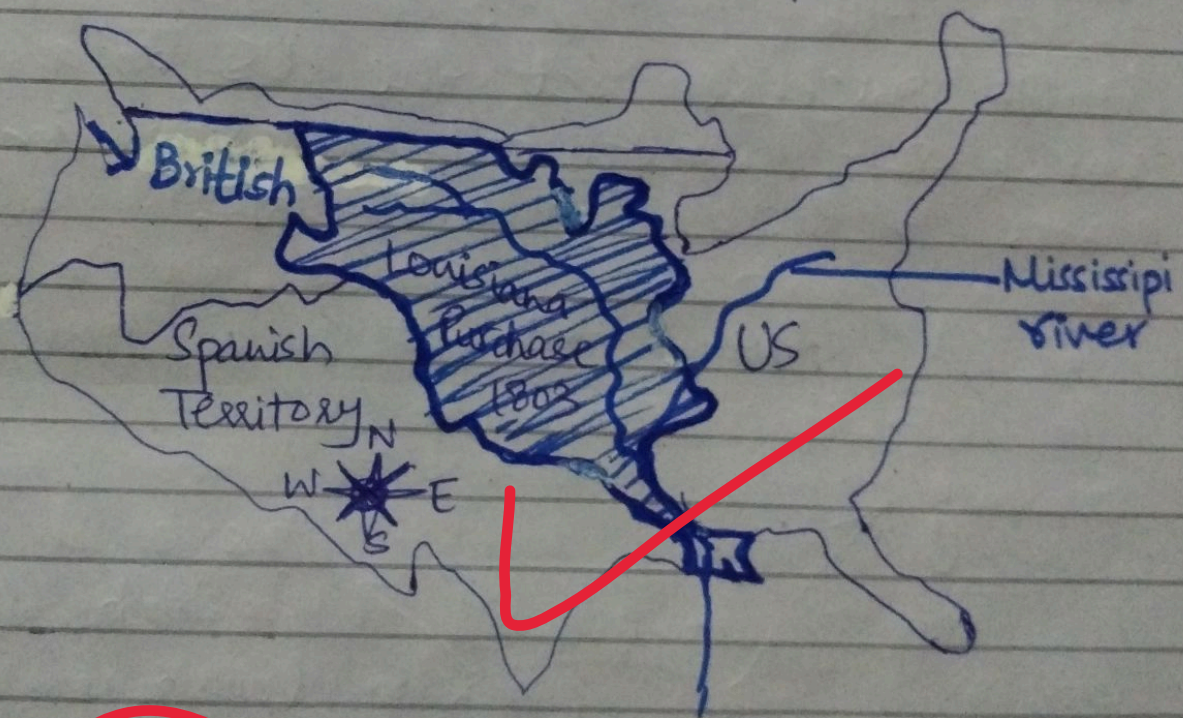
This purchase was a key event in Jefferson's presidency, in many ways.

## Accomplishments:-

### 1- Financial Stability:-

He addressed the ~~the~~ issue of

Secretary. Their financial plan

of a national bank, which  
laid the foundation for  
a stable economy.

### 2- Establishing the Executive:-

He established the executive  
branch by creating a cabinet  
along with the departments  
like Treasury etc. This was  
the initial step towards governance.

### 3- Suppression of Whiskey Rebellion:-

At domestic level, Washington



showed the strength of the federal authority by ~~the~~ taking action against the Whiskey Rebellion. The rebellion was cracked down, soon by the government.

#### 4. Foreign Policy:

He maintained neutrality during the era of French Revolution. He maintained diplomatic success in Jay Treaty with Britain and the Pinckney Treaty with Spain. In this way, he was able to secure favorable trade agreements and resolved disputes.

#### 5. The Two-Term Tradition:

Washington set the criteria of two term for a president. He wanted to ensure national unity. Therefore he decided to step down after serving as a two term president.

### b) U2 Incident:-

The U2 Incident happened in



May 1960 during the Cold War. In this event, a US U-2 spy plane was shot down over Soviet airspace which led to a tussle between the US and the Soviet Union.

The U-2 Incident happened during a period of intense political and military rivalry. In other words, it was characterized as an era of arms race.

### • Eisenhower's Acceptance:-

The U-2 spy plane was a high-altitude aircraft designed to collect intelligence data from Soviet territory. Write it's significant instead

During the accident, the pilot Francis Gary Powers was shot down. In the beginning, these flights were carried secretly.

Later on, US president Eisenhower under great pressure had to accept the claim of the existence of ~~the~~ this spy program. However, he defended the flights



as vital for national security besides expressing that it was a mistake.

## Impacts of U-2 Incident:

The incident led to the cancellation of ~~the~~ a summit between Khrushchev and Eisenhower. In fact a set back to ~~the~~ ease Cold War tensions. Second, this incident eroded trust between two nations.

'Go West Young Man!' is a phrase associated with Horace Greeley, an influential American journalist and editor of the New York Tribune in 19th century. The reason for this association was his support for western expansion and the spirit of Manifest



Destiny. In reality, he never used these words for himself.

## • Causes of Popularity of this Phrase:

### 1- Economic Factors:-

The rapid industrialization of the East led to a saturation of jobs in market. So west expansion was a best solution to the problem, in the 19th century in North America.

### 2- Manifest Destiny:-

It was a 19th century doctrine which held the view that US was divinely ordained to expand westward across the land from Atlantic to the Pacific Ocean.

## 1- Indigenous Displacement:-

The westward expansion happened at the cost of Native American population. According to historian Francis Paul Prucha in his book "The Great Father: The United States Government and the American Indians", he suggested that the expansion "brought profound changes to Indian life, often devastating consequences."

## Woodrow Wilson's Foreign Policy and the Challenges of Neutrality in World War I:-

Wilson was a democrat who brought a unique vision to the foreign policy of America, after 1913. He brought positive elements in the foreign policy:-

### 1- Wilson's Ideal Foreign Policy:-

He wanted to ensure peace, ~~self~~ ~~sovereign~~ self determination and justice for all nation states. He wanted to resolve international conflicts through diplomacy instead of force so that they can be a sole model for others.



## • Challenges to Neutrality:-

### 1- Divided Public Opinion:-

The American public was divided into segments on one the war. Some of ~~a~~ British descent favored with British as an ally. While ~~some~~ others of European descent preferred neutrality policy. This divided opinion became a challenge for Wilson to unify the nation. (Arthur S. Link in his book Woodrow Wilson).

### 2- Economy:-

The US has strong relations with both the Central ~~per~~ powers (Germany, Austria etc) and the allied powers (Britain, France etc). According to Ernest R. May in his book, "The World War and American Isolation, 1914-1917",

"American trade with the Allies soared during the war, while trade with Germany plummeted."



~~The~~ This economic interdependence created a biased approach in the foreign policy.

### 3- German Submarines-

Germany's use of unlimited submarine against allied shipping was another threat to American neutrality. ~~Foreign~~ At that time, the sinking of a Lusitania, a British passenger liner carry American citizens in 1915 outraged public response and lead to the entry of US in war.

### 4- The Zimmermann Telegram:

In 1917, the interception of the Zimmermann Telegraph created an alliance with Germany with Mexico against US which ~~so~~ affected US neutrality policy.
