## INTRODUCTION

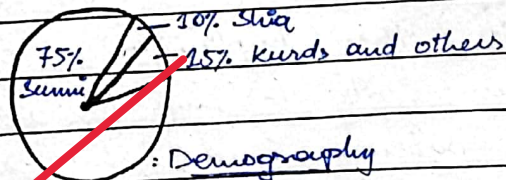
### 3 REASONS BEHIND THE FALL OF DAMASCUS:

#### 3.1 IRON-HAND RULE:

Al-Asad family has ruled over Damascus for 54 years approx. In this rule, fundamental human rights, freedom, economic stability have remained a distant dream. To put things in perspective, the rebels emptied private jails of Asad and found an 11-year old in it. (-BPC).

#### 3.2 THE CURB OF MAJORITY:

Asad and his family are Shia Muslims that ruled Sunni majority without even their consent. This created distrust for decades between the people and their rulers.



#### 3.3 DECADE LONG UPRISING:

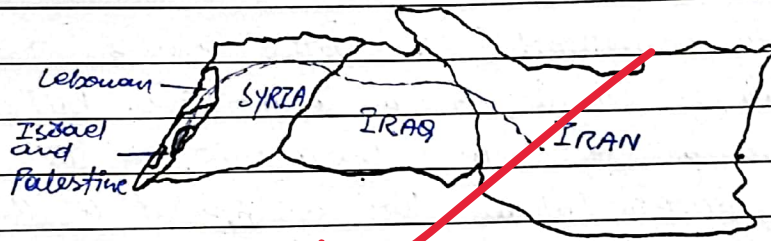
Back in 2011, there were protests going on inside Damascus and Arab Springs. A 13-year old boy, Ibrahim, casually wrote 'Now, it's your turn, Doctor!'. The line is high/lighting towards Asad as he is also a doctor. Resultantly, Ibrahim along with his friend - all winners - were taken by Syrian forces. After physical



and mental torture, they were released, but the event created so much chaos that HTS emerged. Since then, HTS was fighting for Syrian liberation backed by Turkey, ISIS and Al-Qaeda.

### 3.4 ON-GOING ISRAEL WAR:

In contrast of HTS, Assad government is controlled or influenced by Iran. Through Syria, Iran aids its proxy Hezbollah in Lebanon and Hamas in Gaza.



Since October 7, 2023, Israel is engaged in proxy wars and so is Iran. Leadership of Hamas, Hezbollah has also been killed. On the other hand Russia is busy in Ukraine as well. Owing to these reasons, it was perfect time for HTS to topple Assad.

### 3.5 Change of US Regime :

It is also a major reason as Trump has given warning to Tel Aviv to clean-up this mess by January 20, 2024. Like his earlier rule, Trump will go hard on Iran and try to create peace in Middle-East. Hence, clipping Shia govt. wings in middle-East is the first step.

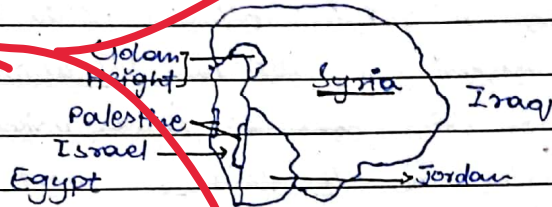
PROXY WARS WILL CEASE TO EXIST:

### 3.1 UNIPOLARITY TO MULTIPOLARITY :

The rise of China in 21st century has proved that this world is too big to have single superpower. The Eastern wing, China-Russia, are dominating side-by-side USA economically, politically and militarily. This will create tensions in the west. USA for years desperately militarizing Pacific ocean for this region.



### 3.2 INFLUENCE OF USA IS DIMINISHING:

A super power is like a big brother of all as Ottoman Empire once was. USA has lost its glory amid Gaza war. The blind support to Tel Aviv has done more harm than good. This was seen in recent UN security council ceasefire voting. The UNSC ceasefire seized to be acted upon by USA's veto with 1/25



vote, making it alone standing on the other side of the ground. Not even its allies, France or UK, voted in favour.

### 3.5 Internal conflicts also ignited in USA:

There goes a proverb, "before managing external threats, set your own house in order." The on-going Gaza war, inflation and diminishing diplomacy role of USA has made its people stand against state's policy. Therefore, Trump's 'Make America Great Again (MAGA)' mantra worked too. 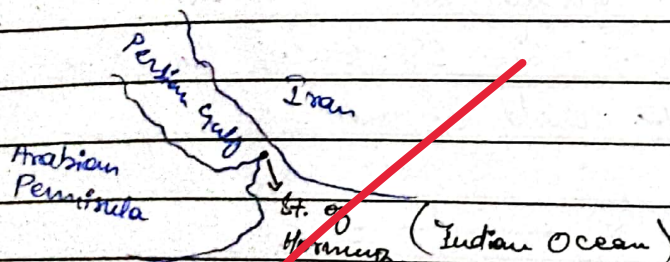
## INTRODUCTION

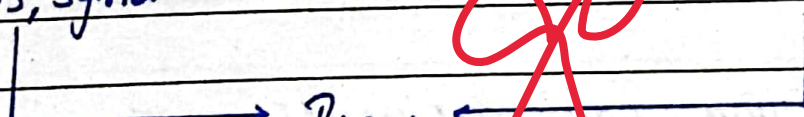

### 1. INTRODUCTION

Pakistan holds a strategic position in Asia as it is at the crossroads for central Asia at one hand while a pathway to touch warm waters on the other end. This boon of Pakistan will fully be utilized in the form Belt and Road Initiative (BRI)'s flagship project China-Pakistan Economic Corridor (CPEC). CPEC will make Pakistan a prominent state in world affairs on the bases of trade and commerce. Unfortunately, there has been a delay in its implementation. There are various reasons behind snail-paced progress of CPEC. Both countries need to take pragmatic actions to counter it. After all, this project is capable to make Pakistan self-reliant.

### 2. REASONS BEHIND SLOW-PACE OF CPEC

#### 2.1 POLITICAL INSTABILITY IN PAKISTAN:

Every political leader in Pakistan comes with his own ideas and ambitions. This results in the halt of ongoing projects. Lack of political consensus cause projects like CPEC to stand still at the mercy of political will.



## 2.2 SECURITY PROBLEM:

The emergence of de facto government in Afghanistan since 2021 gave safe heavens to terrorist such as Tehreek-e-Paliban Pakistan (TSP). This made them attack CPEC developments such as on its western route and hide in the mountains or cross Durand line. Balochistan Liberation (BLA) has also been a problem for Pakistan. Recently, two engineers killed on Jinnah International Airport, Karachi by BLA, making CPEC pipe dream.

## 2.3 IGNORANCE OF ESTABLISHMENT:

The negligence and ignorance of Pakistani elites and establishment has deteriorated the situation in Balochistan. The province capable of feeding whole Pakistan is in distress under militants, landowners and politicians. This prevents the utilization of Gwader port, world's deepest port. Also, many right movements such as Baloch Yakjeeti movement halt CPEC.

## 2.4 Role of India:

India reportedly funds BLA in Pakistan to create emergencies. The capture of Kalkashan Yachar is its example. India even planned to develop Chahsbahar port of Iran intentionally to make it opponent of Gwader. IMEC by India also shows the desperation of India to counter CPEC.



## 2.5 RELIANCE OF PAKISTAN ON USA:

Reliance on USA has always exploited Pakistan's domestic and foreign policy both. In the case of CPEC, USA knows that it is a game changer, the benefit of which will be enjoyed by China. The threat of multipolarity forces USA to influence Pakistan to focus on CPEC.

## 3. POSSIBLE SOLUTIONS FOR CPEC CONTINUATION

### 3.1 WORK ON SECURITY:

Pakistan needs to work on security situation with China. Shanghai Cooperation Organisation (SCO) is its answer. More than 90 percent of border disputes are done by SCO-RATS, along with countering of militants. Comprehensive framework is necessary for the CPEC.

### 3.2 POLITICAL CONSENSUS:

It is the need of the hour as without internal stability, progress will remain a distant dream. All the political parties need to agree on CPEC as a project of 'national interest'. Once done, following the same trajectory, Economic consensus can also be built with CPEC as uncompromised project.



### 3.3 ADDRESS LOCAL PEOPLE:

The multistage development is necessary for the stability of CPEC. The cry of the people of KP and Balochistan must be addressed. Their share in the pie must be given and opportunities should be opened for all. After all, routes of CPEC pass through these surgency-ridden provinces.

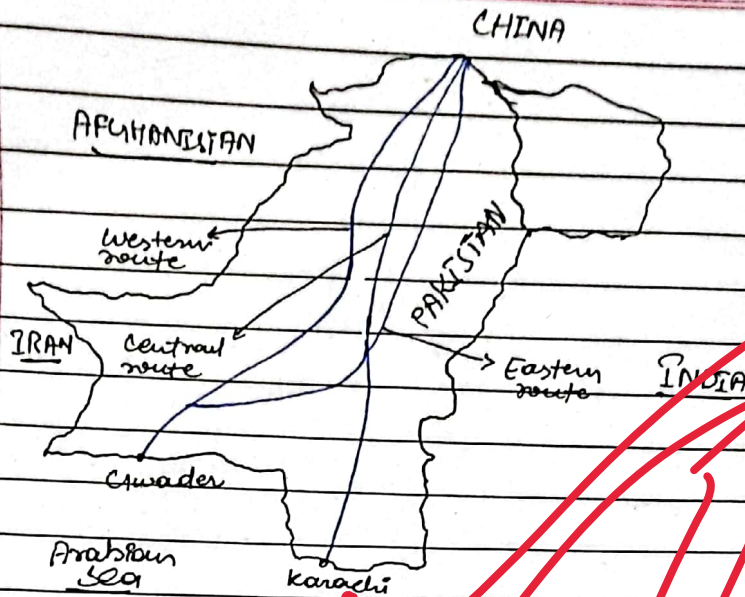
### 3.4 Intelligence-based operations:

This step is essential to curb the influence of India. The separatist movement must also be addressed. The one with threat perception must be dealt with from-hand.
