control of Assad family for the last 50 years almost.

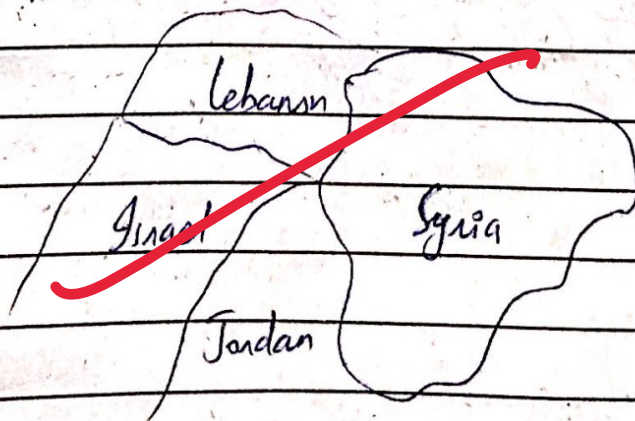
⇒ Assad's father:

Reasons of Unprecedented change in Syria:

⇒ Weakening of Russia:

⇒ weakening economy

Russia's economic might has been worsened badly due to the war. Due to this very reason, Russia's economic support to Asad's government declined.

⇒ lesser military support:

Due to Russia's weak economic conditions, it wasn't able to provide further military support to Syria.

⇒ Role of US sanctions:

US sanctions on Russia had further reduced its ability to fund any war.

⇒ lesser support from Iran:

Iran was also supporting

Asad's government due to Shiite ideology. But, currently Iran was also not able to support Syria further.

⇒ Sanctions on Iran:

US sanctions on Iran had hit Iran badly, and due to this, its economic might was not that strong enough to fund war in Syria.

⇒ Role of Gaza Conflict:

Iran has already been engaged in Gaza conflict indirectly by supporting Hezbollah and Hamas to some extent. Its economy was not allowing to engage in another war front.

⇒ Weakening of Hezbollah:

Hezbollah - a key ally of Asad's regime - had also crippled down in Gaza conflict. Due to this very reason, it was also not in the position to support Asad's regime further.

⇒ Turkey's support to Rebel group:

Turkey had played a key role by

⇒ Internal Reason:

Asad and his brother had also not been united in his decision making, which also played a key role. This can be proved by the fact, that after the regime change, Asad and his family took asylum in Russia, whereas, his brother took asylum in Iran.

⇒ Strengthening of Rebel group:

HIS which separated itself earlier from Al-Qaeda, gained strength when Assad didn't completely wipe them out. Slowly, they trained themselves and comeback with a stronger military fight.

⇒ Taliban's Influence:

Seeing that Taliban had also regained control over Afghanistan after the US war, they thought they can also do the same.

⇒ Hope for Rebel groups all over the world:

* Introduction:

* Background:

US dominated the world after the world war-2 especially by taking certain steps which are mentioned below:

=> Dollarization of world's trade:

=> US took control of the world by signing a deal with them that US would print dollar against gold, and rest of the countries would print their currencies against dollar.

This led to dollarization of state banks of the countries.

=> US also signed with world's leading petrol producing countries especially KSA, to export its oil in dollar. This

converted major chunk of world's trade into dollar.

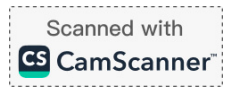
=> As a result, both world's trade major chunk i.e: oil and countries banks started to convert their reserves to dollars.

=> US hegemony of World sea trade routes.

US also replaced the queen of sea i.e: Britain, by taking the responsibility of sea routes as well. This further strengthened US hegemony as world's mostly trade took place through these sea routes.

=> US hegemony over International Organizations:

US being the sole super power also took control over the global organizations like World Bank, IMF, and WTO, and also used them in its favor while sanctioning or penalizing



other countries.

⇒ SWIFT:

The transaction system of SWIFT - dominated by US - led to dollarization of all the countries reserves, which further strengthened US hegemony over the world.

⇒ Alliances:

US also strengthened its military might and diplomatic power, by making Alliances like NATO, Five eyes, AUKUS, QUAD and several other in order to control the global south further.

* US exercising dollar and Swift as a weapon against global south:

There are various instances where US has exercised these as a weapon against global south:

⇒ Iran:

Iran has been paralysed severely due to ^{use of} dollar and SWIFT as a weapon by US against them.

⇒ Pakistan:

Presley amendment and other sanctions of US against Pakistan.

⇒ Iraq

Iraq had also been sanctioned earlier in order to force it to destroy its Weapons of Mass destruction.

⇒ Russia

The recent example is of Russia which has been severely hit due to US sanctions on it.

⇒ China:

China had also been sanctioned for providing nuclear support to Pakistan.

* How BRICS+ can get rid of western exploitation on permanent bases:

There are several ways in which BRICS+ can get rid of western exploitation which are being enlisted below:

⇒ Introducing alternate currency to dollar.

By introducing alternate currency they are going to end the hegemony of dollar in the world.

⇒ Introducing alternate transaction system to SWIFT.

⇒ By convincing member and friendly countries to trade in local currencies rather than dollar.

=> By utilizing BRICS+ as an alternate to NATO.

=> By utilization of New Development Bank as an alternate to WB, IMF, and WTO.

=> By using this as a platform to solve global issues and increase cooperation among the member countries.

Conclusion:

In a nutshell, US had sidelined the global south till almost a century, but now the BRICS+ is challenging its hegemony in several ways. US could not suppress them further, either today or near future, BRICS+ is going to retaliate as just like HTS had retaliated to the despotic rule of Assad.
