The colonial masters have exploited the women of colonized society. Massive rape of the girls of colonized girls occurred at a huge level by the colonial masters.

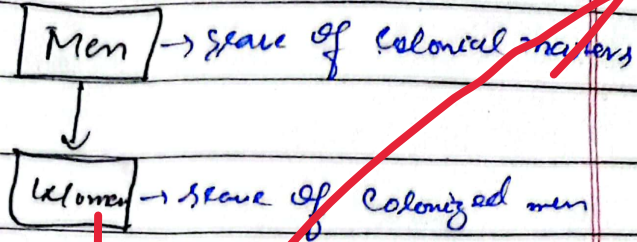
B) Colonialism proved blessing for women in India

F) Domestic violence against women

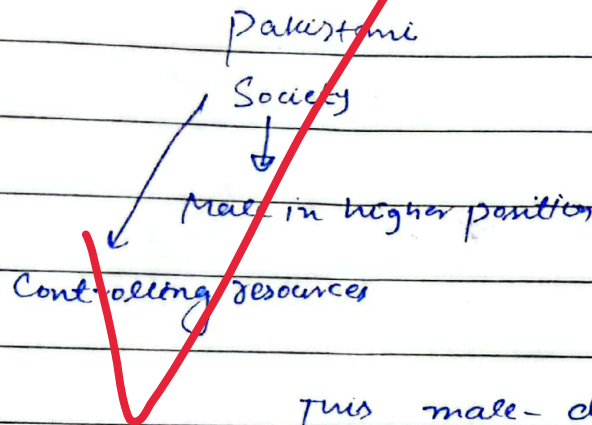
Women bear the brutal domestic violence resulting in lower participation of women in male-dominated works

The so called

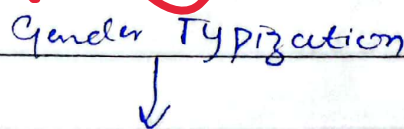
muldahs and their strict interpretation of religion results in lowering women participation in outdoor activities. This results in gender inequality.

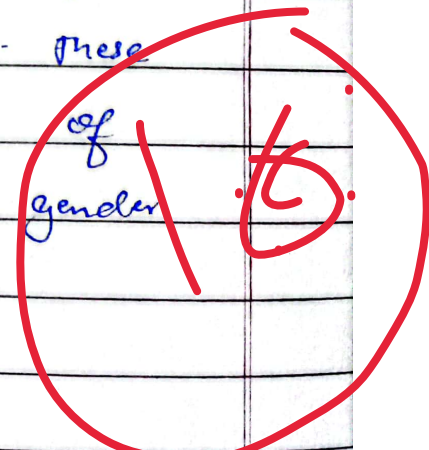
