Background behind Assad Regime fall :-

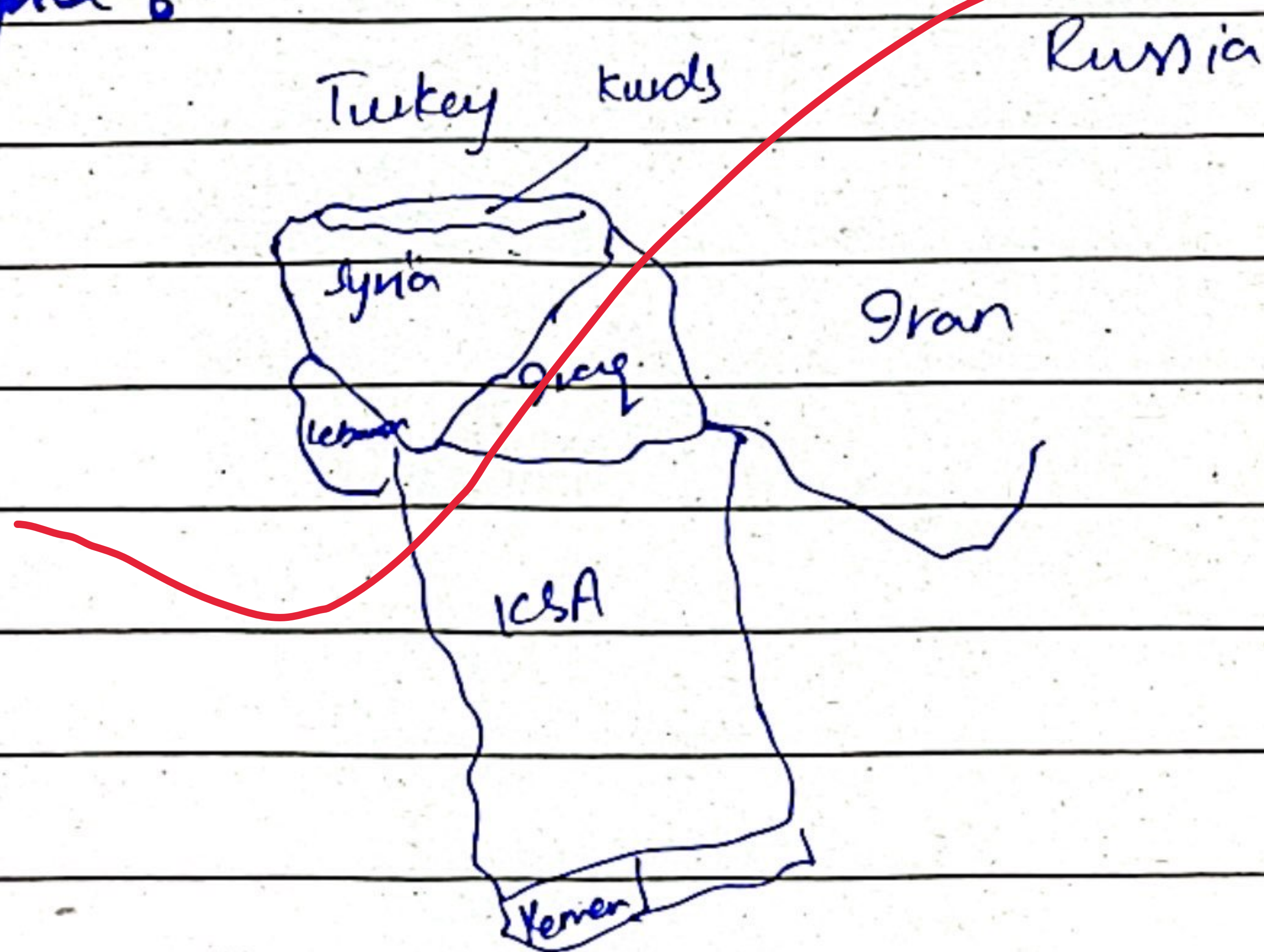

③ Reasons of Regime Change in Syria :-



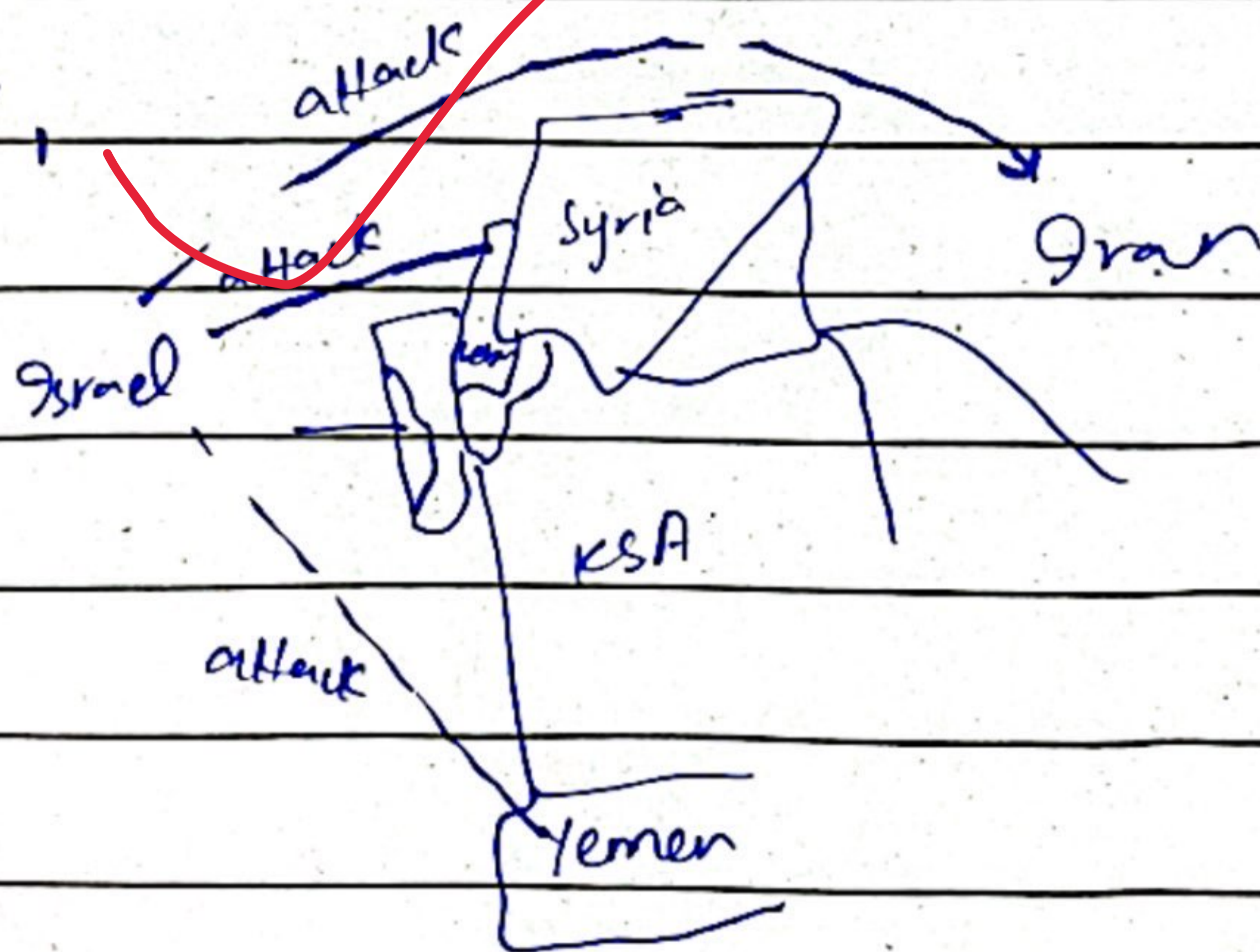
(a) Support of Asad Regime has lost :-

Asad Regime had been supported by regional allies including Iran and

Russia since Arab Spring, 2011.
 To overwhelm the Arab Spring
 Russia supplied ① Military weapons
 ② Drones ③ Helicopters ④ Russian
 troops. In this way Assad regime
 was restored.

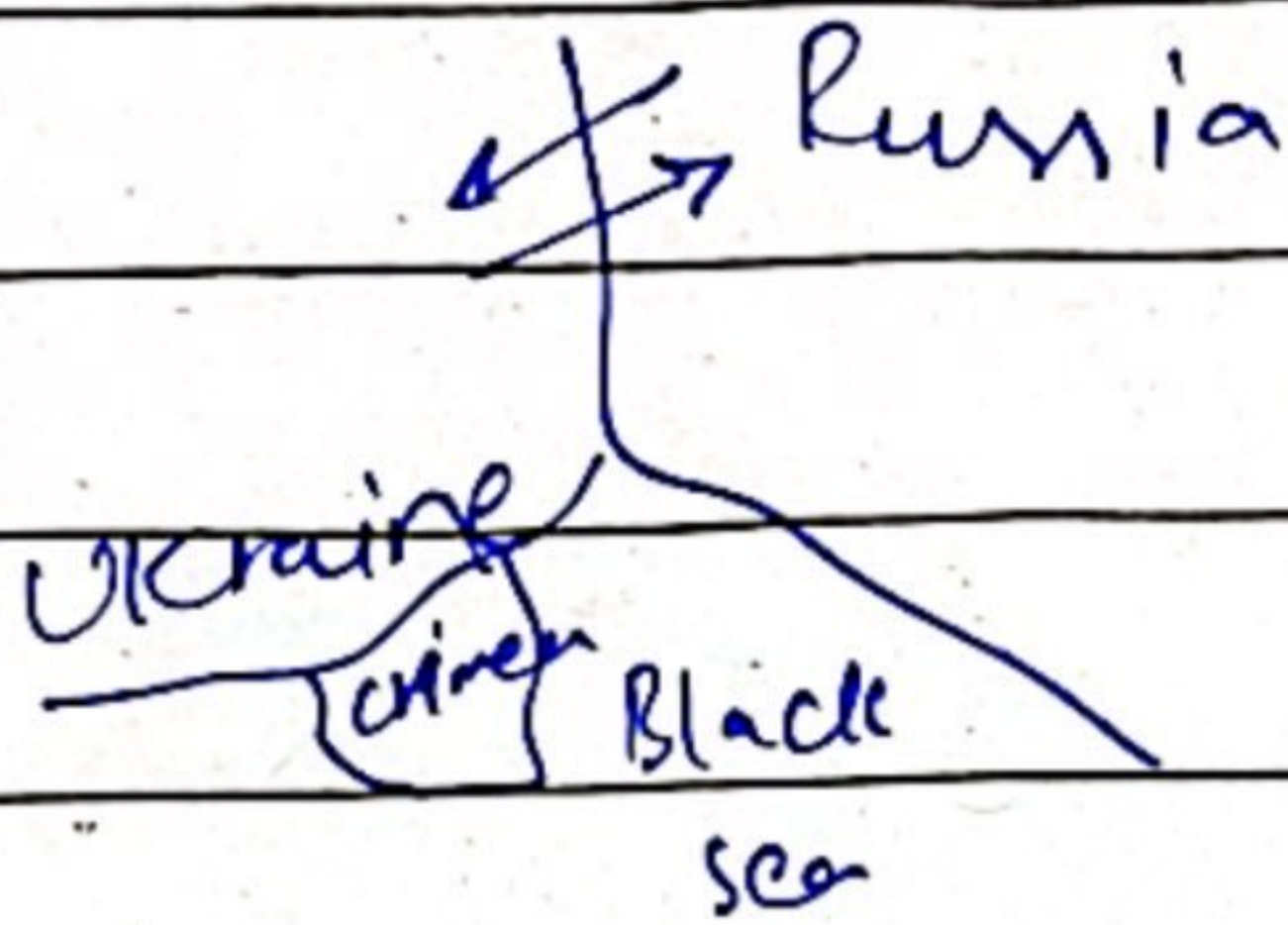
Russian airbase at Mediterranean

(c) Organization of Rebels :-

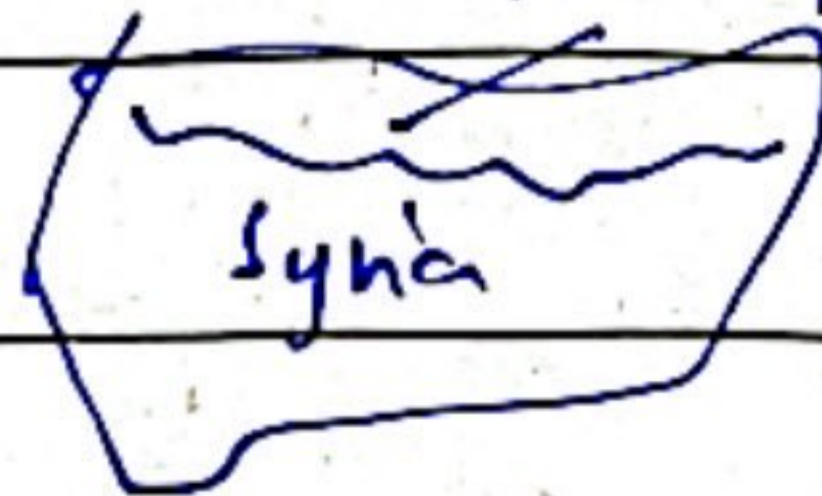
The rebellion group of HTS is highly organized under its leadership as compared to other rebels, like Kurds, who in past tried to capture Syrian control.

① Introduction :-

State owned Enterprises of Pakistan have become "blackhole" which gives no output. So, the government of Pakistan has decided to privatize them as soon as possible. Because these are burden on economy as well as their standard does not meet with that of international. So, it is highly recommended to sell them but their bidding must be transparent and efficient. The remodelling of enterprises can also make them to earn more profit.

② Privatization of SOE : Backgrounds-

Once in 1980's, the state owned enterprises were privatized but due to lack of political will, it remained ineffective. Now, in 2024, again the government of Pakistan has decided to privatize the SOE's. PM Shehbaz Sharif chaired the High level meeting along with Privatization minister and

commission to privatize ^{all} SOE's
 'either they are in profit or loss?'

The statement was made after IMF meeting with IMF delegation which reports that; In 2019, almost 50pc SOE's of Pakistan were in loss.

→ Highly Prioritized SOE's

- (1) PIA (Pakistan International Airline)
- (2) Roosevelt Hotel in USA
- (3) Two coal power plants and other distribution companies
- (4) Railway of state etc.

3. Why Privatization of state assets is necessary?

(a) Burden on state economy :-

The SOE's have become only a burden on state economy.

Because instead of earning profit, Pakistan is spending money to run smoothly.

These SOE's have increased 'financial gap'. Now there is high

debt on these enterprises.

(b) To serve the public efficiently :-

These enterprises are privatized, and the main objective is :-

(1) To serve the public, as the incentives were given to those enterprises which instead of earning only consume money.

(2) In this way, the taxation system will be improved, the owner of those enterprises will pay the state and the economy will flourish.

(c) To attract facilitate the investor :-

When the major companies are presented for sale, the foreign investors attract to purchase them. In this way, the foreign investment will increase. Now, it is essential to privatize them because it will become a life-line to save the

state economy.

(d) Huge Competition on international level :-

There is much competition on international level, as many multinational companies are operating in Pakistan. With the advancement of technology, these companies have not made any progress, so, it is difficult for state to run those enterprises in a huge competition.

(e) Inefficiency of state to raise their standard :-

The inefficiency of state in terms of :-

(1) Accountability

(2) Check and balance

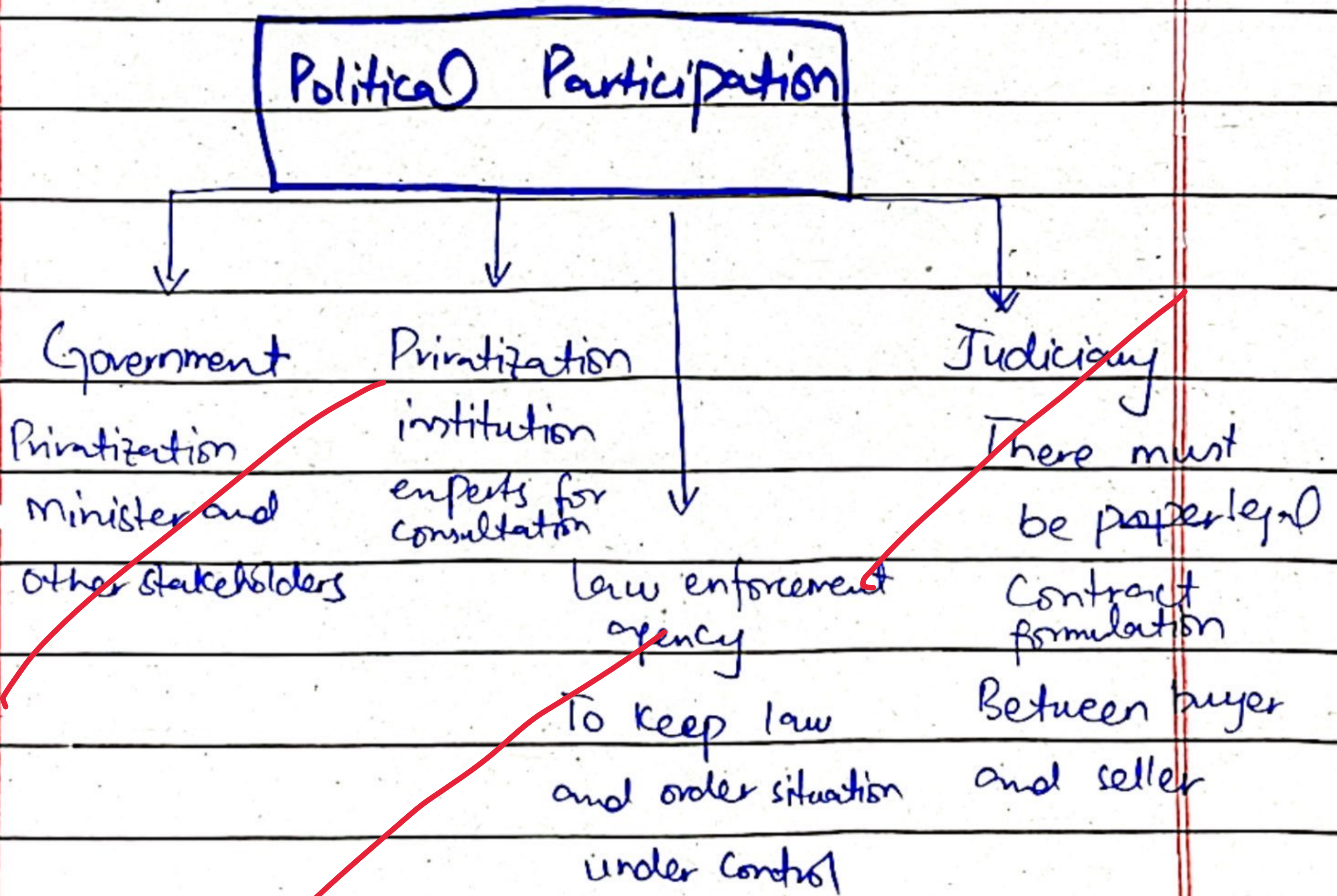
(3) Transparency

(4) CEO were appointed randomly without merit.

All these inefficiencies ^{could not} ~~plead~~ led the state enterprises towards international standard.

4. How those enterprises should be privatized?

(a) By Active Political Participation:-



Active political participation is essential to make the deal quickly and efficiently so as to avoid further loss.

(b) By Transparent Bidding

The bidding must be open, rather it must be on air on TV, so that everyone can participate in bidding. This is necessary because these assets belong to state and the nation has rights over them. Furthermore, to sell the enterprises at best possible cost it is mandatory that bidding should be kept transparent.

(c) Finding a high caliber investor :-

Finding a high caliber investor should also be state priority.

As in case, of first women bank, the dialogues are in process with UAE.

Similarly, for Roosevelt the dialogues in the way, because

its responsibility of state stakeholder to find the high caliber investor, who can purchase SOEs at maximum price.

2. Russia - China Relations in :

(a) Economy :-

Russia and China signed a treaty of "good Neighbourliness and Friendly Cooperation" to enhance relations in :

- (1) Military
- (2) Security
- (3) Trade
- (4) Technology

Let us see the economic relations between two as follows :-

(i) Trade Turnover

Between two states the trade turnover has exceeded to \$100bn.

(ii) Eastern Siberia - Pacific Ocean Oil :-

In 2009, both states agreed on construction of Eastern Siberia - Pacific Ocean oil pipeline, now it.

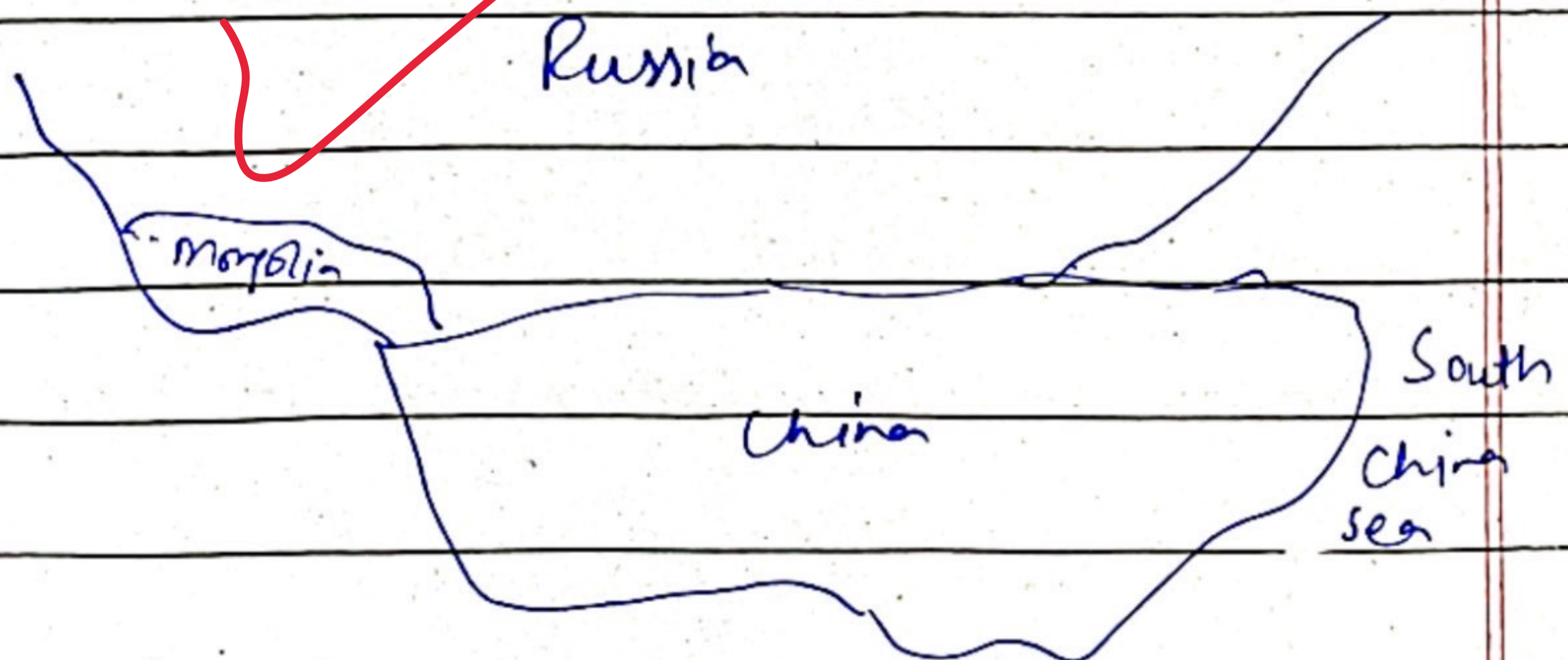
is completed and operational between the two states, which is economically beneficial for the two.

(iii) Russian withdrawal from SWIFT :-

In 2022, Russia has withdrawn from SWIFT and now it has started trade in Yuan. Actually, both states want to end the dollar hegemony in trade and commerce.

(b) Strategic Relations :-

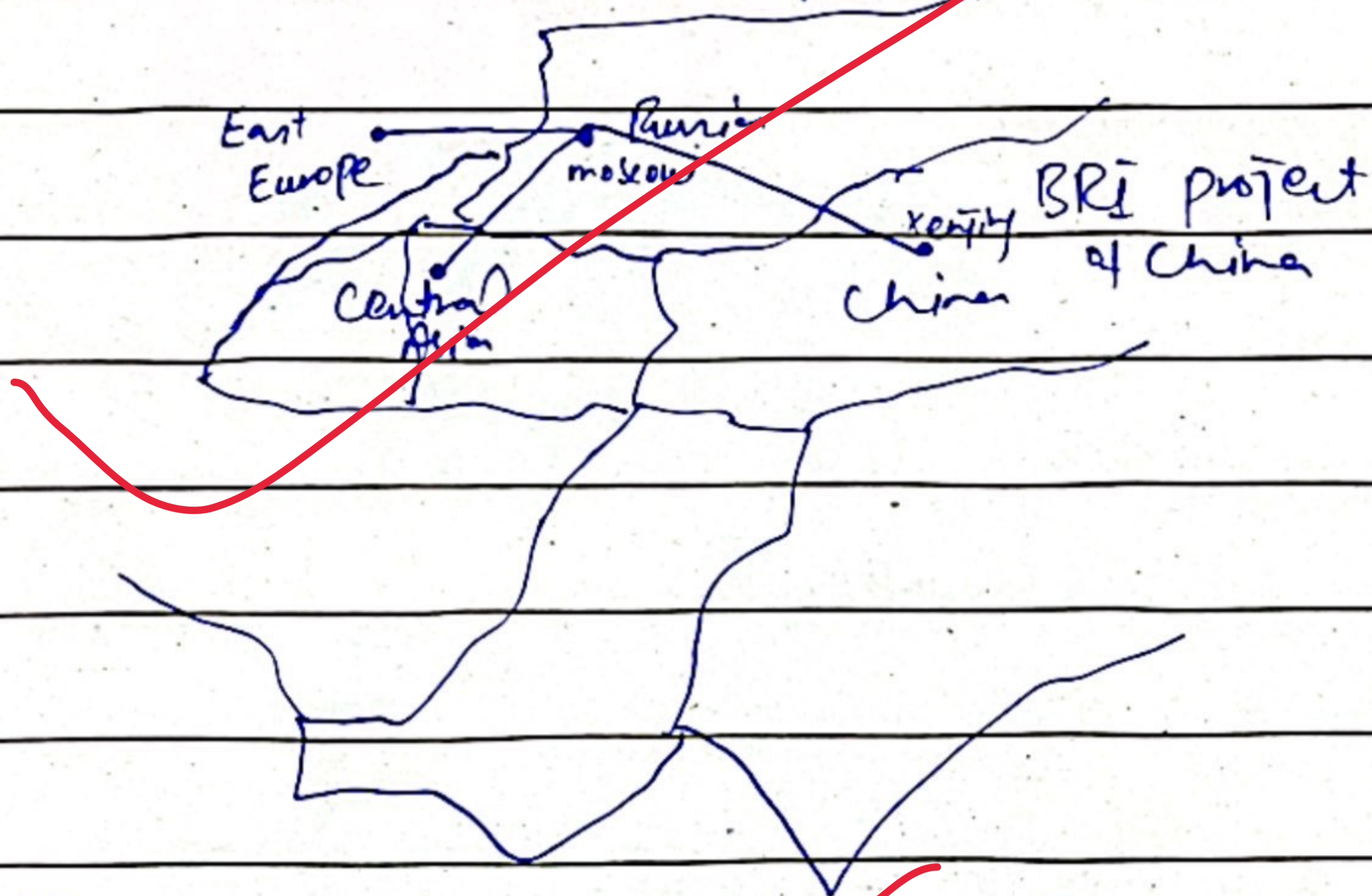
Russia and China are sharing longest border with each other.

Russia - China Strategic Interests in Middle East :-

China :-

China want to expand its trade in Middle East. As it played a diplomatic role in the reapproachment of Saudi - Iran relations.

Russia :-

① Russia want to promote its soft image in Middle East, that's why it is providing assistance to Syrian refugees.

(2) To counter US influence in the middle East.

(c) Geo-political Interests :-

The geo-political interests of both are same as both are "Communist States". In both of them opposition is weak and they are against Capitalist states.

China's political Interest in Pacific Ocean :-

China claim on Taiwan, which is bone of contention between US and China.

China support towards N-Korea and US support towards S-Korea.

There are major point of clash between USA and China. That's why USA is encircling China in Indo-Pacific region.

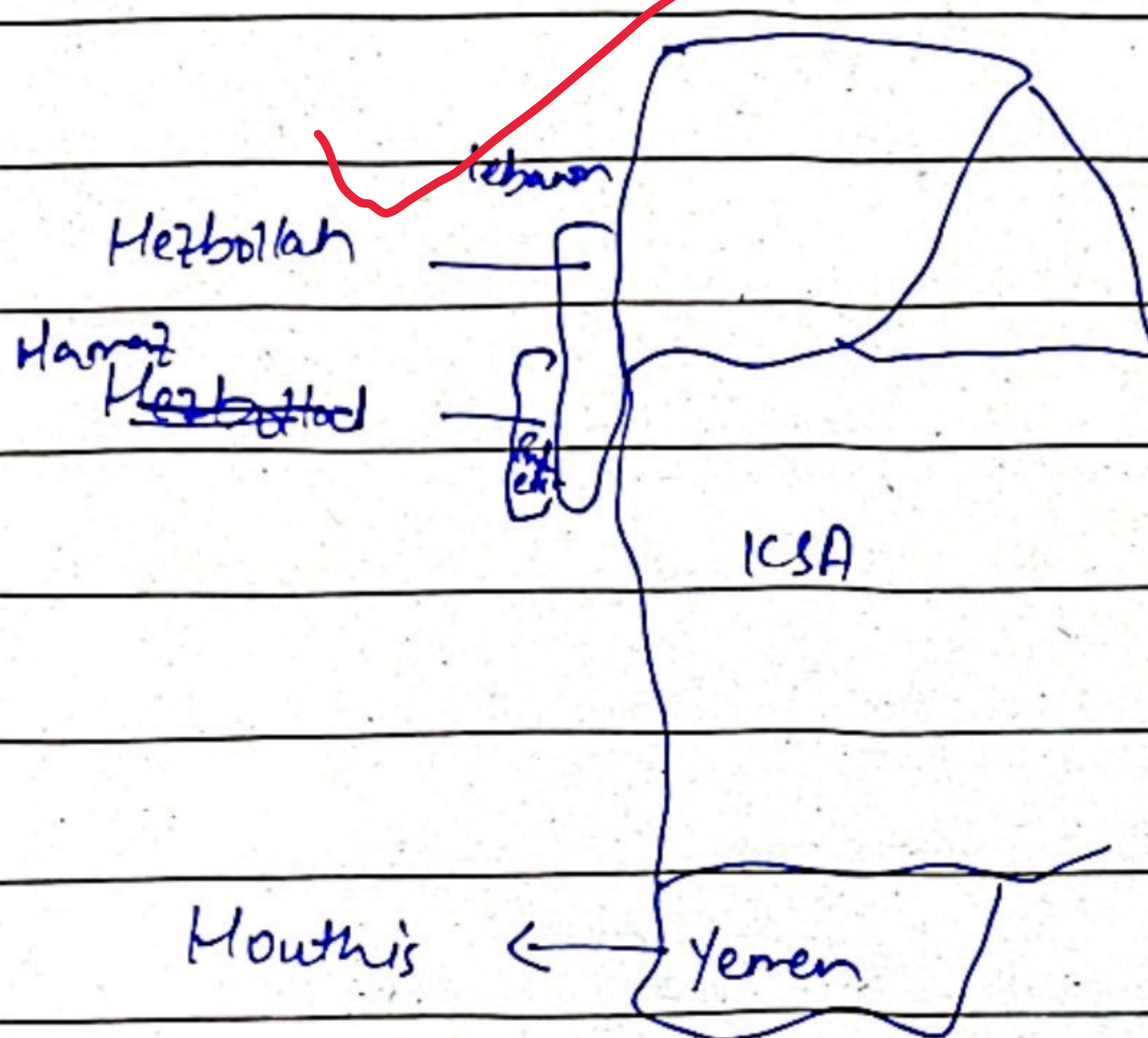
Russia's political Interest on Ukraine :-

USA want to include Ukraine in NATO to counter its enemy in Asia. That's why Russia attacked on Ukraine on Feb. 2022

to counter the influence of USA at its border.

Both Russia and China want their hold on their neighbouring regions.

Political Relations with Hezbollah, Hamas and Houthis :-



→ China invited both Israeli PM Benjamin Netanyahu and Hamas leader in 2023 to resolve the Palestinian conflict.

→ China want a peaceful Middle East to expand its trade relations with Arab state and to import oil from them.

Chinese President denounced the

Israeli atrocities in Palestine in United Nations General Assembly.

→ Russia also ^{voted} passed ~~money~~ in favour of Palestinian cause in United Nations Security Council.
→ Both states also support each other cause in their respective territories. As they conducted joint "military-naval exercises" at several occasions in 2022.

And in 2015, Russia started selling Su-35 and S-400 air defence system to China because both want to strengthen their military against US.

3. Russia - China or counter block to US hegemony :-

US strategy against Russian and Chinese alliance :-

US is encircling China in South China Sea by establishing

① QUAD

② G20

③ AUKUS

US has good relations with Philippines, Japan, New Zealand and Australia to counter China in South China sea.

US is supporting (1) militarily (2) Technological support to these states to strengthen their security system.

US support to Israel:

- ① US vetoed many resolution in UNGA against in favour of Israel.
- ② It provided (1) NATO Troops (2) Funds (3) Military weapons to Israel.

US support to Ukraine:

US is supporting Ukraine both morally and militarily.

US and its allies has given (1) Funds (2) military weapons to Ukraine.

→ West has placed sanctions on Russia.

Russia - China Strategy to counter US and its allies :-

→ Strengthen their economy

Despite of Sanctions on Russia, China is doing trade with Russia to ease its economy.

→ Strong defence system

Both are strengthening their defence system. According to 'Voice of America Journal' from 2022-2023, China warhead increased 18% in number.

→ Strong relations with neighbouring

Both are extending their relations with neighbours to block US from the region.

Critical Analysis of US-based Thinktank:-

Both Russia and China are together, till their common enemy is USA. Once, USA collapse, both will compete with each other.

Conclusion :-

Hence, it is concluded, that as long as the interests are

same and the enemy is common they will fight with by backing each other. And in Asia especially in South China Sea, the authority of China is challenged by USA but its weaker position in Middle East has created a space for Russia and China to fill.

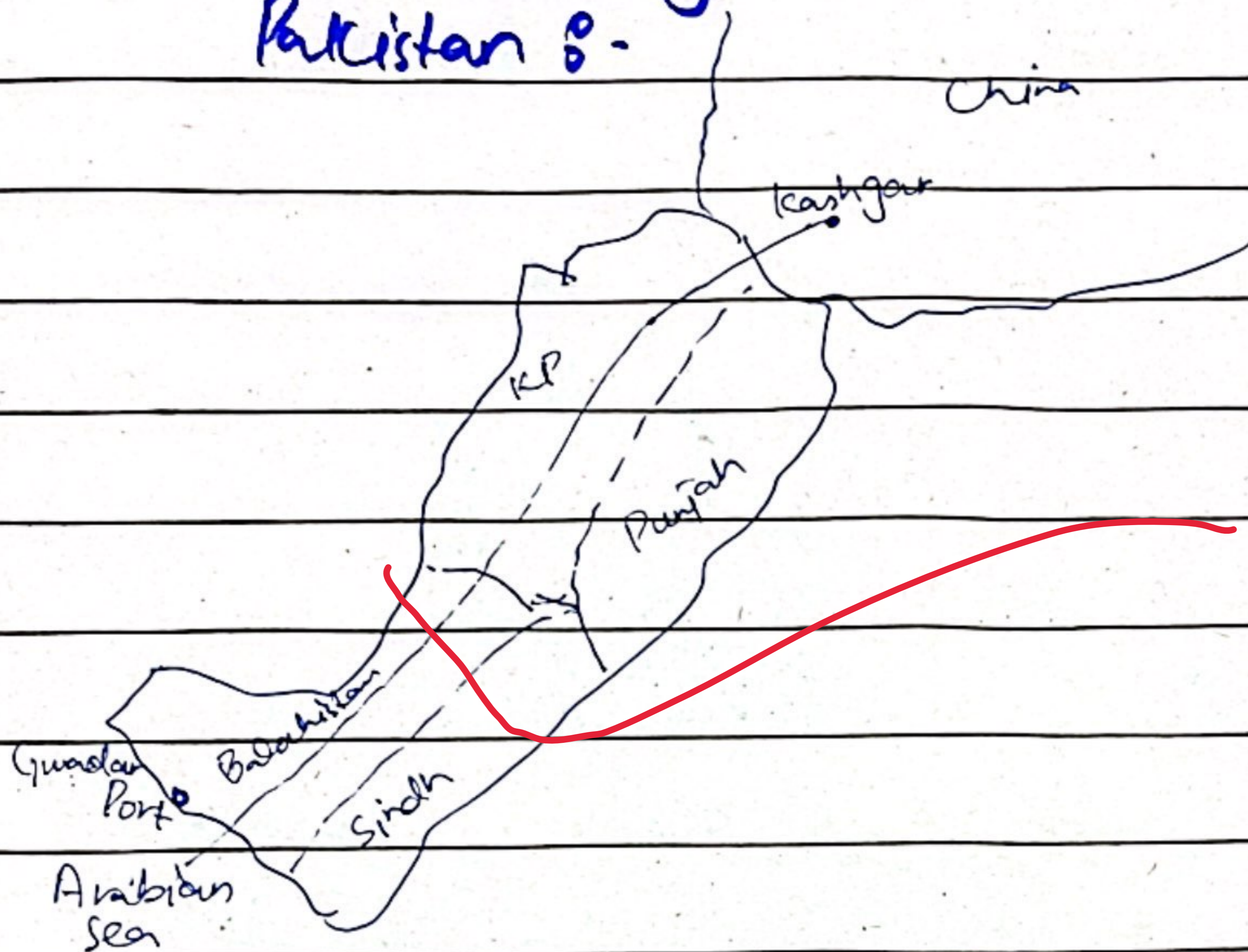
After Covid-19, the Project is operating with full speed and there is no truth in these fake news.

(a) Chinese Security Concern in Pakistan :-

Attack on Chinese Workers

→ Recently, in Southwestern province (Balochistan) an attack carried out on Chinese workers.

So, China has severe security concerns for his workers in Pakistan.

China Claims:-

China asked Pakistan, to have its boats on Pakistani soil, which Pakistan rejected. This may be a bone of contention b/w the two states.

(b) Political Instability in Pakistan:-

Andly, the political situation of Pakistan is another reason of slowing down the project. Since, the ouster of former PM Imran Khan, the civil chaos has increased. After Feb. 2024 election, a weak coalition is formulated which is working but still the protests are common phenomena.

was highly criticized by
international media also.

(C) Worsening economy of states:-

Furthermore, the ^{wider} worsening economy
of state is further stressed
but no foreign investment by
other states.

→ Pakistan reliance on foreign
aid like IMF to pay its
debts and to formulate its
budget.

→ Pakistan demand to China
for another loan and the
will to rollover the previous
ones.

This has become a matter of
concern for China that how
would Pakistan pay back
such huge amount of money.

(2) Trade cost will be less

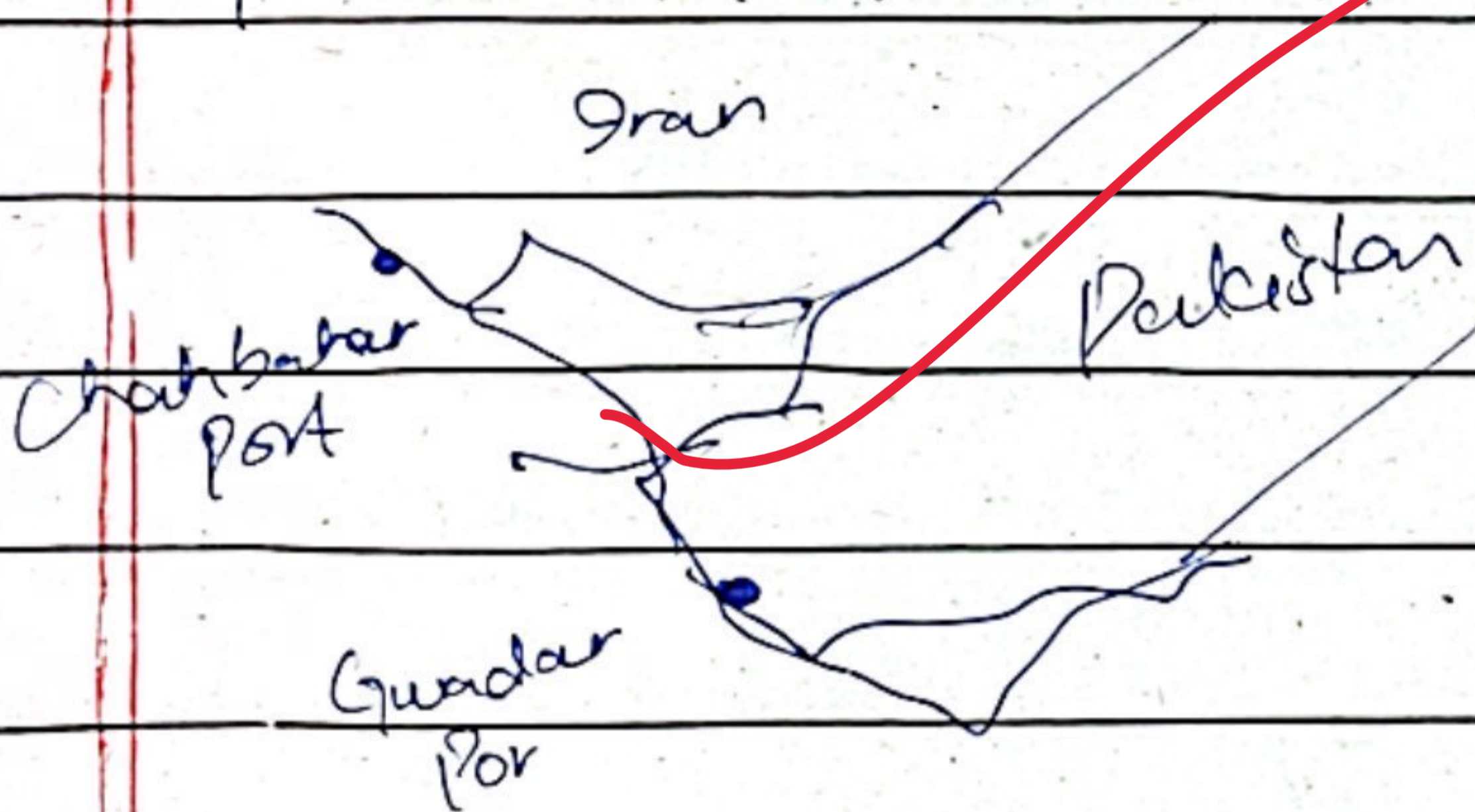
through Gwadar port is not

(c) Revision of Project Plan

according to Budgetary input :-

The plan must be revised according to the budget because there are concerns of Pakistanis that project is not actually benefiting the Pakistanis in case of job opportunities and also it has not benefited the state economy much.

(d) Initiation of Cost-effective projects rather than roads and railways :-

The main issue is release of funds from China, on which Chinese concerns are that Pakistan is not returning the previous loans. While Pakistan's concern is that, it has not earned

much from project. So it is high time to revise the project policies and plans and invest in those projects which provide more profit and jobs to people.

Conclusion:

At last, it is concluded that there are many reasons behind the derailment of projects like Chinese security concern, international media propaganda etc. But by adopting comprehensive measures like revision of project according to budget and high level meeting between two states regarding security.
