Introduction

The system of zakaat is one of the important obligations of Islam. Allah Almighty has ordained for giving zakaat to establish a balanced system between the rich and the poor. It purifies the wealth as well as soul. It promotes a sense of harmony, solidarity and removes resentment and envy that might arise from economic disparity.

The importance of Zakaat and its role in alleviating poverty

① Spiritual and moral significance

significance. It is a duty of muslim and by paying zakaat, it purifies soul as well as wealth. It produces a sense of closeness to Almighty Allah. As Allah says in Holy Quran,

(Surah Baqarah : 43)

② Zakaat produces a sense of responsibility

④ Zakaat helps alleviating poverty

⑤ It fosters unity and harmony in the society

As when the rich spends on the needy with humbleness, in the way of Allah, it reduces resentments and envy present in their hearts. It fosters a strong relationship and produce a harmonious society.

⑥ Zakaat promotes economic growth

marginalized communities.

As Allah says in Surah Taubah,
"Take from wealth a charity by which you purify them and cause them to increase, and invoke Allah's blessing upon them."
