26th Amendment: Affecting Balance Of Power Between Pillars of State

Introduction:

The main pillars of state are Parliament, Executive and judiciary. The recent 26th amendment have changed the balance of powers between these pillars. "The Constitutional 26th amendment strengthens Parliamentary and executive check on judiciary." It was passed on Oct. 1. 2024 by Two-third majority, from 65 votes of senate and 225 votes of National assembly. It amend 27 clauses of the Constitution. Unlike 18th amendment, this amendment did not built a consensus between stakeholders and its controversial enactment manner presented undue best and negative impact on stakeholders.

First discuss the different aspects of the amendment

Parliamentary and Executive check on Judiciary:

- 1 → Appointment of judges
- 2 → Snatched Sze moto
- 3 → Establishment of Constitutional bench Executive Dominance
- 4 → Allow to Independence of judiciary - Limitation of Judicial Review

Appointment of judge:

Twenty-Sixth amendment to the Constitution of the Pakistan has severely affected the balance of Power between various pillars of the state. As it has organized a parliamentary committee consisting of twelve members 8 from national Assembly and 4 from the Senate. The member selection will be based upon party position. The Committee will select

Chief justice of Pakistan among three most senior judges. After nominating name of chief justice, the prime minister will approve it and then president will sign on it. This can illustrate that how executive and parliamentary check on judiciary change the power balance between these pillars of state.

Suo moto Powers of Supreme Court

The biggest change in power of supreme court is snatching of suo moto. Supreme court, previously was able to change any fundamental human right mentioned in Article 8 to 28 of Constitution. In era of justice saqib niso and chaudry iftikhar various suo moto was taken on very small issues. In Twenty-sixth amendment to curtail hyper activism in Supreme court, suo moto powers are snatched. This shows that the power of Supreme Court

has been reduced. Moreover, the inter power fluctuation within judiciary is also a main area of concern.

Now, after this amendment, Supreme Court has right to transfer any case from high court to itself. Experts see it as a politically motivated

Step. Establishment Of Constitutional Bench: Executive Dominance

This Twenty - sixth amendment, have dominated executive over judiciary. The power dynamics are being changed in the states. From selection of judges to Selection of chief election commission of Pakistan , the executive contains more power. According to experts establishment of a Constitutional bench within supreme court has potentially allowed executive to influence with judges. ~~but~~ This has created a imbalance of power . Judiciary which was influencing earlier now remain under influence of Executive.

Limitation On judicial Review of Executive Decision

The Twenty - sixth amendment has restricted the courts from questioning executive recommendations to the president and prime ministers. It has reduced judicial oversight of executive actions. This undermine judicial independence and consolidated executive power over judiciary. It potentially affects the separation of Powers and rule of law in Pakistan, quoted by International Court of Justice.

A Lazy Incompetent Government Leadership


