Judges Appointment of judges is manipulated by the political persons which cause a fear in the mind of the upcoming office holder. Ideally it based on merit, legal expertise and seniority but by political involvement they ^{are} appointed on the basis of favoritism. Such practices compromise the productivity of the judiciary. Not only the appointment is manipulated but also political parties pressured the judicial independence to gain results of favor.

When a judge is pressurised politically, it create a sense of fear in the mind of the office holder and also fear of permanently dismissed by involving in fake cases. This pressure is used by the political parties to gain these political benefits and to their rivals political rivals. In addition to this political parties pressured judges to favor their party.

When a political party is in government they pressured judges to favor their party. This interference often

manifest through threats, coercion, or subtle incentives aimed at ~~sway~~ swaying judicial decision in favor of political parties.

Judges under this pressure may deliver biased verdicts and compromising the principle of justice. This practice not only damages the credibility but also erosion of public trust on judicial system prevails in the society.
