When it comes to attractions and disapprovals, the white and black hues have always participated in this discussion. From past to present segregations have been made on the basis of 'black colour' and 'white colour'. Historically, the concept of black first emerged with the emergence of slavery. Slaves from America were a high demand for the purpose of agriculture and crops harvesting. With the increase in demand, more and more slaves were transported from Africa to different nations or the then super powers. Since the Africans appeared to be black in colour, the concept of discrimination on the basis of black emanated. Thus considering the person with black coloured skin subordinate to the one with white. This idea further created distinction between the white women and black women.

The 'women' themselves were considered a suppressive and subordinate entity in the past. Even today, women are deprived of their rights, but on the basis of race the white women are considered superior than the blacks.
