Tauheed is the core factor that makes Islam a monolithic religion. It is one of the main pillars of Islam. Tauheed signifies perfection of Allah. In Islam, it means believe in the Oneness of Allah. There are two parts of tauheed: First, it states that there is only one God. Second, it considers Muhammad (SAW) as the messenger of Allah. Tauheed has significant values in individual and social life. It incites the spirits of humbleness, morality, faith and tolerance, social welfare, social development and brotherhood. Tauheed constitutes to shirk i.e., associating others with Allah.

Tauheed = Belief in Allah and his Prophet (SAW)

Oneness of Allah:

Tauheed stresses that there is only one God. Everything in the world and heavens are created by him. He has the power to control everything. According to Quran, there is no match to Allah. Surah Ahaad states, "Say He is Allah the One and there is none like Him."

Being the only God, Allah is perfect. He is the disposer of all the affairs. Angels comply with His commands. This is why He has no need of sleep or rest. Nor He has any descendents. According to Biology, reproduction is the technique of survival of species. Hence, Allah does not need offsprings. He is Eternal and Absolute. In Ayat-ul-Kursi, it is clearly stated that neither He sleeps or get tired. Hence, Tauheed stresses Oneness of Allah in the truest of its essence.

Shirk: associating someone with Allah:

If a person associates a living or non-living thing with Allah, he/she undermines Tauheed and commit Shirk. Shirk is a grave sin and is not forgivable if a person die as a Mushrik. Committing shirk clearly violates all the principles and attributes associated with Allah. For example, Christians believe that Jesus (Isa A.S) is the son of God. This clearly contradicts with the perfection of God. It indicates that He needs offsprings and is unable to run the affairs of heavens and the earth. Hence, Shirk has been strictly condemned.

Prophet (SAW) as the Prophet of Allah and the Seal of Prophets:

Muhammad (SAW) is the last Abrahamic

Prophet sent by Allah with revealed guidance. Believing in Prophet (SAW) is an integral part of Tauheed because he is the messenger guided by Allah. In order to understand and follow Islam, the teachings of Prophet (SAW) must be adhered. According to Huzrat-Ayesha (R.A), Muhammad (SAW) was a walking Quran. In addition, it stresses that there will be no Prophet after Muhammad (SAW), and he is the seal of Prophets.

Importance of Tauheed in individual life:

Tauheed humbles down individual into submission of Allah:

Tauheed makes a Muslim realise that there is no one above Allah. It suppresses his pride, as he believes to be a sinful human being. It deters person from considering himself above people, since he would meet Allah someday who is the greatest judge. Hence, the person submits to none other than Allah, knowing Allah is the sole disposer of affairs. His faith strengthens and his morality increases.

Strengthened faith results in strong individual moral principles:

Since the person believes in absoluteness

and perfection of Allah, he also believes in the Absolute Superiority of His knowledge. The revealed guidance becomes his objective and perfect approach to core moral principles. The struggle of Saudi Arabia and Iran against each other to declare themselves as leaders of Muslims:

The ongoing conflict between KSA and Iran emboldened the Muslim Ummah division. The former is a Sunni-majority state while the latter is a Shia-majority state. Both want to become the most dominant Muslim states. Consequently, it led to sectarian conflicts in Syria, Yemen, Iraq and Libya. Both supporting the factions of their sects. The constant state of war all together weakened the Muslim Ummah.

The effects of 9/11 and Arab Spring 2011:

9/11 tarnished the image of Muslims and made an excuse for Westerners to destabilise the region.

After 9/11, the American declared War on Terror. Invasion in Afghanistan initiated followed by that of Iraq in 2003. The Muslims were stamped as terrorists and the world stood against them. This led to exponential rise in Islamophobia. Till date Iraq and Afghanistan face the after effects of Western invasion severely. The concept of National Interest in International relations:

In international relations, a state prioritises national interest over religious interest. There are no sentiments in policy making of national interest.

### a) Peace in Islam
