## 1- Introduction:

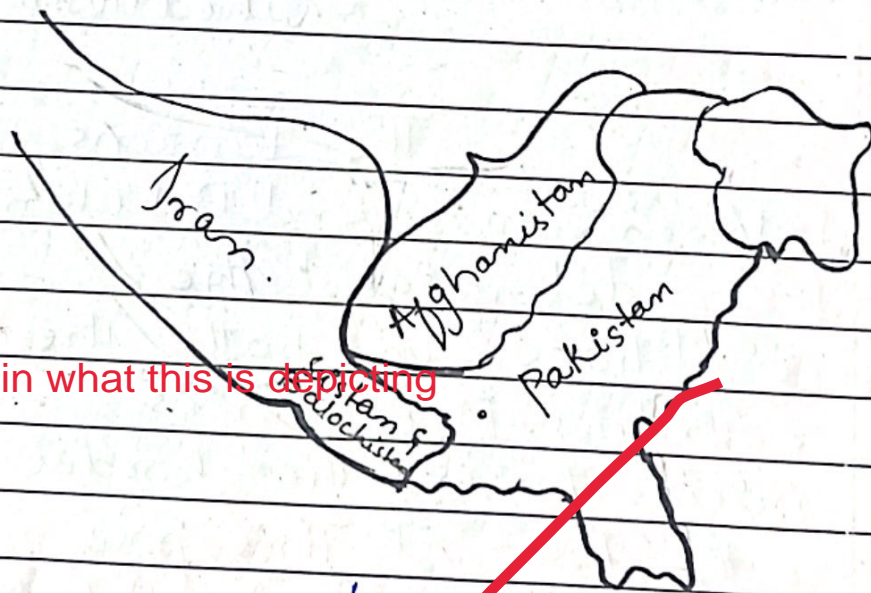
"The deteriorating conditions between Pakistan and Iran pose grave concerns for Pakistan's security."

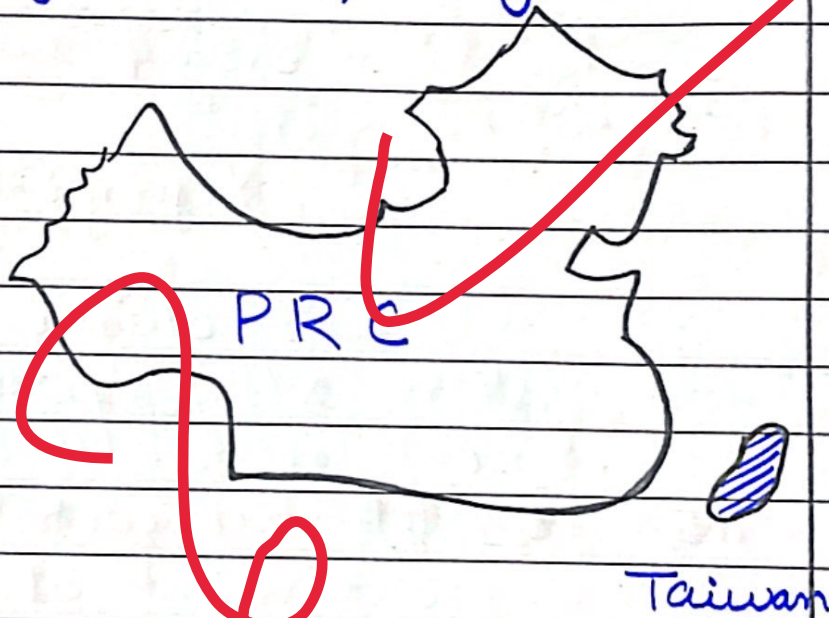
### Introduction:

c- Economic downturn in Taiwan due to sanction:

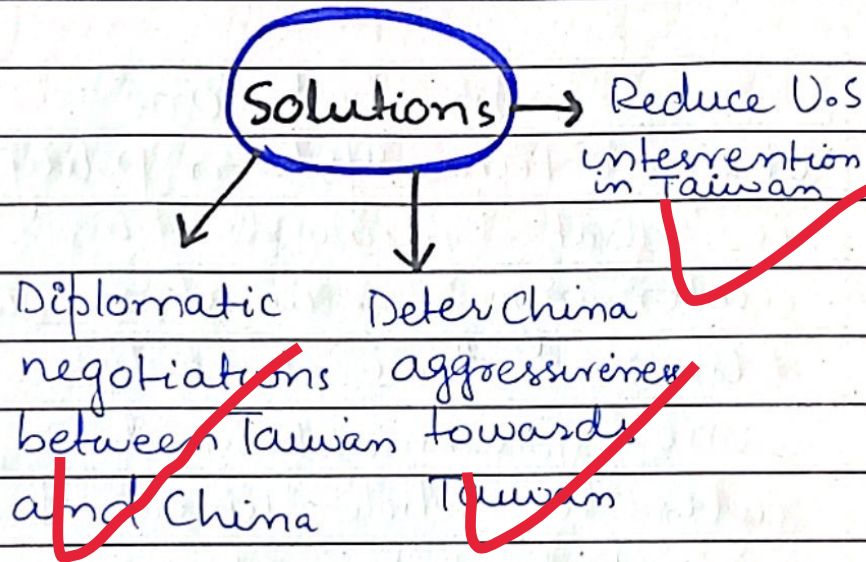
Due to the sanctions, economic downturn can be witnessed in China this can further escalate the condition.

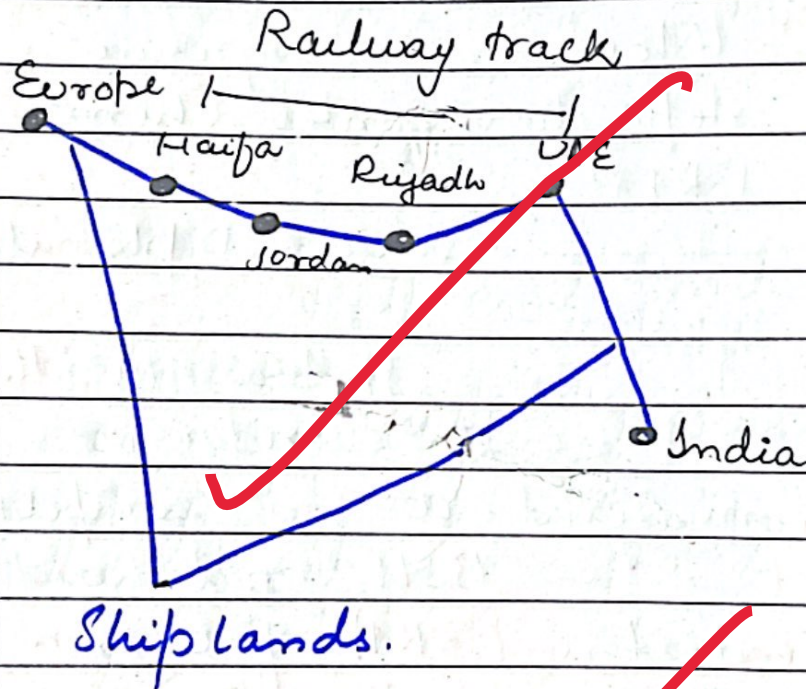
