At that time, the cold war was also on its peak, if any vacuum was spared by USA that must be cashed ⁱⁿ by USSR. To control this phenomenon USA had signed petro-dollar agreement that the price of petrol has determined by dollar in future. By this agreement, USA was completely able to control the energy market of middle East again.

That was decided the future of world politics revolve around the international political economy. States initial goal in 21st century to fulfilled energy needs at national level and trade if rich energy resources are available. Those countries which are importing energy to fulfill domestic needs are bullying by state which export. For example, Russia-Ukraine war, USA announced that cut off trade with Russia.
