


### Q3. INTRODUCTION

According to a maxim by Deng Xiaoping, "Hide your strength, bide your time". China has departed from this maxim as it has revealed its strength to the world and has challenged the might of US. The playbook used by the US to rise to the great power status is being used by China now. US came to the great power politics when European powers were fighting amongst themselves. US established itself as a great power by intervening in the World War I. President Woodrow Wilson gave his Fourteen Points and proposed the formation of League of Nations. This mediation led to the rise of US. China has hijacked the same playbook. It is rising to the great power status by mediating in conflicts, leading the transition to clean energy, using the nuclear deterrence strategy, forming defense cooperation pacts with various countries, and by constructing ports in major countries. China too is developing its soft power on the world. However, China is a better mediator than the US because China only mediates in conflicts and not in internal politics of countries, it does not use hard power and favours a law-based international order.

# 1. US AND CHINA'S GEOECONOMIC AND POLITICAL EXPANSION - A COMPARISON

China is adopting the same methods and strategies used by the US to expand its geoeconomic and political influence. These strategies are as follows,

## 1. Playing the Role of a Mediator in Conflicts




US rose to power when it mediated in World War I. China is using the same playbook.

US led the transition from an agriculture world to an industrialized world along with Britain. Industrialization gave a boost to US economy and made it into an economic giant.


China is similarly leading the transition to green economy which will give it global clout and influence.

### 4. Defense Cooperation and Building Alliances


US rose to the status of global power by building alliance through defense pacts and

## REASONS WHY CHINA CAN PLAY A BETTER ROLE AS A MEDIATOR


China can play a better role as a mediator

## 1. China Does not Intervenes in Internal Politics of Countries



## 2. China Mediates Using Soft Power and Not Hard Power

### 3. China Supports Law-Based International Order



US has mediated and intervened in conflicts such as the Afghanistan wars to protect human rights. China believes in respecting the territorial sovereignty of a country. Thus, China is the better mediator.

## Q4. INTRODUCTION



Iran has revived its axis of resistance, which includes Hamas, Houthi rebels and Hezbollah in Lebanon. The Axis is currently at war with Israel at multiple fronts.

## 2. Houthi Rebels in Yemen and Red Sea Blockade

The blockade of Red Sea by Houthi rebels has brought the war to the Red Sea and Yemen. The conflict has expanded as Houthi rebels have attacked cargo ships in Red Sea and have blocked oil cargoes from crossing.

## 3. Expansion of Conflict to West Bank

The West Bank has been under public unrest for decades due to wildcat settlements. The conflict in Gaza can spread to West Bank and it can threaten Israel's de facto control of the territory through Palestine Authority.

#### 4. The Chances of Saudi Arabia's Inclusion in the Conflict

Saudi Arabia was on the verge of normalizing relations with Israel. This conflict disrupts the talks between them. However, it is unlikely that Saudi will directly intervene in the conflict. They have rejected suspending oil trade and have only condemned the Israel attack despite public outrage.



## Q8. INTRODUCTION



## 1. The Impact on Business Environment







The political vacuum created by political instability has been historically filled by military leaders in Pakistan. This affects constitutions, suspends fundamental rights and strengthens non-representative institutions.


## 5. Political Instability and National Integration
