ANSWER:

1. INTRODUCTION;

2. ECONOMIC PRINCIPLES OF ISLAM IN LIGHT OF SOCIAL JUSTICE:

i. EVERYTHING BELONG TO ALLAH:

Islamic principles advocate for sovereignty of Allah Allah and everything in this world belong to Him. As Allah says in Quran:

"And everything in heavens and earth belongs to Allah"

Thus, there is no concept of material gains among muslims are everything is under the control of Allah.

ii. MAN AS FIGURATIVE OWNER:

Whatever man owns in this world is blessed by Allah and is given for temporary lifespan. He holds custody of things for certain amount of time, which will be transferred to next generation in the form of inheritance.

iii) EVERYTHING BEYOND NEEDS IS THE SHARE OF POOR;

Muslims believe that whatever surplus in income is blessed by Allah belongs to poor and needy. In the life of holy Prophet (S.A.W.S), there were some of his companions known as "Fuqarah-e-Sahiba", who lowered their basic needs and shared everything to needy in the form of Sadaqah and Zakah.

iv) CIRCULATION OF WEALTH;

Islam obliges its followers to pay alms or Zakah every year to the Masakin (deserving) mentioned in Quran. Every eligible muslim give 2.5% share of his wealth comparable to 7.5 tolas of gold and 52.5 tolas of silver to deserving and needy people. In this way, the wealth is circulated in the society and social justice is achieved.

3. ISLAMIC ECONOMIC SYSTEM

APPLICABLE TO MODERN WORLD:

i) OBLIGATION OF LAWFULL EARNING:

Contemporary world is indulged with increase illegal practices and unlawful earning. Islam has forbidden gambling, earning through Capital and other illegal practices whatsoever. These economic injunctions of Islam will support white money of the current world and ensure legal earning.

ii) CONTROLLED MECHANISM:

Capitalism is under the clouds of corporate interest and big business. Islam checked any form of extravagancy through interest or usury, which erodes current economic system. This controlled mechanism for big sharked is applicable to current world.

iii. BALANCED CONSUMPTION:

Another principle of Economic System of Islam is that it advocates balance consumption. Modern world is following the trajectory of unregulated expenditure and income, which harbors resentment between the poor against the rich. Holy Prophet (S.A.W) have said:

According to the recent reports, top 10% of Pakistani population hold 60% of country's wealth. Accumulation of wealth is strictly prohibited by Islamic economic system and thus applicable to modern world for just distribution.

IV SOCIAL WELFARE:

Modern world is facing huge humanitarian crisis of all times. Territorial wars and internal conflicts in the countries have displaced more people than ever before. Islamic economic system ensures that deserving people, needy, poor and white-collar people should get their due share through Zakat and Sadaka.

V RIGHT TO PROPERTY:

As Capitalism advocate for right to ownership and property. Similarly, Islam never prohibit its followers to own any property. Everything man owns in his life is considered blessings from his God. As Allah says

Political system of Islam allows people to consult with each other and resolve issues. Allah says in Quran:


And those who profess to believe in Allah, obey Allah, his messenger and the ones who hold authority among you."

spiritual connection of muslims
with their God. As Allah
orders muslims to take care
