Introduction

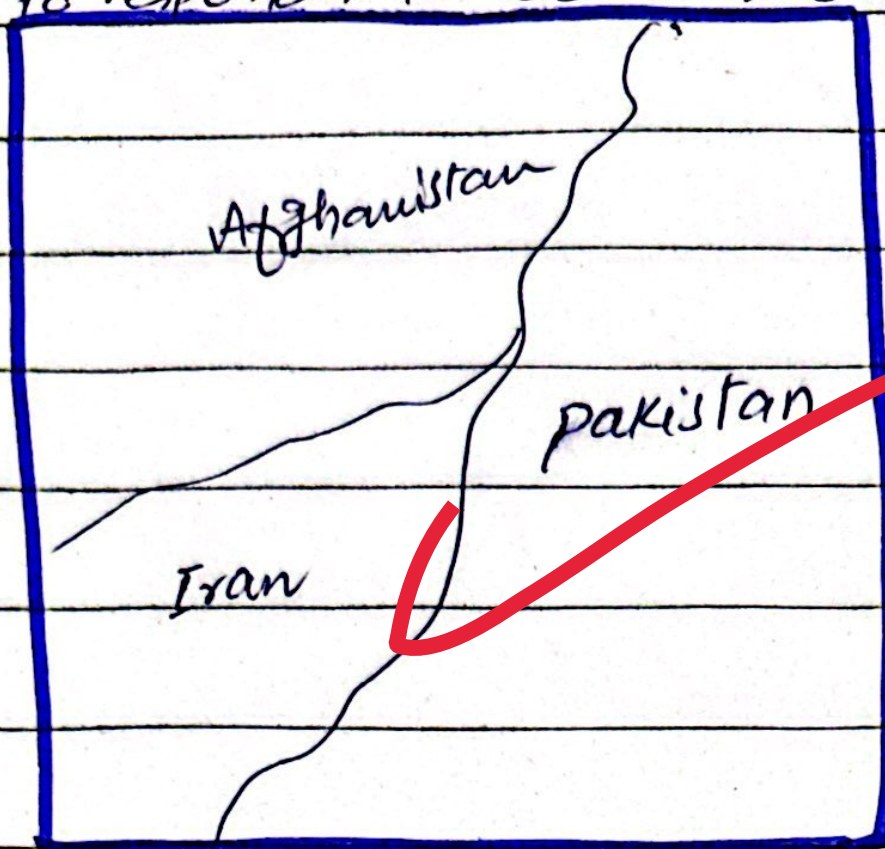

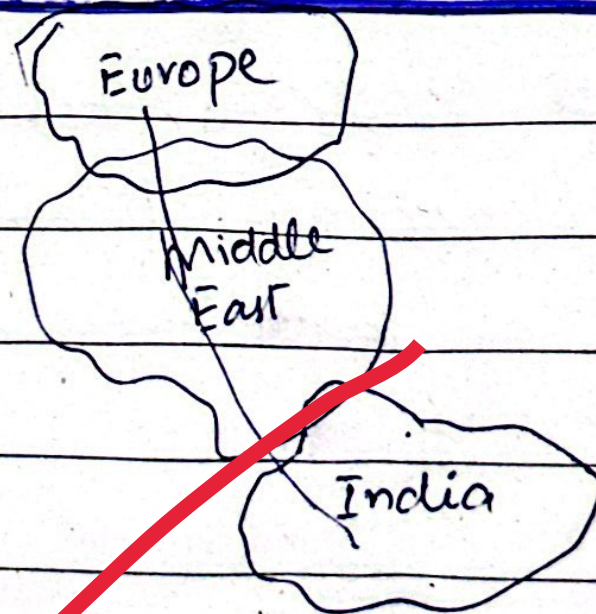

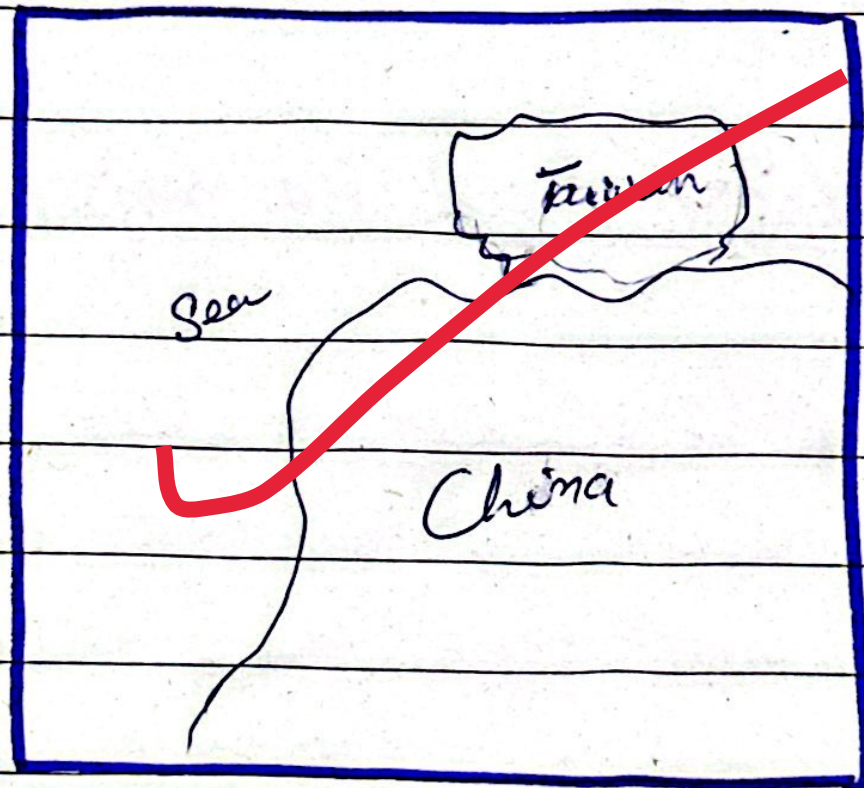
US - Policy towards Taiwan is hurting it
