Everyone is entitled to all the rights and freedoms set forth in the Universal Declaration of Human Rights <sup>discrimination</sup> without distinction of any kind, such as race, religion, colour, sex, language, religion, political or other opinion, national or social origin, property, birth or other status. Everyone has the right to life, liberty and security of person." Violation and Casualty of human rights impacts devastating effects on the society. dignity and value. One of the ways that we recognise the fundamental worth of every person is by acknowledging and respecting their human rights. Human rights can broadly be defined as a number of basic rights that people from around the world have agreed are essential. These include: the right to life, the right to a fair trial, freedom from torture and other cruel and inhuman treatment.

Many of the gravest human rights violations are committed in war. These also includes using rape as a weapon of war. From ancient times till now rape is used as a tool for war. (The rape of women by soldiers during wartime has occurred throughout the history.) During the World War II both Allied and Axis armies committed rape as a means of terrorizing enemy civilian populations and demoralizing enemy troops. The mass rape committed against German women by advancing Russian soldiers. Recruitment of children to serve on the frontlines during war is also a worst example of human rights violation. Thousands of children are recruited and used in armed conflicts across the world. Between 2005 and 2022

more than 105,000 children were recruited as recruited and used by parties to conflict. Warring parties use children not only as fighters, but as porters, guards and more. (UNICEF)
