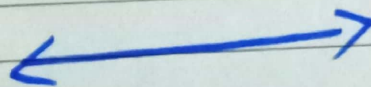

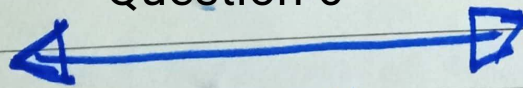

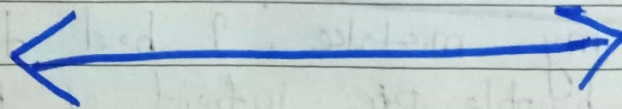

## QUESTION # 02

The regulation individual's behavior comes under municipal law whereas regulation of state's behavior falls under the ambit of international law. Due to lack of its foundation and social contract, it works in different way. International laws are made between states and it is not superior to anyone. Some lawyers argue that international law does not have mechanism of imposition of punishment. If rules are imposed on the state then it loses its sovereignty.

As per consent theory, imposition of any sanctions on any states comes after legal binding. If state accepts international law, it becomes effective.
