to commit the similar blunder as done in the past. When any nation or individual learns about the past events with the lens of a critique, they become more aware of different realities and hence any mistake or blunder similar to that of the past is least likely to be done in the future. This shows that learning from the past ~~sho~~ lightens up the way towards a better future.

When a person learns from the past and is well-enlightened about his/her past mistakes or areas where he/she could've done better, he/she is less likely to fall prey to the similar mistakes in the future. This 'learning from the past' idea is also true in the modern technological

advancements of the 21st century. The current boom of Artificial Intelligence and machine learning is all due to the fact that the new machines and AI models do not repeat the same mistake, and this is because they work on the iterative learning models. All the intelligent predictions done by AI and super-intelligent machines work on this principle. They learn from the previous results, take feedback and avoid making the same mistakes in future. This eventually makes them error-free.

To add further, past experiences are the major drivers behind any policy of the state with another state. The inter-state relations are heavily dependent on the burden of history. This is because states learn from their previous experiences and incorporate the lessons into their future decisions. One of the best example for this is the Russia-Pakistan relations. Pakistan has been historically inclined towards the (anti-Russia) American bloc in the international theatre. And, Russia has had more cordial relations with India than Pakistan. Not just the bilateral ties, but the history plays key role in the multi-lateral and global ties, policy making and peace process. No policy can be successful without taking into account the lessons of the past. For example, the Afghan peace process had a major role of history. Similarly, whenever the world deals with Iran, China, India or any other country, history is taken into account and all are dealt accordingly. If this same concept of 'learning from the past' is seen with the lens of Islam, we will see the same reality. Islam always emphasises on the fact that past is something to be remembered only for the lessons. From the life of the Prophet, it is evident that He^o used to take into account the previous experiences while making new policies or devising new plans. For example, He^o made this seal to put on the letters, sent to foreign lands, as the Prussians did not consider any letter as from the authority that used to be without seal. This shows how well did He keep His blessed eye on the history and used to align His actions accordingly.

At one occasion Hazrat Ali (R.A) who was a close companion and cousin of the Prophet^b said: A true believer is not bitten by the same snake twice. This shows how important it is for a muslim to take into account his/her past experiences, learn from them and then take any future actions.

Contrarily, a better future can never be achieved without taking into account the lessons of history. When a person or nation do not consider the lessons from the past, they would more likely be committing the same mistakes as done in the past. When the results and implications of past actions are not considered, same blunders are repeated by people and nations. For example, trusting the same person who back-stabbed earlier silently or maybe signing a deal with a country who had hidden agendas earlier but go unnoticed as nobody learnt from the past. Hence, learning from the past is vital to have a better future.

Similarly, when a country, person takes decision at a certain pattern without learning from the past, it becomes more predictive. The enemy could then easily predict the next move and attack at the most vulnerable segment. This all can be avoided by keeping an eye on the past, in order to ensure a safe future.

If Pakistan is seen in this context, the need to learn from history is the greatest at this time. The historical event of the fall of Dhaka and the rising insurgency in Balochistan both emerge from the same root and that is; the enemy exploiting the weaker segments of the society and state's lesser attention towards the backward provinces. The Bengalis were exploited by India when state did not incorporate their demands in national policy. The policy of inclusiveness was not followed then and the similar situation is happening in Balochistan today. The rise of BLA, backed by RAW and India is trying to repeat the history of East Pakistan in Balochistan. Now, the state of Pakistan should and must learn from history and cater for the demands of the communities in Balochistan to avoid any such tragedy to be repeated.
