Question 3

SOCIAL LEARNING THEORY

Social learning theory suggests that individuals learn behaviour by observing and imitating those around them.

This theory was given by Albert Bandura

The Bobo Doll experiment

Social learning theory is the result of the 'Bobo Doll experiment'.

Psychologist Albert Bandura showed children, adults that were violently thrashing a bobo doll. This was a controlled experiment.

After watching the adults, the children were then taken to a room with a bobo doll.

They would then imitate the behaviour of adults and ~~adults~~ similarly aggressive towards the Bobo doll.

Process of Social Learning

Albert Bandura suggested that learning occurs in four steps:

1. Attention
2. Retention
3. Reproduction
4. Motivation.

attention:

observing and paying attention to the behavior and act of those around them.

retention:

Ability of storing the memory of this act in the mind. Playing it over and over again in their thoughts as well as being able to retrieve it when needed.

reproduction:

Once given the opportunity, the action is then reproduced and imitated. Behaviour that is learnt is performed.

motivation:

After the behaviour is performed. The learning of such behavior is deemed successful and permanent depending on consequences of the action. Reinforcement and Punishment play an important in this regard.

If the behavior is reinforced, it is strengthened and learned. However, if the consequence of behavior is punishment, the action is withdrawn.

Social learning theory and Crime

Social learning theory explains that criminal behavior is learnt by observing crime and criminals. Association and exposure to criminals is how criminal behavior is acquired. Reinforcement and punishment are an important aspect in this regard.

Bandura's four steps of learning describe how criminal behavior is acquired by exposure to criminals.

→ observation and attention

Individuals that associate with criminals, pay attention to their behavior. They witness criminal acts and also communicate about them. They learn from the consequences of actions.

→ retention of criminal behaviour

When an individual is constantly associating with criminals, their behavior and actions are retained.

→ imitation of crime

Once crime is observed, individuals are inclined to imitate and reproduce the behavior.

→ reinforcement and punishment

of the criminal behavior is reinforced by financial gain, respect, status and no consequences, individuals are more likely to repeat and act criminally.

However, when criminal behavior is punished and has consequences, individuals are deterred from repeating the action.

Criminals as Role Models

Individuals acquire criminal behavior when they look up to the criminal. Especially when they are of high status and influential. This motivates the individual to be just like them.

Social Learning Theory in the Rehabilitation of Juvenile Delinquents

Juvenile delinquents are minors who exhibit inimical behavior.

Juvenile Delinquents are treated with more compassion as to

break the pattern of delinquency.
As children in their development phase, they are more prone to learning behavior.

Hence juvenile delinquents are not set on trial in different courts so as not to be exposed to criminals.

They are not handcuffed and their identity is kept private.

They are also kept separately from adult criminals and are kept in juvenile centers.

CRIME CONTROL INSTITUTIONS

The goal of such institutions is to create a peaceful society.

Law enforcement agencies

Law enforcement agencies include the police. In Pakistan, it includes the federal investigation authority, police, ~~and~~ the army etc.

In the United States, it involves the state police, Federal Bureau of Investigation. And the Central Bureau of Investigation in India.

Roles of Law Enforcement Agency

- To maintain Law & order
- To collect evidence
- Conduct interviews and take witness statements

- Request for warrants and make arrests.
- apprehend criminals.
- Issue penalties for breaking traffic violations.
- To deter criminal behavior.

Judiciary

Judiciary is a legal institution involving the courts that enforces the law.

adjudicates the criminals and corrects criminal conduct.

Roles include:

- To prevent occurrence of crime.
- Punish the criminal with appropriate sentences and penalties.
- To compensate the victim.
- To rehabilitate the criminal.
- To create deterrence from committing crime.
- To hear trials and appeals in a swift and timely manner.

Corrections

Correctional institutions include the system of jails, prisons and rehabilitation centers.

Roles of such institutions:

- To incarcerate the criminals and isolate dangerous and high profile criminals from the society
- To create a special deterrence from committing crime
- Rehabilitate offenders to reintegrate them into society.
- To carry out sentences given by the criminal court
- Rehabilitation centers include providing training programs and social support to low profile criminals.
This also includes parole centers.
- To ensure that criminals are taken to the court when needed.

While crime control institutions are essential, it is subject to ongoing improvement and evaluation. Collaboration and effectiveness of such institutions guarantee the harmony of society.
