

Q1] Who are entitled to receive Zakat? How poverty can be alleviated with its distribution in Islamic society?

\* Introduction: The Quran uses the term Zakat around thirty times. It is always mentioned with the term Salat. Zakat is as basic to Islam as other forms of worship such as prayer & fasting.

\* Meaning of Zakat:

In Islamic terminology, zakaat is the sum of amount which a Muslim pays to the poor people of community.

The literal meaning of Zakaat is "to purify" & "increase in a thing".

Its minimum amount has been fixed at 2.5 per cent of the wealth.

## \* Distribution of Zakaat:

Heads for the distribution of Zakaat has been mentioned in Surah Toba.

"Alms are for poor and needy."  
(Al-Quran)

## \* People entitled to Zakaat:

The following are the people who are entitled to Zakaat

### (i) Fuqarah & Masakeen:

Those who are really poor persons. Who do not own property or asset at all. Who do not own any property or asset in excess of basic necessity. Who own property in excess of basic necessity but excess is below nisab.

② Amileen: Amileen are those persons who are appointed by the state for the purpose of collecting zakaat.

③ Muallaft'ul Qulub:

This category refers to the poor & needy Muslims for the purpose of strengthening their heart. This can also be given to those who are expected to convert to Islam.

According to Imam Shafi, a rich person may also receive zakaat under this category.

④ Ar-Riqaab:

Slaves of Muslims who have or intend to free from their masters of a kitabah contract.

⑤ Gaarimeen:

The word gaarim means debtor. Zakaat can be given to a person to pay his debts.

Holy Prophet (P.B.U.H) said

I have been ordered to take Zakaat from the rich and distribute it among the poor.

It follows that the verse refers to a specific type of debtor, who is poor. His debts exceed his assets.

⑥ Ibnus Sabeel:

This category refers to a traveller who is in need during his journey & is deemed to be poor. Zakaat can be given to him according to his need.

⑦ fi-Sabeelillah:

fi-Sabeelillah means in the way of ALLAH. This category refers to those fighting for a religious cause or for Jihad.

① Alienation of poverty through the distribution of Zakaat:

The Prophet (PBUH) said:

"Poverty may lead to unbelief".

Thus, poverty is a threat to the faith & morals of an individual and the security & stability of society.

Following are important points in this regard:

① Equitable distribution of wealth:

The economic system of Islam has been founded on the eradication of usury & establishment of Zakaat & usher system. Wealth circulates from top to bottom through Zakaat system.

② Eradication of inflation through Zakaat:  
Inflation, which is a major

reason behind poverty, can be eradicated through the system of Zakat as wealth circulates from top to bottom.

③ Role of Zakat in economic stability

Eight categories have been mentioned in Holy Quran. Among those six are directly related to poor. Zakat transfers wealth from rich to poor. The poor spends this money to fulfil their needs.

④ Zakat increases investment:

A great impact of Zakat is that it eliminates the concentration of wealth because if a person hoards money he would have to pay Zakat. So fearing that his accumulated wealth would decrease, he brings it into circulation by

investing in some profitable businesses. In this way he contributes in reduction to unemployment.

### Circulation of wealth:

Zakat prevent the accumulation of the wealth in few hands.

"And it should not be that wealth is accumulated in few rich hands" (Al-Quran)

### Conclusion:

It is the duty of every Muslim to help his brothers. Zakat can help the society flourish. The circulation of wealth ensures it.

"ALLAH has blighted usury and made almsgiving fruitful." (Al-Quran)
