International law does not operate with a social consensus and a central authority imposing its rule with sanctions. International law does not exist above the states, but rather within them. Sovereign states and an international legal system do not go hand in hand. Sovereign states do not recognize the rules governing them and if they do then they are not sovereign - This issue is resolved by the theory of consent that when states accept international legal norms, these norms become binding on them, and they in effect, exercise their sovereignty. As international is based on this understanding, it is no surprise that its interpretation varies.
