Worst democracy is better than ~~the~~ best dictatorship because a government elected by the people eventually works in the best interests of the people. Even the worst democracy grants people the right to elect their representatives through elections. On the other hand, so-called ~~best~~ best dictatorship deprives citizens of their fundamental right of electing representatives. It would therefore not be wrong to infer that elected representatives in worst democracy are better than selected representatives in best dictatorship. Similarly, democratic institutions, even of worst kind, uphold civil liberties due to constitutional supremacy prevalent in democracy. In contrast, dictator's supremacy curtails fundamental rights given by the constitution. Furthermore, even the worst democracy has some accountability mechanism due to balance of powers and decentralization while in best dictatorship, the dictator is accountable to none. However, best dictatorship can be better than worst democracy. According

to Aristotle, democracy is the worst form of government. In his views, if a monarch is just and wise, it can turn out to be the best form of government. Dictatorship can also be effective in homogeneous societies, especially if democracy has failed to achieve results. Also, the political stability in best dictatorships can have positive socioeconomic implications. Although possibilities like these exist, yet worst democracy is better than best dictatorship.

**The** <sup>faulty</sup> Worst democracy refers to a democratic system which does not fully adhere to democratic principles. This is often prevalent in developing countries where democracy is weak and controlled. Bad governance is often a manifestation of worst democracy, having poor socioeconomic conditions. On the other hand, best dictatorship implies having the rule of a visionary and a charismatic dictatorship who typically enables the country progress in various spheres. These concepts of 'best' and 'worst' can have different interpretations, but, in general,

they refers to best and worst forms of governance

He One of the reasons worst democracy is considered better than best dictatorship is that worst democracy elects representatives, while best dictatorship is self-selected. Even in worst democracies, people have the liberty to participate in electoral process and elect their representatives. Since elected representatives are answerable on people's mandate, they work in the best interests of people. In contrast, even the best dictatorship is self-selected and deprives people from participating in elections and electing their representatives. A dictator selects his cabinet by his will, which therefore scarcely works to protect the interests of the dictator. Owing to the factor of elected leaders in worst democracy, it is better than a self-selected ruler in best dictatorship.

Similarly, worst democracy is also better because it upholds civil liberties, in contrast to best dictatorship which even curtails

Fundamental rights. It is due to the fact that constitution is sovereign in democracy.
