State Sovereignty and International Law

The national, domestic, or internal law of a sovereign state is called municipal law. It is defined in opposition to international law which is based upon governing the behaviour of states. International law operates differently from municipal law as it has no social consensus and central authority. As international law has no authority which provides rules with sanctions, many professional lawyers criticized its legality. International legal system and domestic legal system are not compatible in many ways. States are bound by international law because they accept international legal system which makes the states sovereign.
