Stages of socialization

1) Primary Agent of socialization

Differential association theory explains that how peers and neighbourhood impacts the behaviour of individual.

3) Learning through others modes

Classical conditional

Observational conditioning

Humans learn from their role models like parents, teacher or leaders. Hence, observation plays crucial role in learning.

Operant conditioning

Humans learn through impulses. As in an environment where he sees the continuously the same actions he become prone to such actions and adopt it through impulses.

Positive

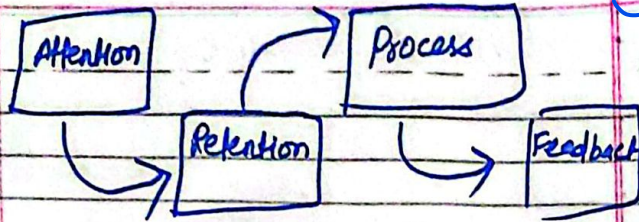
Positive reinforcement is to encourage a behaviour for repetition.

Feedback: He was being appreciated by friends in the game for killing enemies. Hence, it depicted the positive reinforcement by society. Hence, in this process, learning is completely through the

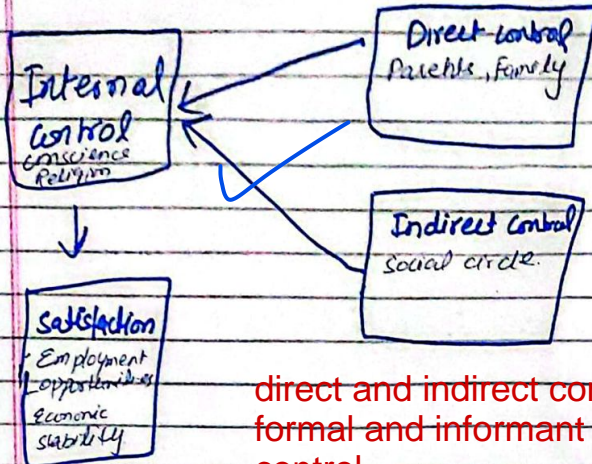
Increase in white collar crime

Beccaria through rational choice theory that humans

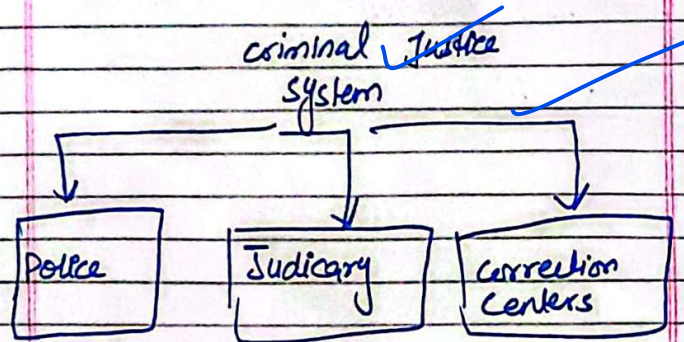

Criminal justice systems

Police :-
