interest in middle east.

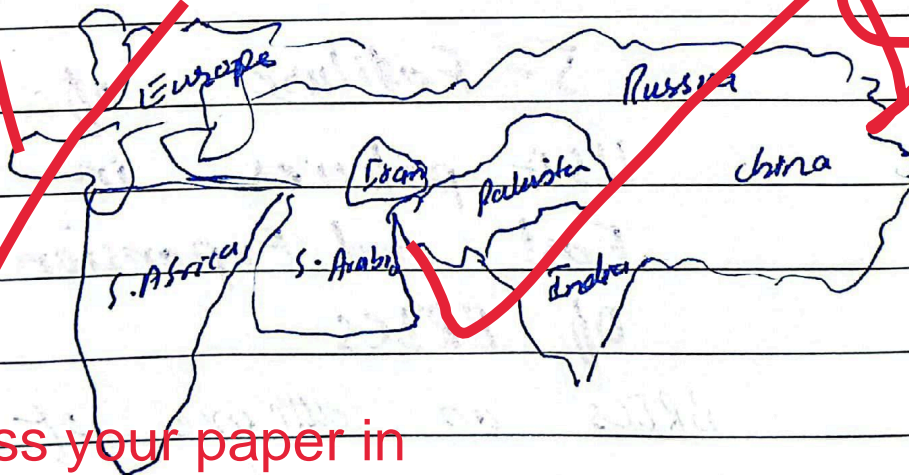
5 - Failure of USA policies in East and Expansion of BRICS

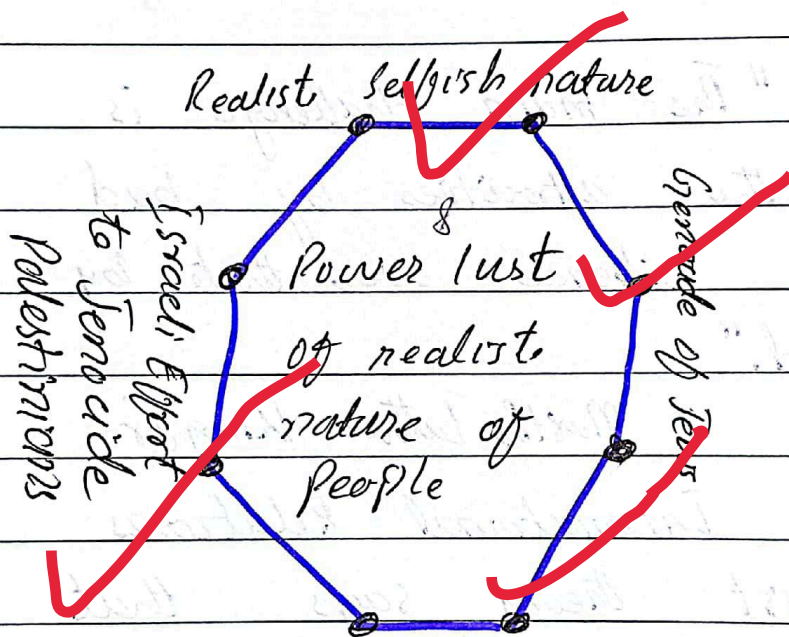

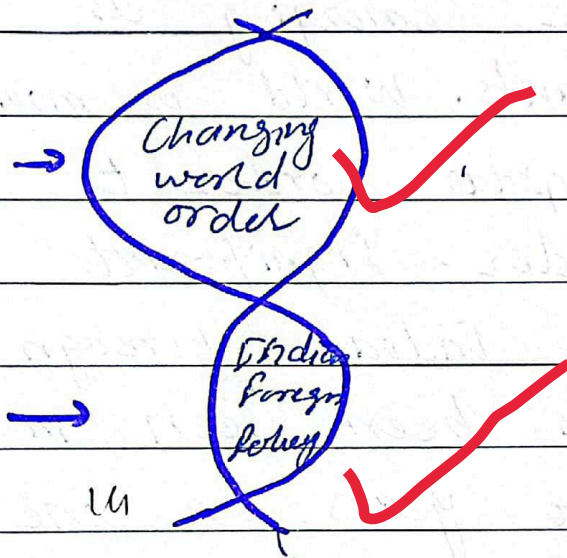
There has been seen a

in Indian foreign Policy.

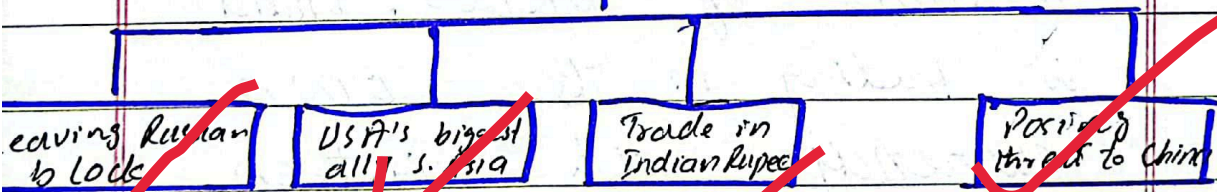
At present, United States

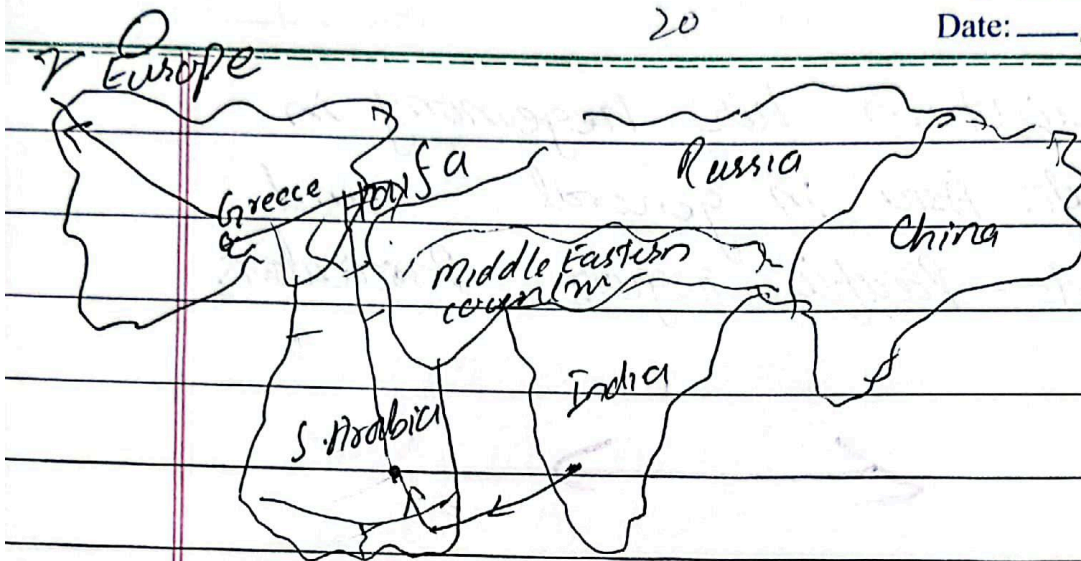

Hence, **G20** a group of twenty countries, has potential to transform

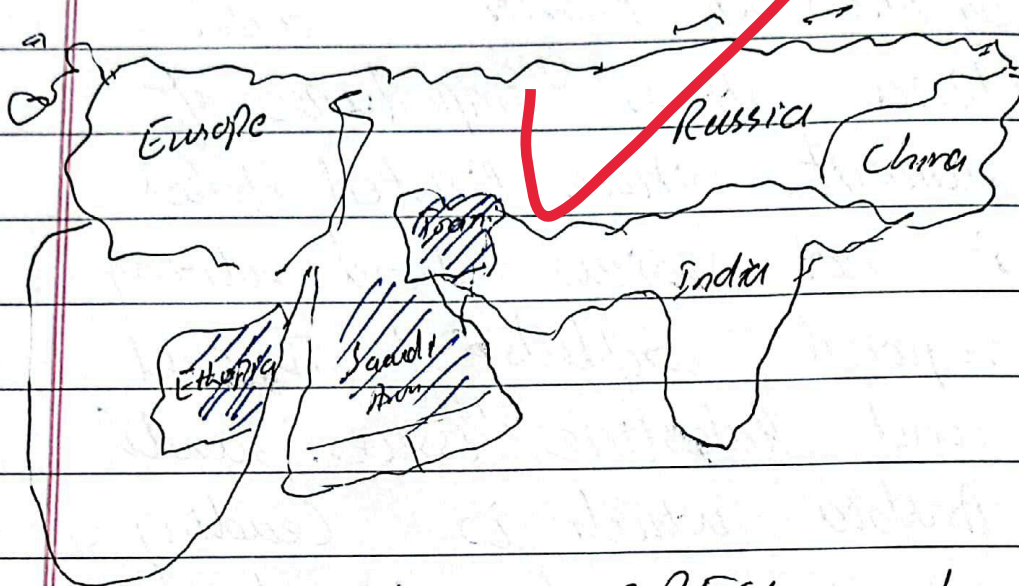
