Another important benefit of democracy is that the rights of people are upheld. Since sovereignty in a democracy belongs to the people, safeguarding people's rights is paramount. Any arbitrary policies aimed at undermining fundamental rights can have serious repercussions. Moreover, the governments are well aware that their way into powers depends on people's votes, so any attempts to sabotage these rights is tantamount to the government shooting itself in the foot. Reinforcing this notion, The Human Rights Index 2022, ranks democratic countries like Sweden, New Zealand at the top of the chart, while dictatorial countries like North Korea are ranked at the bottom.
