women in terms of their great status,

rights and equality in every field

of life.

Rights of women in Islam:-

Islam has given all the fundamental rights to women; some are described below.

Right to education:-

Islam has given the right of education to women. As, said by the Prophet Muhammad (P.B.U.H);

"Seeking knowledge is obligatory for every man and women"

This principle extends to both men and women, encouraging education for all individuals.

Right to Property:-

Legal rights:-

Right to dignity and respect:-

Roles of women in Islam:-

Women as Mother:-

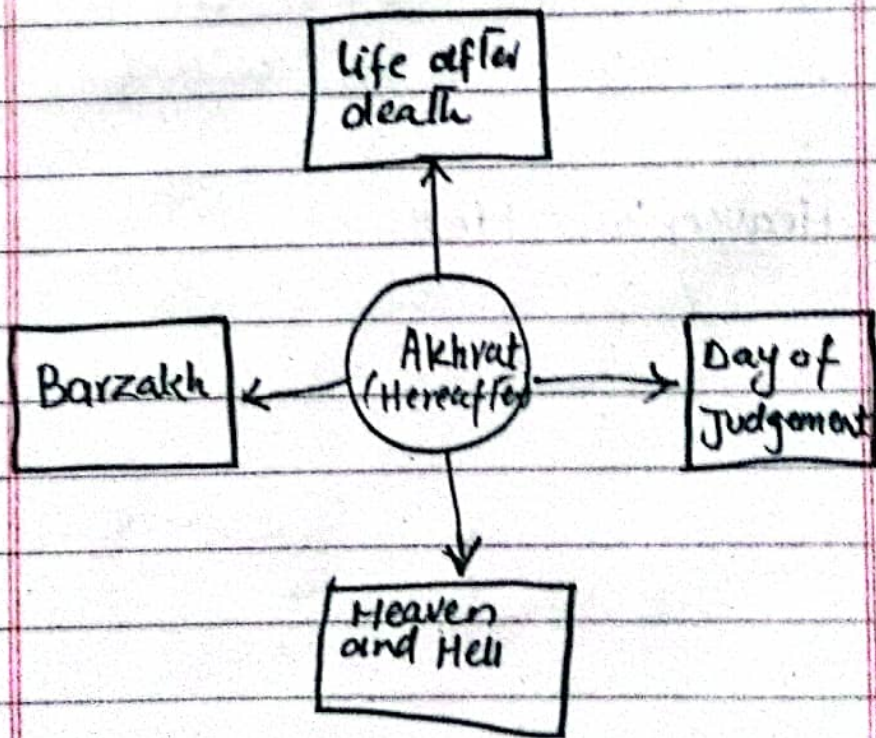

This is an intermediate stage between death and the day of judgement

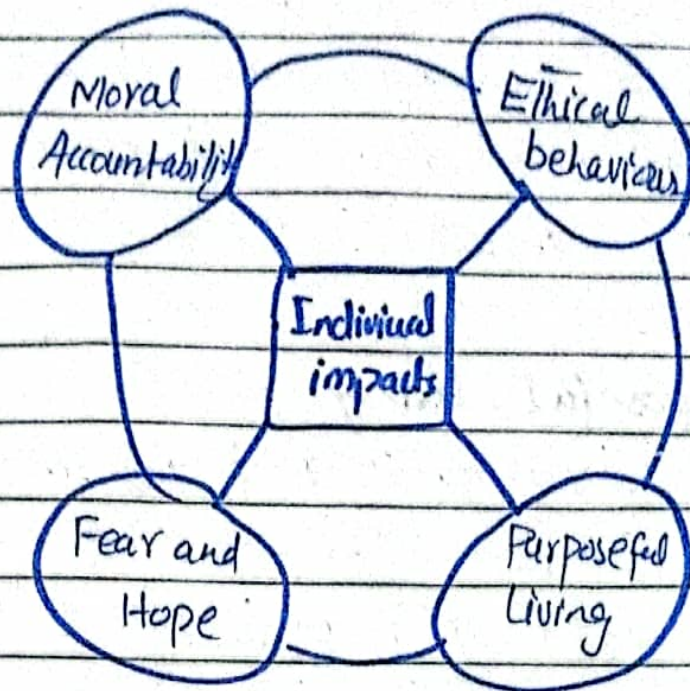
3. Day of Judgement

Muslims are encouraged to perform right deeds like kindness, honesty, justice for which they will be rewarded in hereafter.

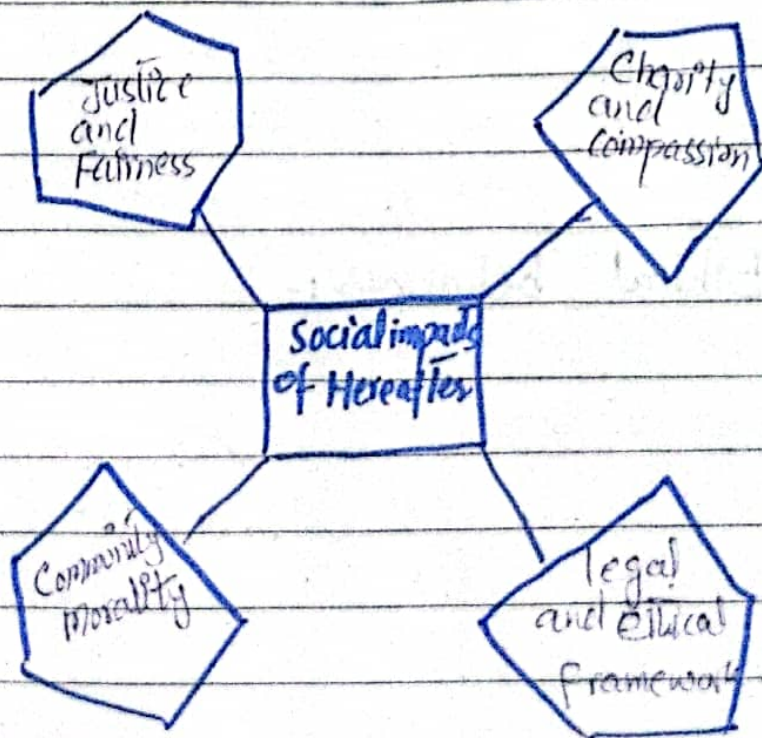
3. Fear and Hope:-

In summary, the doctrine of Akhirah profoundly influences both individual conduct and societal norms in Islam, emphasizing moral responsibility and justice.



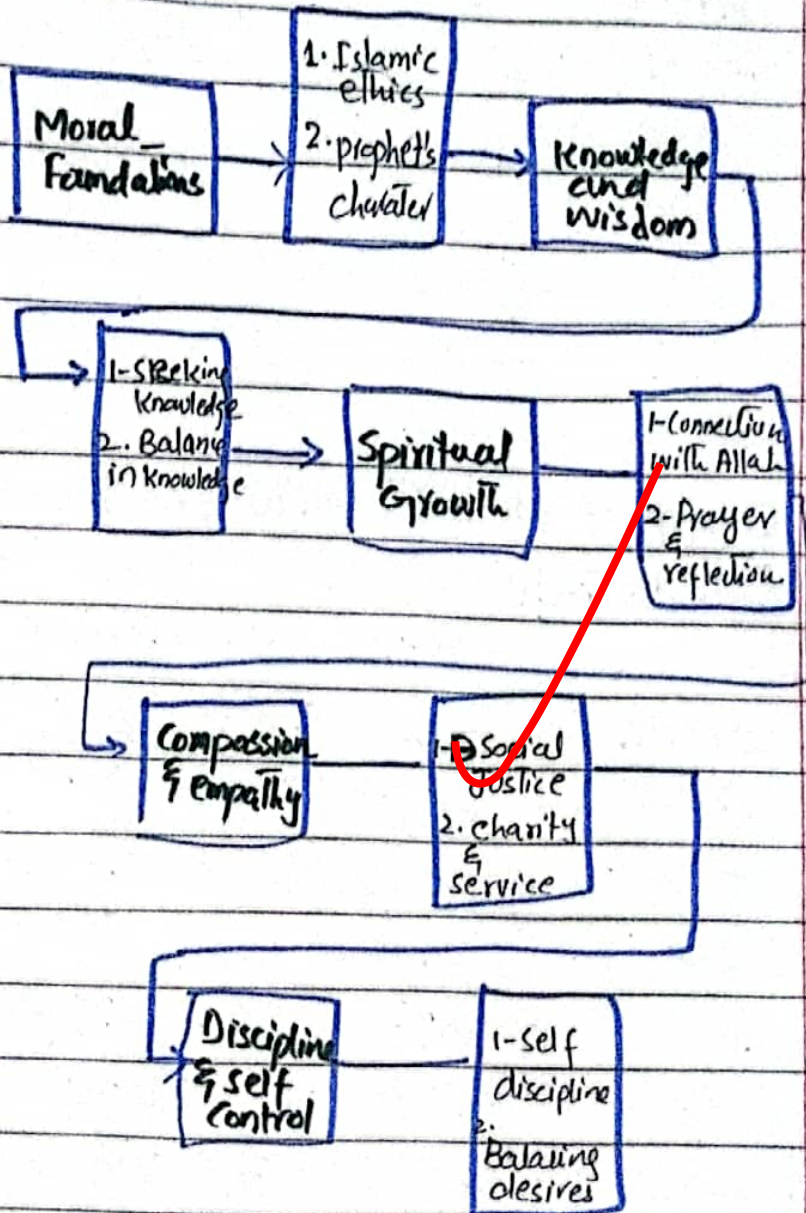
Q.No. Concept of character building in Islam:-

Self-discipline:

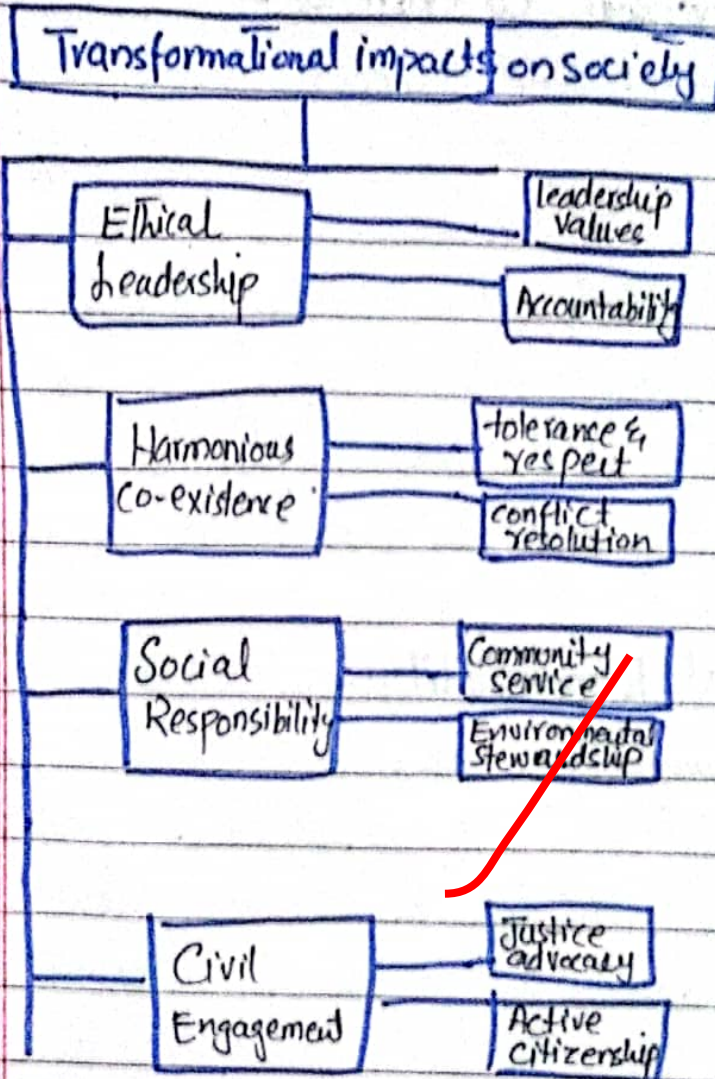
Islamic education emphasizes self-discipline, teaching individuals control impulse and follow the ethical principles.

To summarize, it is highlighted that character building through education in Islam, aims to produce individuals with strong moral values, including harmonious co-existence, social responsibility and civil engagement.

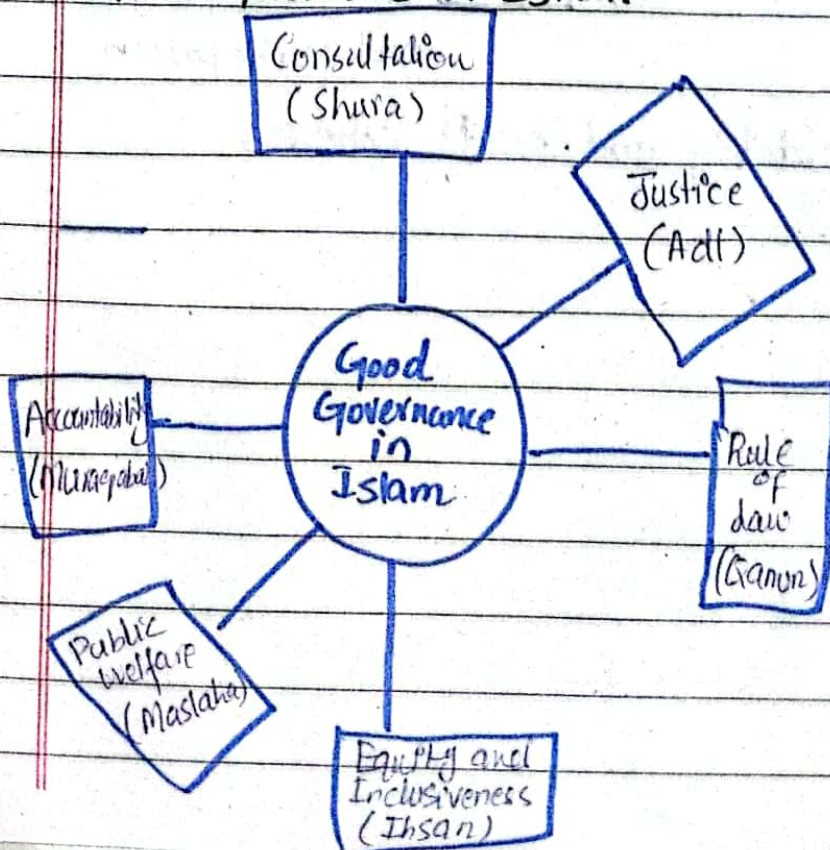


Qno-6 Concept and Principles of Good Governance in Islam:-

Holding leaders accountable for their actions, establishes transparency and discourages corruption, ensuring responsible government. It is also called Muraqabah.

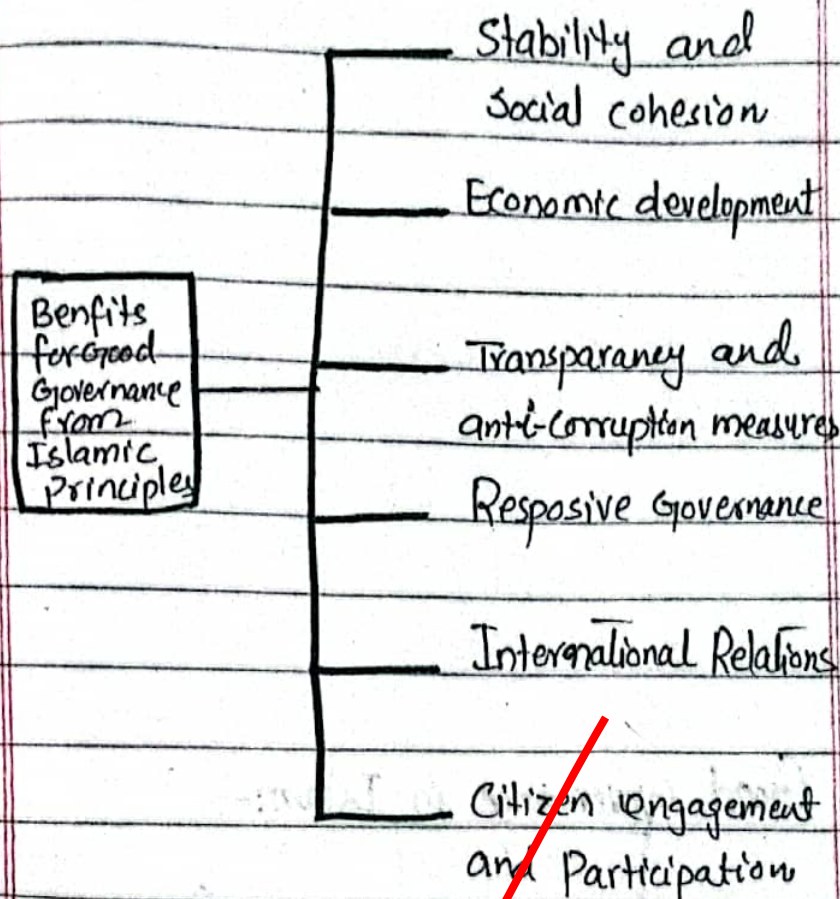
5. Public welfare (Maslaha)
