Recently, a heart wrenching incidents occurred in Rawalpindi. A judge employed a child girl for his household chores. The child was beaten, physically abused and mentally tortured. Her left arm was fractured when she was brought to hospital. Can someone after hearing this incident say that state is focused on child labor? Absolutely not! This is not just one case, there are plenty of others that do not get media coverage. State's neglect can be manifested in many forms like large number of children found in child labor, lax implementation of the law, presence of law regarding minimum age for employing child in only one province. Moreover, it can be manifested through blindness of media about child labour and silence of religious scholars. This would have adverse impacts on both state and life of child. This includes high out of school children, surge in juvenile delinquency, becoming a victim of inhumane treatment, placing country's future at perils and poverty of future leadership. Furthermore, it would lead to tarnishing of global image of the country.

According to International Labour Organization, one in four of the child in Pakistan is engaged in child labour. Therefore, child labour is rampant in Pakistan. Indicating its neglect by state

For surge in child labour it's the absence of strict implementation of laws regarding child labour. Although Pakistan has framed many policies and enacted many laws yet child labour is still reaching the ~~climax~~ heights. The reason for this hike is obvious that laws are only in black and white. In addition to local laws, Pakistan is also a signatory of international convention but still child labour is increasing. Therefore, Pakistan is neglecting child labour by not implementing strict laws.

Only one out of four provinces in Pakistan has law regarding the minimum age for employing a child. Every country has some ~~pieces~~ of laws which deal with matters related to children. This also includes laws related to child labour and minimum age for employing child. However, situation is different in Pakistan. The absence of law regarding minimum age for employing a child give ~~factory owners, industry owners and household owners~~ Reference? hand and impunity regarding

employment of child of any age. Hence, Pakistan is neglecting the plight of children by not enacting law regarding minimum age for employing a child.

Media is also blind about child labour - Media is often portrayed as third state - No one can ignore the power of media in highlighting issues and directing attentions of higher officials to any problem. However, media is oblivious about the child labour. The reason is crystal clear that media covers only those issue that can cause surge in TRP. The cases about child labour that media covers are few and far between. Media is busy in covering the example? fights and verbal spats among politician. Hence, child labour is not getting that much media coverage which it has to be.

Religious leaders and scholars are also silent about the rights of children. Islam is the religion that has covered each and every aspect of life. It ~~has~~ has even set forth the rights of animals then how it can forget to cover the thus problem of child labour. The

Problem is that the entire public knows only ~~that~~ much Islam that has been told to them by religious scholars. Unfortunately, religious leaders are ~~seen~~ silent about this very problem. They never give any ~~fatwa~~ regarding child labour. Therefore, neglect regarding child labour is also observed from religious 'sides' of the country.

This neglect has adverse ~~repercussions~~ on the life of children and the state - This resulted in large number of out of school children in Pakistan. Children, who are busy in labour, find no time ~~to~~ going to school. According to World Health Organization, there are about 23 million out of school children in Pakistan. Poor families are unable to pay the hefty fees of schools. According to survey, 80% children are out of school due to poverty (lack of concern of out of school children, Dawn).

Therefore, child labour is barring children from attending school.

Another obvious effect of neglecting child labour is juvenile delinquency. Children are very sensitive

to environment - They quickly learn from their environment - As they are immature, they ~~cannot~~ distinguish between wrong and right - Children who are employed ~~to~~ in factories, industry and at local dhabas are exposed to crime - They learn from environment and repeat the same in future - There are large number of juveniles in jails - Currently, there are about 1400 juveniles in ~~link to~~ jails and 90% of them are working child labour (Pakistan : Understanding Juvenile Delinquency, Eurasia review). Therefore, Child labour is causing surge in juvenile delinquency -

Children engaged in labour are falling victim to torture and inhuman treatment - Children ~~no~~ ~~no~~ ~~no~~ are ~~walk~~ ~~on~~ ~~on~~ unable to defend ~~an~~ attack on them - Children in employment often face harsh treatment ~~of~~ ~~from~~ their owners - The case of Firziana is epitome of this who was battered and bruised - Other than that children are often sexually abused by their owners - The recent report by Unicef revealed that in 2023, around 21500 cases of child

are reported in Pakistan. Therefore, children are prone to physical and sexual violence in employment.

Child labour put future of country at perils. Children are future of Country. If children are not groomed well then the future of the country would be obviously at danger. Child labour bares large number of children from attending school. This would have repercussion on country in form of high illiteracy rate. Children, who are engaged in labour, are more prone to criminal tendencies. This would ultimately cause surge in hate of terrorism. Therefore, child labour has tendency to mar the future of country.

**Negatives of** Child labour would result in lack of leadership for the country in future. The children of today are the leaders of tomorrow. If these children are **groomed** well, they would make efforts in future to bourgeois the country. However, they would be unable to grasp necessary <sup>skills for</sup> leadership. Their cognitive ability would not be upto the mark. 37 out of 100

children are at risk of cognitive limitation in Pakistan (~~Human Capital Development~~, Dawn). Their education should not be suitable for effective leadership. Therefore, Pakistan would likely to face leadership crisis due to child labour.

### Link with neglect

Child labour would also lead to ~~furnishing of~~ global image of Pakistan. Pakistan would be unable to compete at ~~global~~ level. Nowadays, the entry into global platforms are made conditional. Countries have to fulfill certain demands before getting entry. Another thing is that the progress of country is often measured by literacy level. Child labour diminishes the literacy level. According to Pakistan Bureau of Statistics, literacy level of Pakistan is 59%. Child labour would also cause surge in terrorism; thereby blocking the entry of Pakistan in global reputed platforms. Thus, child labour would spoil the global image of Pakistan.

• There are higher chances of children engaged in child labour to indulge in drug abuse. There are large number of drug abusers in

Pakistan - According to Anti-narcotics Force, there are about 7.6 million drug abusers in Pakistan. Children in labour have often lax parental oversight on them. This would greatly increase the chance of drug abuse as mentioned in Social control theory of Criminology. Moreover, children are also used for transferring substance from one city to another. Therefore, children in labour are at higher risk of substance abuse.

Child labour would also cause surge in terrorism. Terrorism is growing problem for Pakistan. Enhancing levels of child labour is preparing fertile grounds for terrorist outfits for employing. Children engaged in labour often have low cognitive ability. They are unable to understand the traps of these outfits. They lure them by promising them of financial benefits. Moreover, it is more easier to brainwash these innocent children than the mature ones. Therefore, child labour is making the children soft target of these outfits.

There is a dire need for taking some effective steps for curbing child labour. One of the steps is to the strict implementation of article 25A of Constitution. This article is related to free education - Government should make efforts to impart free education to children. It can collaborate with NGOs and international donors for financial assistance. It should build educational institutes in far flung areas of Pakistan. The government should appoint its officials in every tehsil to check whether all the children are going to school. It should check attendance list of schools and meet the families of missing children. This would curb child labour.

Impose strict fines on those households that employ child. This law should be uniformly apply to all parts of country. All the households that employing any helper and servants should register themselves ~~provide~~ in government records. They must ~~provide~~ give all the information of the helper including number of children that helper has. The government should ensure this that child

den of that helper are enrolled in schools. This can be done by contacting relevant authorities of areas where that helper lives. This can greatly reduce the child labour.

Another step that can be taken in this regard is to counsel the children parents regarding the detrimental effects of child labour. They must be informed that monetary benefits that they get from child labour are temporary. If they give chance of education to their children then they would get high and permanent monetary benefits. They must be informed about recent cases in which child faced harsh circumstances and treatment due to employment. This can be done through seminars and individual counselling. Thus, this step has potential to diminish the levels of child labour.

Poor families should be provided with material assistance during the start of every month. This assistance should be in the form of edible items not in the cash. Many parents engage

their children in labour because of their indigent condition. If their necessities are fulfilled there are greater chances of continuation of this practice. Therefore, fulfilling material necessities of family can banish child labour.

In a nutshell, Pakistan is showing neglect in addressing child labour. There are large numbers of children engage in labour, for implementation of laws, <sup>absence of</sup> no law mentioning minimum age for engaging child in labour and media is blind about this issue. This have adverse impacts on both child and the country. This include surge in out of school children and juvenile delinquency, placing country's future at perils and falling victim to drug abuse, terrorism, outfits and inhuman treatment. However, all the purposed steps have potential to save the child and country. These steps are implementing laws, imposing fine on child labour, counselling children's parent and providing necessary material assistance to poor families.
