Pakistan is ranked 88~~th~~ among 132 economies by the Global Innovation Index 2023. Pakistan had a GDP per capita of USD 1,474 in 2023, ~~is~~ compared to USD 14,300 a decade earlier. The figures show a constant decline from past few years. The reasons may be immensely vast but the fact lies in a challenging future ahead.

After getting rid of the economic default of the country, Pakistan went into a debt trap. International Monetary Fund (IMF) gave funds but sanctions were also imposed by them. Continuously

PAKISTAN RESOLUTION & THE PAKISTAN MOVEMENT

Introduction:

With the beginning of the World War II in September 1939, the Viceroy of India Lord Linlithgow declared India's entrance into the world war without consulting the provincial governments. In this situation, Jinnah called a general session of the All-India Muslim League in Lahore in 1940 to discuss the circumstances and also to analyze the reason for the defeat of Muslim League in the Indian general election of 1937, in some Muslim majority provinces.

Pakistan Resolution 1940:-

On March 23, 1940, at its historic session held at Minto Park in Lahore, the Muslim League passed the historic Lahore Resolution that came to be commonly known as the Pakistan resolution, demanding a separate

home land for Muslims of the Sub-continent.

Demands of the Resolution:

The resolution moved by the Bengal Chief Minister, A.K. Fazl-i-Haq, and introduced by Chaudhry Khairuzaman and others inter alia, formally called for the creation of an independent state in the regions where Muslims constituted a majority.

The resolution repudiated the concept of United India and recommended the creation of an independent Muslim state consisting of Punjab, NWFP, Sindh, and Balochistan in the northwest, and Bengal and Assam in the north east.

It was made a part of Muslim League's constitution in 1941.

Pakistan Resolution: The Magna

Carta of Pakistan Movement:

Magna Carta is being a base considered a base of human rights in the world. Some is the importance of Pakistan resolution for Pakistan.

The demand had a great appeal for the Muslims of every persuasion. It revived memories of their past greatness and promised future glory. Therefore, they responded to this demand immediately and the Pakistan Movement was started.
