Laws regarding child labour. As people have no fear about strict implementation of laws, therefore, they keep on employing children to work for them. Children are seen working in mines, factories and farms. Despite legislation against child labour, corruption and lack of awareness allows the employers to exploit children for cheap labour.

All this makes them easy targets of cheap labour. In the world's poorest countries, slightly more than 1 in 5 children are engaged in child labour (UNICEF, June 2023).

Furthermore, poverty and rising inflation are another major cause of child labour. Poverty makes one forget all morals, and rising inflation acts as the last nail in the coffin.

They are made to work above their basic potential which hampers their physical well-being. They are employed in heavy labor for continuous hours and without proper food. They are even paid unfairly for their heavy duties.

According to National Labor Survey of Pakistan, 6% of working children (5-14 years) frequently suffer occupational injuries. Concluding sentence

anxiety and severe stress. It also leads children to the use of cigarettes and drugs, making them drug addicts. It hampers their normal functioning of their mind. They lose their creativity and analytical abilities as well.

Child labour forces the kids to face the maltreatment at work and survive all the tough situations themselves. They are underpaid for their work. They are overworked for their shifts. They are exploited at all levels for cheap labour.

Children also face abuse at their workplace. They are often severely tortured for not working well or learning the new skills. They are also abused mentally and physically.

WHO reports "high burden of mental and physical (19.1%) and sexual violence (8.5%) among child labourers" working in Pakistan.

Furthermore, the literacy rate of the country nearly depends upon these illiterate souls who are deprived of their education. Children are forced to work and skip school in order to earn for the family, which adversely impacts the

literary value of the country. child labour also leads to economic exploitation as well because children are not properly paid for the heavy labour that they perform. This leads to a disrupt in the economic flow and economic cycle of the society. lastly, child labour drives the innocent children into wrong hands.
