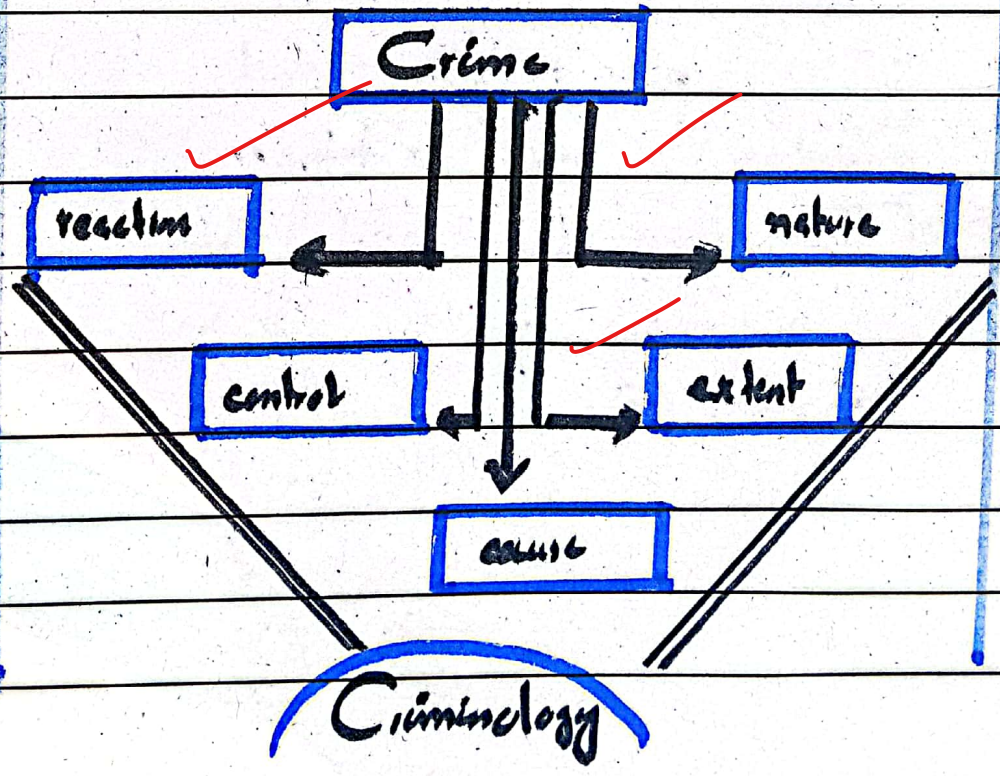
2. Definition and explanation of

'Crime is a social injury, varies from place to place and time to time.'

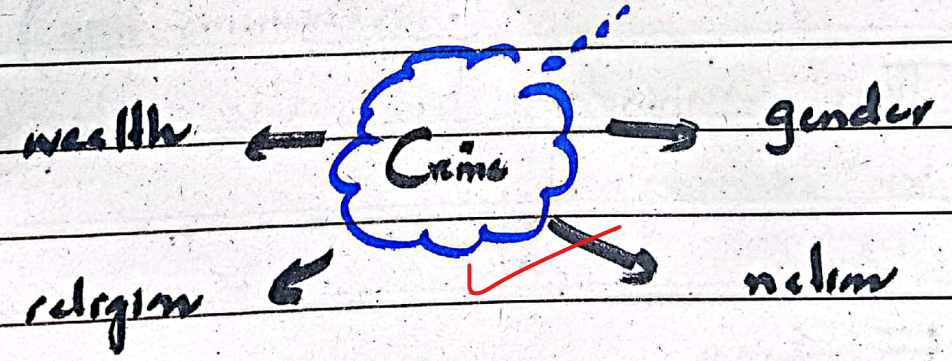
This shows that social factors are also paving a way for understanding Criminology.

Demographic Shift

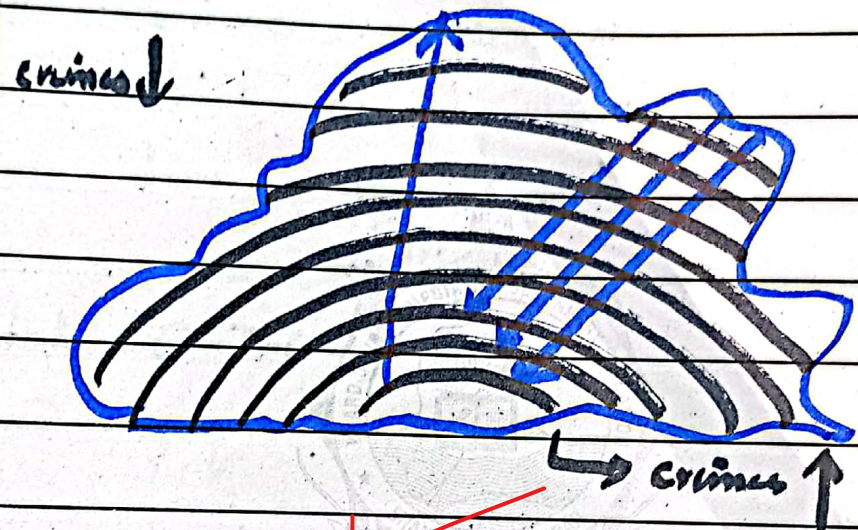

huge influence on criminality.

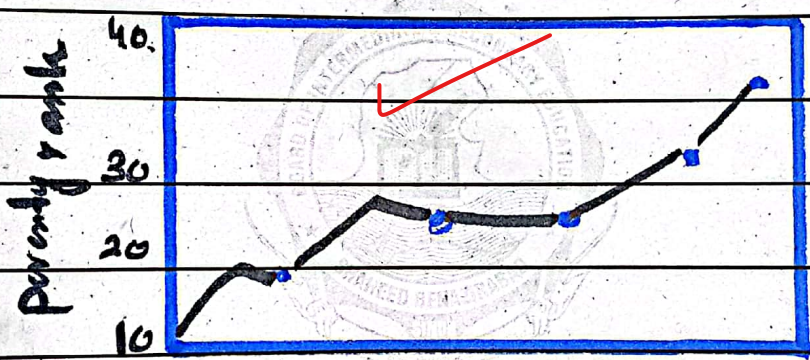
"Poverty is a main cause of crimes."

This highlights civic engagement in public policy development.

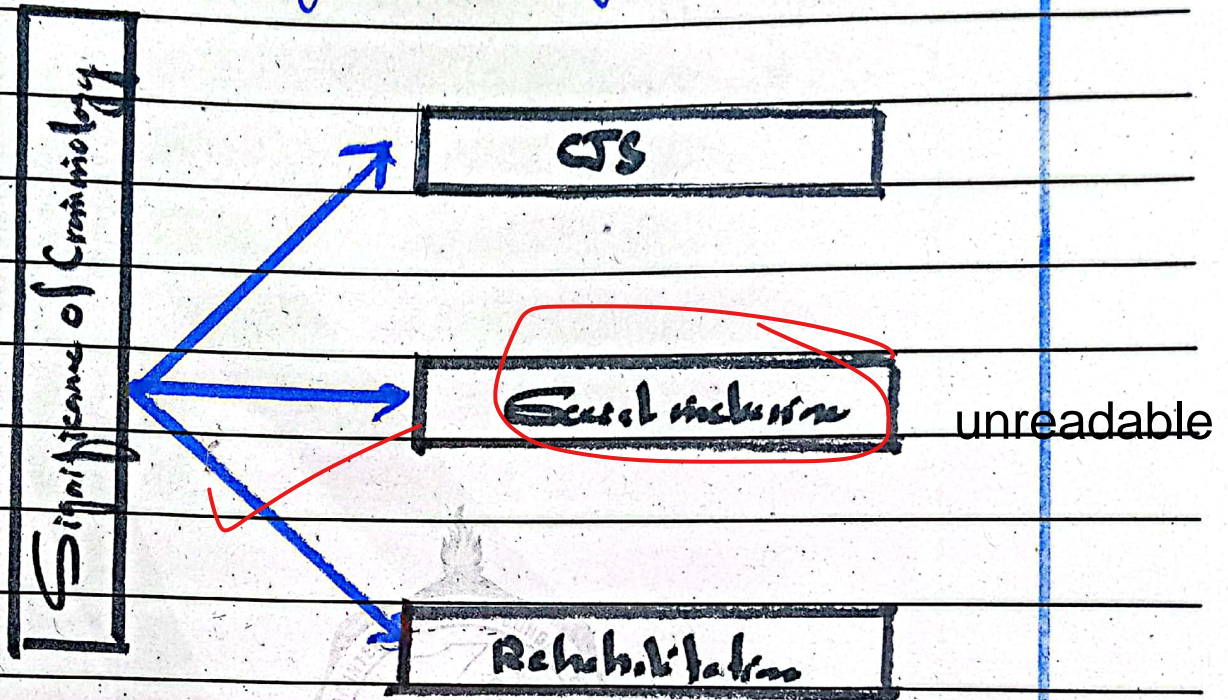
c) Rehabilitation of the offenders
