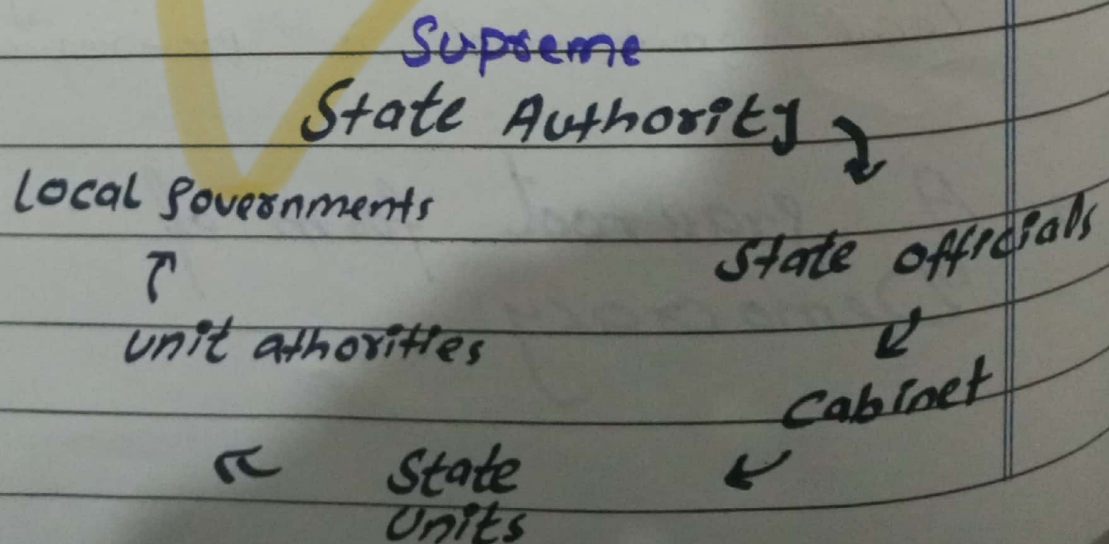
What is a local government system?

"It is image of devolution of power"

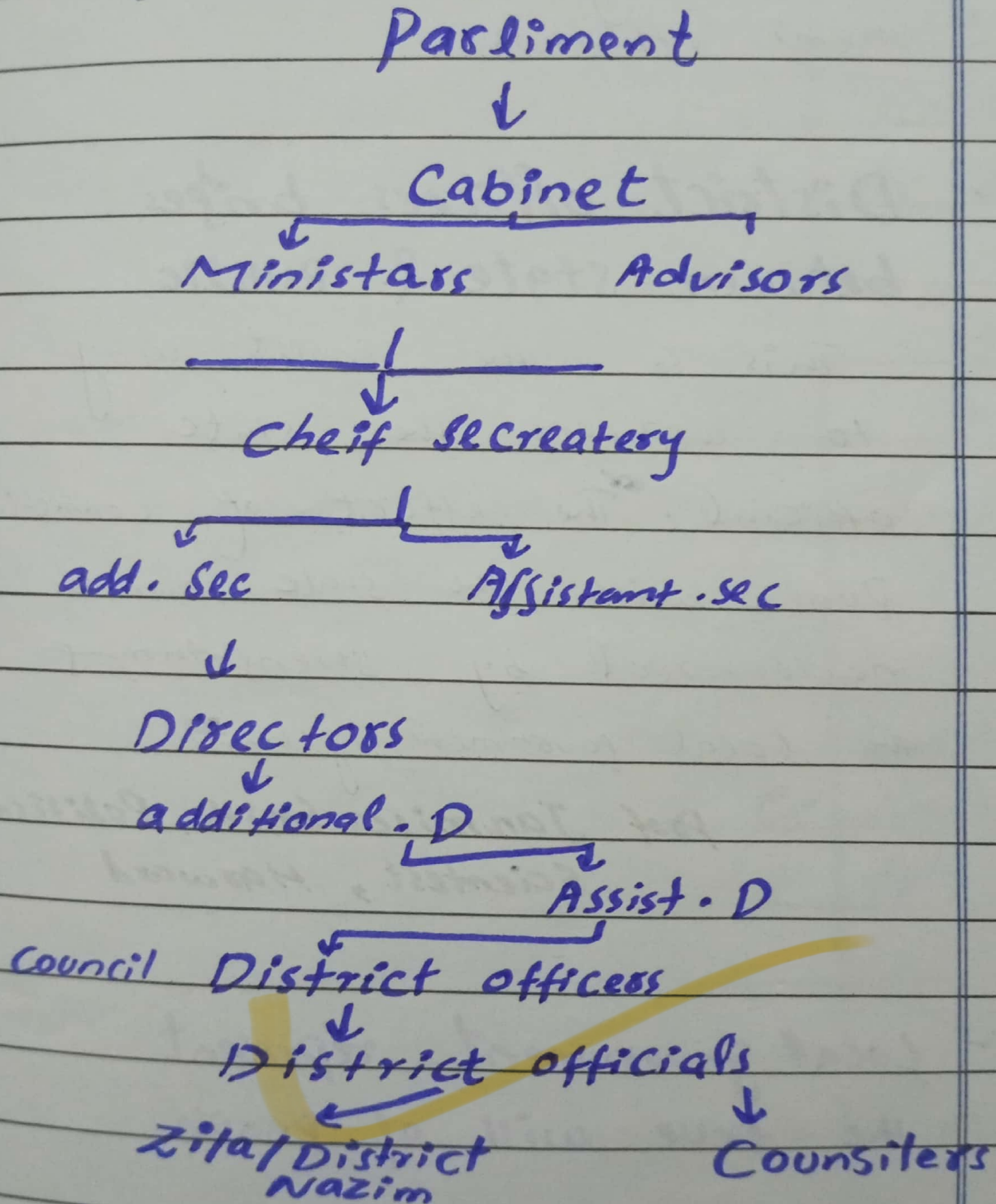
How local government works?

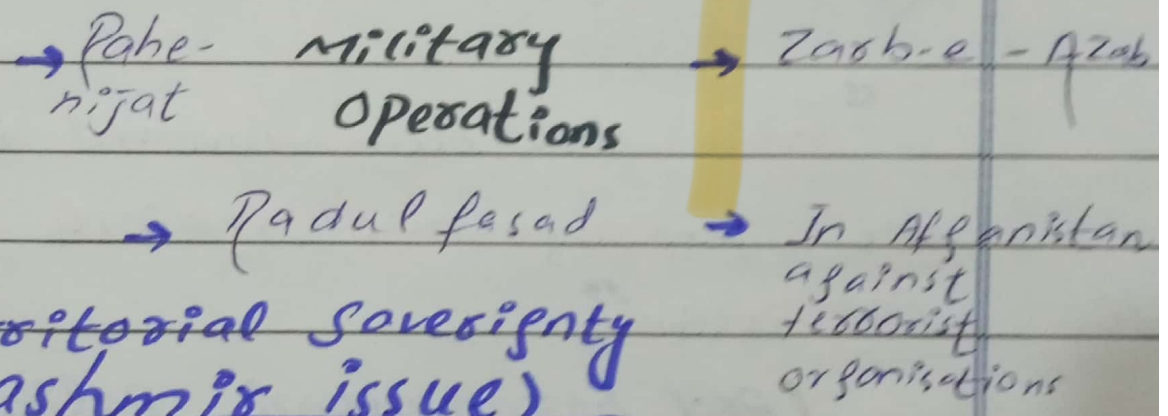

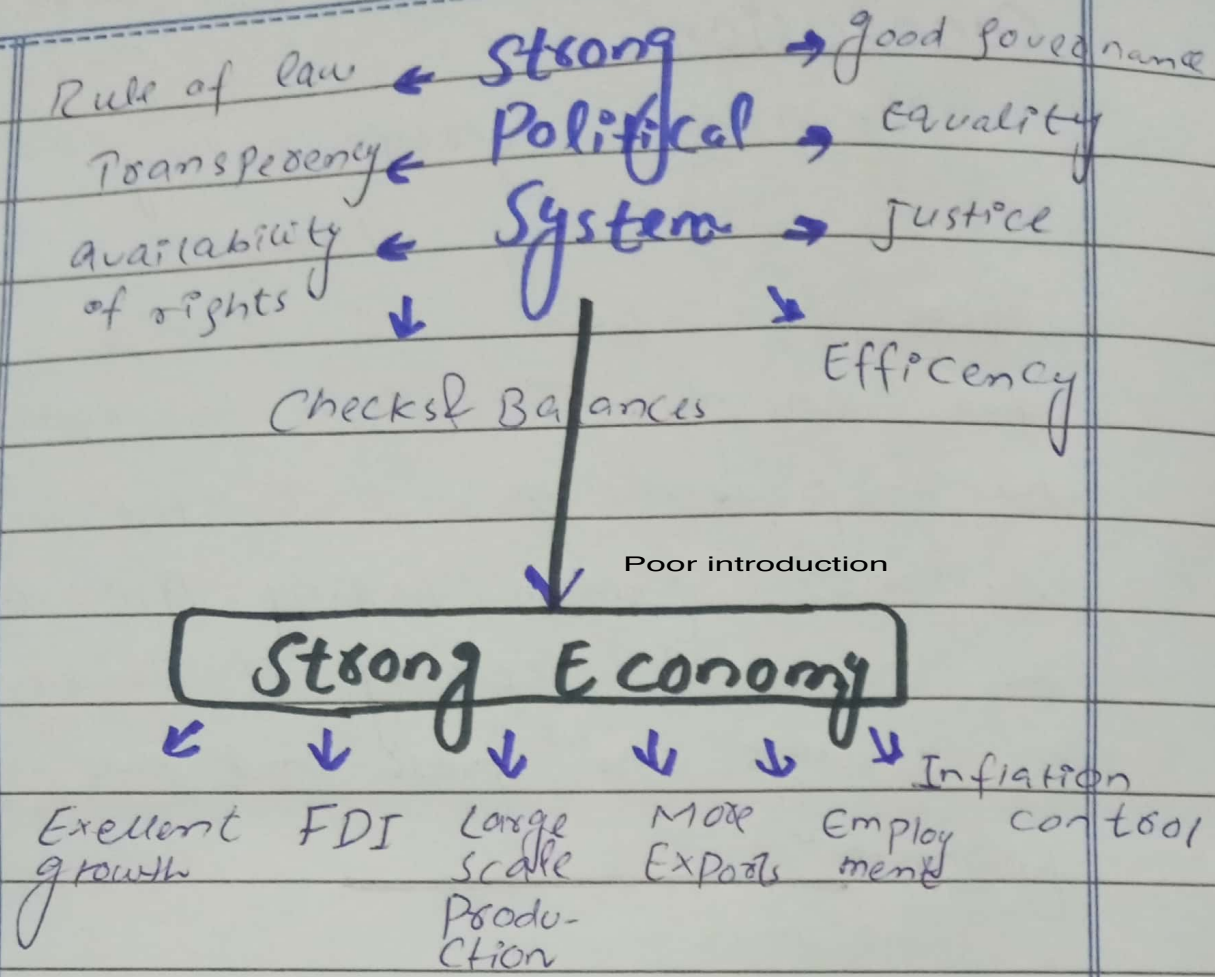
