International law regulates the behavior of states just like domestic law regulates the behavior of individuals. However, both the laws are different in nature. Unlike domestic law, International law is not a result of a social contract nor does it have a governing authority to enforce its rules. It is often regarded as "not a true law" as it lacks binding force. The sovereign status of a state and International legal system stand contradictory. Sovereignty means no superior authority exists above a

state to bind its behavior. However this contradiction is resolved by the "theory of consent" that asserts that International law is accepted by "free will" of the states. A debate revolves around the vitality of International law. Some regard it futile while others hold that it can bring peace in the world but on neither camp recognizes the true essence of International law.
