The Unique Nature of International Law

International law governs state's behavior while Municipal law governs individual's behavior. Both are different in nature. International law operates without central authority, that authorizes sanctions, and is between the states. Some jurists deny its legality because it lacks sanctions. If states are sovereign, law does not bind them, and if it binds them, they are not sovereign. Theory of ~~Contract~~ Consent resolves this contradiction. It claims that states consent to the law. Court in Wimbledon Case held that states consent to a treaty and abandon certain sovereignty. Therefore, its practice varies widely. Some view it a sham while others view it as a chance to ensure world peace. Neither of the view comprehends the unique nature of International law, ~~It~~ as it expresses state sovereignty and its limitations globally.

"Ad hominem" is a tactic used to discredit a person rather than the issue at hand. It has nothing to do with the case, but the health, mistake or condition of a person can be used to destroy someone's credibility. Just like Lincoln used the dressing mistake of his opponent to win the case. When there is one cannot argue, one can abuse the opponent.

Lincoln directed ad-hominem towards an experienced lawyer. He might have given him a befitting reply or countered with another ad hominem. The court might also not have liked this tactic.
