Q2 Precis :-

Similar to the municipal laws which govern the individuals' behaviours, international laws govern states' behaviours. But, unlike its name, international law operates without formidable consensus or a legal implementation. It is just a non-binding mutual agreement between states. Thus, some regard it as nonlegal. State sovereignty and a sanctioned legal system are contradictory. The 'theory of consent' resolves this conflict saying that mutual consent and acceptance of international law helps to exercise sovereignty.

The World Court in "The Wimbledon case" labels the binding nature of any treaty a contradiction to state sovereignty. Therefore, some evaluate international law as fiction, others expect lawyers to ensure world peace by making international laws. Nevertheless, international law balances state sovereignty and global order. (Word count: 119)

The value of his argument. Hence when someone abuses the ad hominem during the hearing of a case, he actually tries to divert the jury's attention from the merits of the case to the maintainability of the ad hominem i.e. the opponent.

(2) Lincoln succeeded in convincing the jury by his political shrewdness and non-malicious use of ad hominem. He was aware of the jury's taste and when he saw his opponents' faltering senses, a glimmer of hope could be seen in Lincoln's eyes although the merits of the case were against him. In view of the result, Lincoln's tactic does ~~not~~ matter as the legal points were on his opponents' side. Hence, Lincoln's political shrewdness and cleverness helped him win the case.

(4) Lincoln risked his case by using ad hominem as if the jury, despite of being biased towards the dressing of Lincoln's opponent, remained unbiased towards the merits of the case, Lincoln would have lost it. Lincoln was fortunate that the jury agreed with him and decided in his favour. One opposing Lincoln, could have countered his move by asking the jury to intervene in the personal attack by Lincoln. Moreover one could also argue that Lincoln himself is not aware of the fashion as the shirt is designed to be buttoned up from the back.
