Social Learning Theory explains that crime is a by product of interaction with intimate and it is a product of learning. Crime is learned.

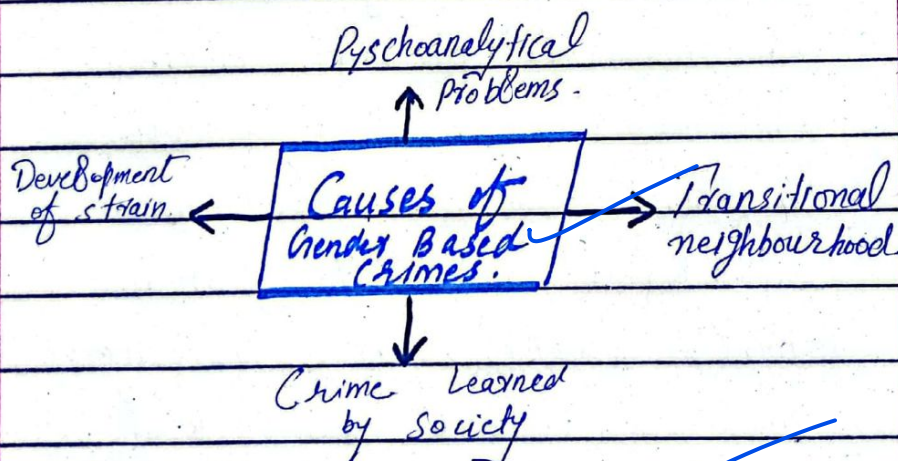
This means that Gender Based Crimes are learned by society.

Situation of Gender Based Crimes in Pakistan.

Learning theory is criticized that it ignores the other factors which help to adopt a criminal behaviour such as psychological health, lack of social involvement, and biological factors. But this theory has helped to understand that criminal behaviour is also learned.

Social Learning theory:

Social learning is early developed by Edwin H. Sutherland, it is also developed by Albert Bandura's social learning theory. This theory has helped to understand that the criminal behaviour is properly learned. It did not explain that it is an asset of a poor people or particular caste. This theory also helps to understand other types of crimes.

Social Learning theory and White Collar Crimes.

Social learning theory also helps to understand that white collar crimes also learned. The upper and elite class learned that how they can commit white collar crimes in a more sophisticated manner. So social learning theory has helped us to understand another aspect of criminality.

Principles of Social Learning Theory.

The following are the principles of social learning theory.

Crime is learned.

The first principle explains that crime is learned. For example a thief learns the techniques how to hide a thing.

Crime is by production of interaction.

This explains that crime is learned when a person meets with other defiant and criminal group's members.

Crime is learnt by intimate

This explains that crime is learnt by intimate people such as mother, father, friends etc. For example: if father is alcoholic, there are more chances

that his son is also an alcoholic.

Criminal techniques are also learned.

Criminal techniques which helps to commit a crime is also a learned. For example, a thief learns how to open a lock without a key.

Perception of law and consequences of crime also helps.

Perception of law and consequences of committing a crime also help to commit a crime or not. For example, cost-benefit analysis of a crime help a criminal to commit a crime.

Duration, intensity and frequency of interaction is also important.

It is also very important to understand the intensity, frequency and interaction of a person with his defiant peers and other intimate partners.

Criticism of Social Learning Theory:

a) Critics argue that social learning theory just explain that people commits crimes because they learned it but it does not explain why a person decided to commit a thref and other Kill a person.
