Title: The Nature of International Law

International law, much like domestic law that governs individuals, set norms to govern states. But

unlike the domestic law that require social consensus and is above the individuals, international law ~~is applied~~ on the states. Nevertheless, the nature of both domestic and international law is not same. If there is a central binding authority in international law the sovereignty of state is undermined. Similarly, if there no central authority the law becomes unbinding. However, the theory of Consent attempts to settle this contradiction

by claiming that the consensual acceptance of law by states is akin to exercising sovereignty. Similarly, world court declared the concept of abandonment of sovereignty in case of not conforming to international law.

It is due to this nature of international law, it is often regarded as a sham.

① Ad hominem is a tactic used when the opponent's arguments are strong and the defender is not able to state the argument. Instead he tries to discredit the argument by abusing the attorney advancing the case. For instance, Lincoln used this technique to win the case by highlighting that his opponent doesn't even know which side of the shirt ought to be in front.

② Lincoln succeeded in convincing the jury by highlighting his opponent's shirt that he does not even know which side to wear on the front. He ^{pleaded} jury not to be influenced by his pretended knowledge of law as he does not know the right way to wear a shirt.

③ Lincoln's tactic was non-malicious as he knew the reaction of the jury when his opponent took off his coat and vest. They too noticed his shirt which buttoned up the back. It does not matter whether the tactic was malicious or not as it is up to the jury to decide. Attorneys mostly lose such tactics to divert the attention from the real issues.

④ Lincoln used the tactic of ad hominem to undermine the credibility of actual argument and won the case. It can be said that he did not take

any risk. If I had been an opposing lawyer in a similar situation, I would have tried to counter Lincoln's move by convincing jury that I wore the shirt wrong way to see if Lincoln in the absence of real counter points tries to discredit the argument or not through personal attacks such as commenting on some one's dressing.

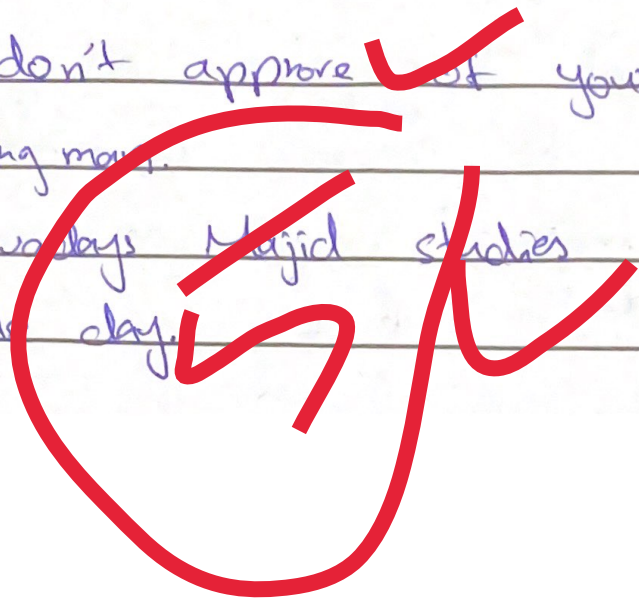

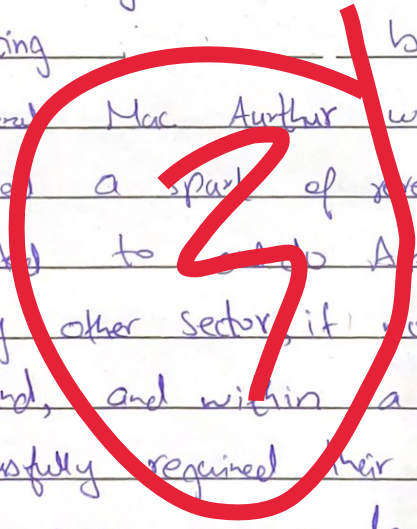
