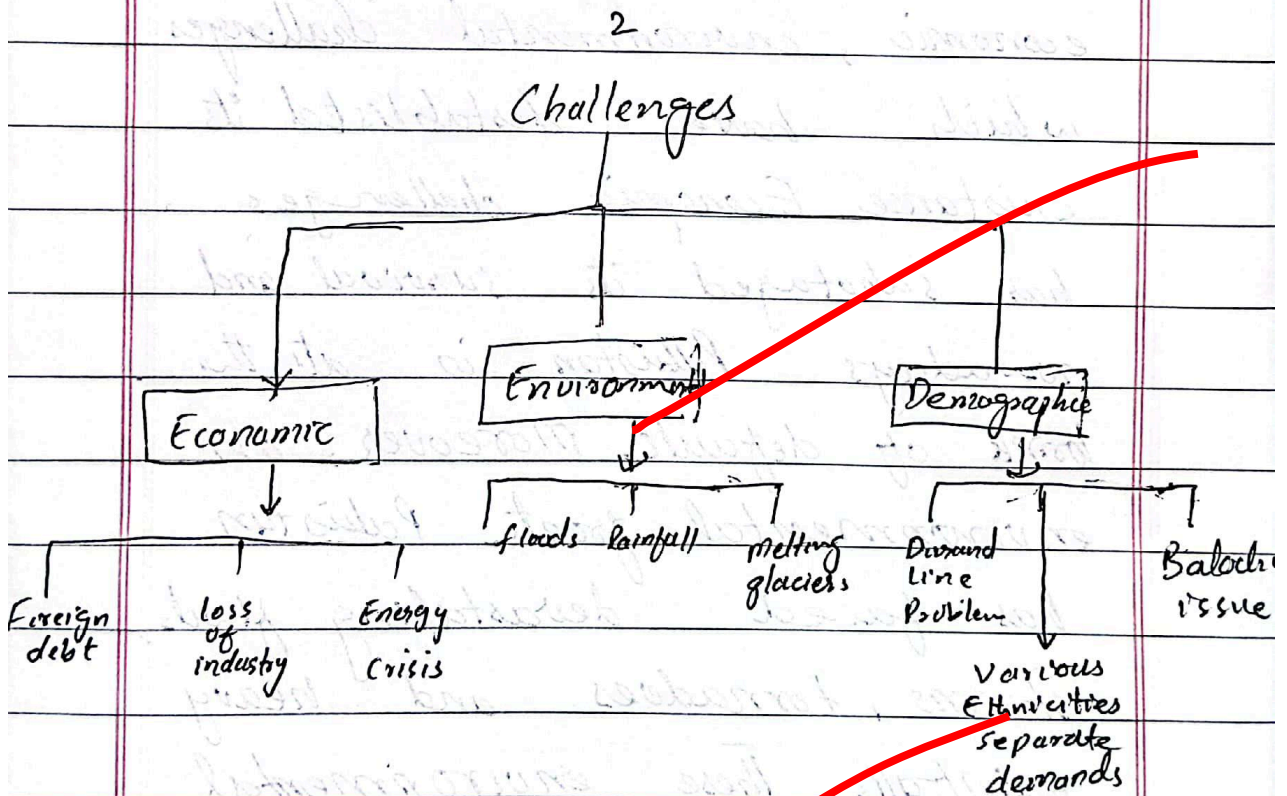

Economic Challenges

- Foreign Debt

2- Industrial Loss

1- Floods

3- melting glaciers

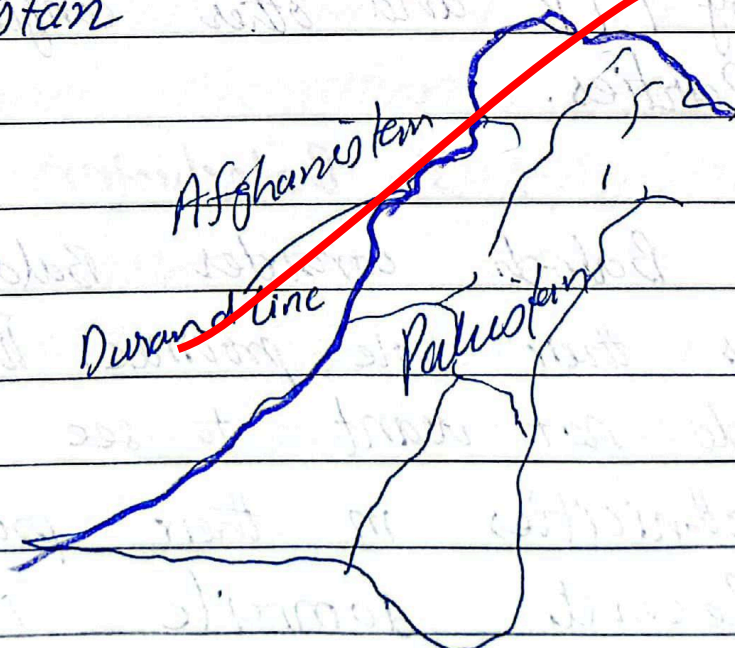
Glaciers are melting at fast speed which is not only environmental but also a economic challenge as in future it will cause water shortage and ultimately challenges economy of the country.

Pakistan's 2023 consensus result shows that Pakistan's population has crossed 24 Billions.

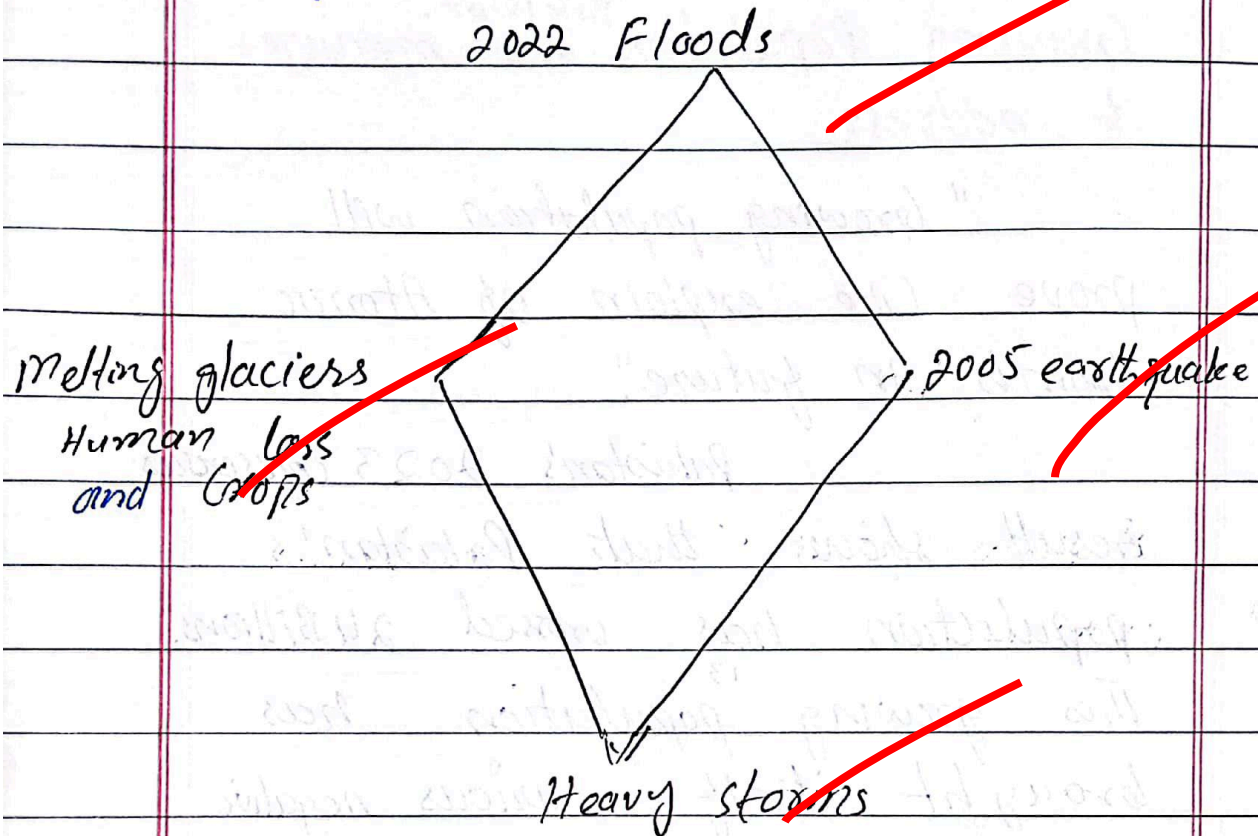
This growing ¹³ population has brought itself various negative implications. Various natural disasters has caused loss

3- 2005-Earthquake

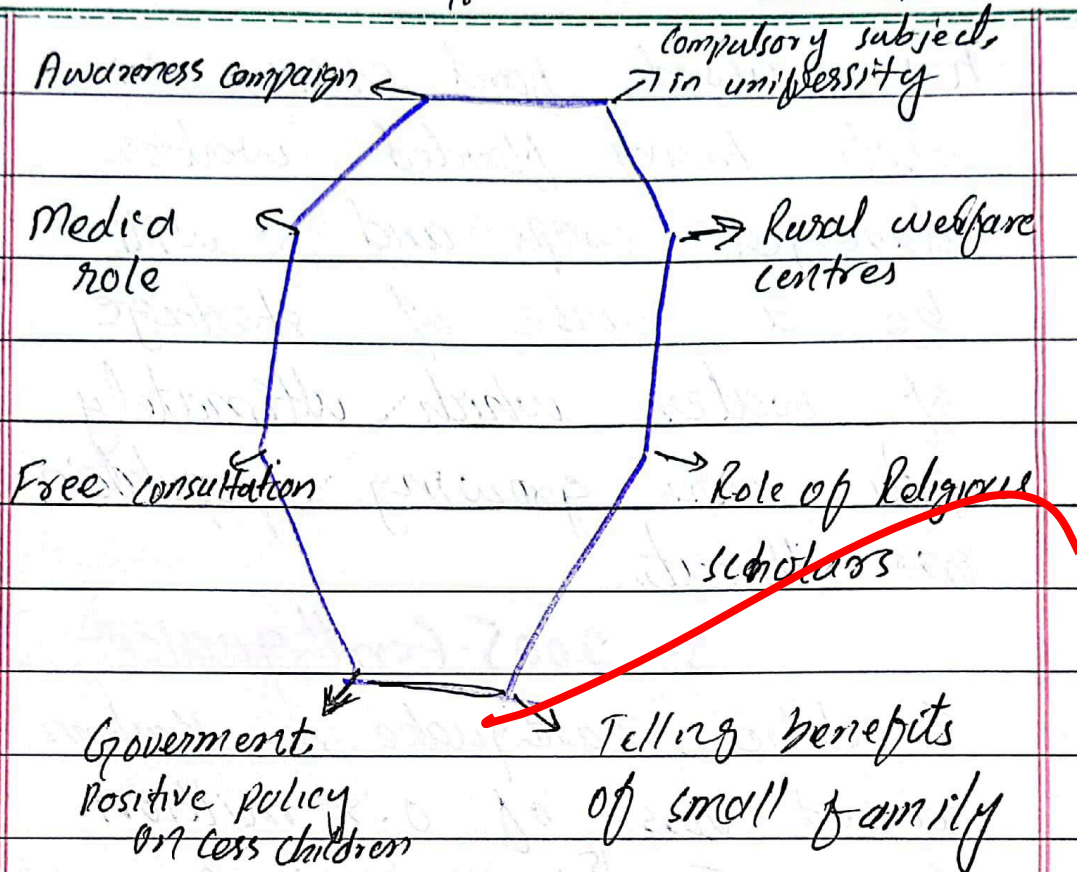
8 October earthquake in Kashmir caused loss of 0.8 million lives. This is a natural effect to cleanse population.

7- Small family Benefits Campaign

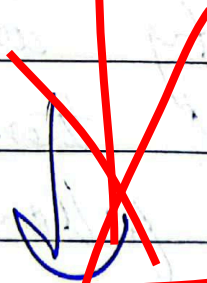
Small family benefits campaign should be started so that people can benefit from

Translation of Holy Quran into Persian

wrote books on muslim downfall

wrote book on economic issue of government.

Invited Siraju dulla from Afgani etc. to defeat Marhata

Preached teaching of Islam

1- Translation of Holy Quran into Persian:

Shah Waliullah²¹ Mohodas Dehloi was a famous scholar and wrote hundred of books and his famous book is "Hajjatal Blaiqha".

He translated Holy Quran in Persian language after returning homeland from Hijaz. The basis purpose of this translation was to raise awareness

regarding teaching of Islam.

2 - Books on Muslim

Downfall in Subcontinent.

He wrote many books to make people aware about basic reasons of Muslim down fall after Aurangzeb Alamgir's death. He tried to awake ²² Muslims to acquire their lost status in the region.

3 - Invitation to Nawab

Sirajudullah to Defeat
Marhattas

He wrote letters to Sirajudullah in Afghanistan to curb the growing influence of Marhattas in middle of subcontinent. He came and attacked Marhattas due to which they became very weak.

4- Preaching teaching of Islam:

He started ~~teaching~~ values of Islam in subcontinent after acquiring knowledge of Islam from Hijaz.

Sheikh Ahmed Sirhindi Services:

2. Force against

Akbar Deen ilahi

He stood firm against
Akbar deen - e - ilahi which
was made by Akbar in
which Hinduism and
Islam was mixed. The
one reason ~~of~~ of this belief
was of his various hindu
wives and wazirs in
his court. Emperor Akbar
incarcerated him as a
punishment when he denied
prostration in front of him.
Akbar's son Jahangir released

him and awarded him with gifts and gave him Royal place to live.

3 - Preaching of Islam.

During his stay in Mecca he never stop teaching of Islam. His previous work benefited people through his writings.
