This is almost $\frac{1}{10}$ one in ten children world wide. Nearly 1 in 10 children are subjected to child labour world wide, with some force into hazardous work through trafficking (UNICEF, for every child).

A 2022 study carried out by the International Labour Organisation revealed that one in every four households in Pakistan employ a child in domestic work. The study further highlighted that child domestic labour is prevalent across all

Like wise, lack of technical education can also be considered

In modern world, where the use of Artificial Intelligence (A.I) is expanding in every sector but majority of individuals even lack basic computer / technological skills to operate such helpful tools such as ChatGPT, Chatbot and others. Apart from these technological skills, other life skills are also required to be learned in order to face the short comings of life.

After discussing factors responsible for child labour, it's time to have a glance on the consequences of child labour. To start with, this is

the deprivation of child from educational institutes. Children involved in child labour have zero access to school life which fall them short in current race of modern technology. remains poorer. All of the

by the owner. No matter,

how much work labour perform / do, he'll remain deprive and will be paid fixed wages.

Furthermore, health issues and wellbeing is also one of the hurdles faced by child labour. Children at young age are not well exposed to different hazardous chemicals.

They experience different health issues such as mental, physical or psychological. Children working in industries, mines confront different harmful chemicals that lead them towards different incurable diseases.

In addition, there is rise in human trafficking due to child labour, because children can easily be exported from one place to another and has

good demand in international market because they are great asset in coming years for mafias. These children between the age of 10 to 14 are youngsters in coming age which can be put well in use for different works.

Similarly, low income families are more vulnerable towards child labour. Low-income families or having no source of income faces more difficulties in their life. According to ILO, 9% of all children in lower-middle-income families and 7% of all children in upper-middle-income countries, are in child labour.

As far as the recommended solutions for criminal neglect of child labour are concerned,

They can be many. Firstly, role of law and relevant authorities. Government and as well as concerned departments should come forward and take bold steps to address the issue. According to article 11 of the 1973 Constitution of Pakistan, paid labour performed by children under the age of 14 is ~~often~~ categorized as child labour. Government should introduce new policies either to stop child labour completely or to introduce new program in a way that with in two years, the course (instead) should teach all the skills to his labour aged above 15, so that he can further carry on the same task and can get the opportunity to stand on his own feet.
