Every community faces challenges and so too does the Muslim Ummah. The challenges to the Muslim Ummah have persisted over a long period of time and their intensity has increased exponentially. The challenge of Islamophobia presents a social and physical threat to the Muslim community which is external in nature. On the other hand, extremism is the narrow interpretation of Islam which is mostly for the benefit of certain bodies. This threat is internal in the Ummah. Both challenges present far reaching challenges for the Muslim and will be discussed in the context of the contemporary Muslim world in this answer.

Challenge of Islamophobia in the contemporary world

social integration is necessary for progress & Islamophobia, the fear of Islam, forces the Muslim community into a corner and prevents them to form a cohesive part of society which challenges their progress.

Battle against The Hijab

The western community especially the so-called secular groups have developed an obsession with the hijab. This piece of cloth is considered a existential threat to their social fabric (Rafa Zakaria). For example, in France - the Hijab ban has been popularized to attack the Muslim community and force them to assimilate into French and overall western culture. This presents a threat to the ideals and practices of the Muslim community. The hijab was made compulsory in Islam in SAH and the Islamophobia forces Muslim women to not practice the true essence and teachings of Islam.

Racial profiling in employment prevents Muslim progress

Muslim men and women are discriminated against during the



employment process and after being employed as well. For instance, they may not be employed due to the way they look while having the right credentials for the job. For example, they may have a beard or wear the hijab. Moreover, they may be discriminated against at work. This was referenced by Arsalan Iftikhar in his book 'Fear of the Muslim Planet' which cited a study where Muslim women felt prejudice at their place of work. This ensures that the Muslim community cannot make economic progress as they have difficulties in employment.

Increased surveillance after 9/11

Muslims are constantly being monitored in the west due to Islamophobia. The FBI, for example, particularly monitors calls and activities of Muslim men and women. Moreover, after 9/11 there was an increased surveillance of mosques along with resistance to build new mosques (Arsalan Iftikhar, Fear of the Muslim Planet). This hinders the Muslims to fully and comfortably practice their religion as they are socially prevented.

Increased and Intense ~~at~~ airport checks

Travelling has become a source of anxiety ~~and~~ for the Muslims. If an individual watches the stereotypical image of a Muslim man or woman, he spends hours at the airport with increased questioning and sometimes, disrespect. This anxiety creates mental health problems for the Muslim community.

Excuse for war on Muslim countries

Islamophobia has wreaked havoc on the global stage as countries often go to war based on ideologies. Islamophobia can be cited as the reason for the Palestine-Israel conflict. The current war against Gaza since October 7th which has resulted in the death of more than 30,000 civilians is because western countries view Muslims as a threat. The subjugation and oppression of Gaza was ignored ~~to~~ since 1948 and now the retaliatory strike on October 7th is used as justification for terrorism. The contextual dynamics of the crisis are ignored ^(Furgan Khan, 'The Evolving Dynamics of the Israel-Hamas Conflict, 2023). Hence, Islamophobia presents existential threats to Muslim countries.

Increased instances of Muslim Targeting

Islamophobia is used as a cover to has resulted in gunmen targeting Muslim groups that are innocent. For example, recently, a man killed a 6-year-old boy in ~~Illinois~~ Illinois by stabbing him to death because he was Muslim. More incidents such as the Christchurch mosque ^{where 51 were killed,} attack in New Zealand, also presents challenge to the Muslim Ummah. What's interesting is, the Christchurch ~~that~~ mosque gunman cited the concept of 'The Great Replacement' which is the increased migration of the Muslims as one of his motives. So Islamophobia is an excuse for blatant racism.

Challenge of Extremism in the Muslim World

widening schisms ^{in the Muslim Ummah} and sectarianism

Extremism presents an internal threat in which the Muslim community becomes divided. The extremists claim to hold the True Islam whereas the same is claimed by the liberals (Khaled Abou ~~Ed~~ EL Fadl, The Great Theft: Fighting Wrestling Islam from the Extremists). This creates a wide gap between two different groups in Islam and causes disunity.

Increased sectarianism

The Muslim community was over the right Islam in their respective sects which creates another factor of widening gulf between the two. The teachings of the Quran are ignored which says

Indeed, All Muslims are brothers...

Hence, the Muslims remain divided.

Clash of civilizational mentality adopted

Extremism facilitates an us versus them mentality. This was promoted by Samuel Huntington in his essay 'The Clash of Civilizations'. The Muslim extremists follow this path and try to attack the non-Muslims by declaring jihad on them such as what ISIS-K is doing. The concept of jihad is ignored in this case and so are the rules.

"And fight in the way of Allah those who fight you and do not exceed limits, surely Allah does not love those who exceed limits" (2:190)

Economic isolation due to extremism

Economic isolation is deadly in today's world and extremism is isolated in the world community. For example, Afghanistan is isolated due to its fundamental interpretation of Islam and is not ~~being~~ recognised by the world community which means it cannot form economic ties effectively and progress. This results in poverty and hardship for the people.

Inability to focus on academic excellence and civilities

Extremism has led to the Muslim community unable to function along academic lines. Previously, scholars like Alwarazmi, Ibn Sina and Ibn Khaldun ~~had~~ among others had provided the Islamic civilisation with progressive ideas in sociology, mathematics and medicine. However, centring on extremism has led to academic decline.

Overall, Extremism is a bigger challenge

Introduction

Islam is an all encompassing Deen that includes the principles of Good Governance. Muslim leaders are taught the main principles to ensure the society runs smoothly and welfare is the top objective. Modern states can benefit from these principles because a blueprint is provided for the Muslim community leader and no ambiguity is present. Some principles include taking care of the poverty-stricken people, collection of ~~to~~ zakat, protection of minorities and welfare approach in trade. In this answer, the principles of good governance and benefit to modern state ~~and~~ will be discussed.

Principles of Good GovernanceTolerance and protection of minorities

Good governance includes the protection for all especially minorities. In Islam, minorities cannot be forcefully converted and are free to practice their religion. This ensures peace and stability in the community. The Quran says:

لا اراة في الدين

"There is no compulsion in Deen."

(2:256)

This was practiced by the prof of Prophet as ~~with~~ Jewish, Christian and Pagan tribes lived in Medina and were under the same contract as the Muslims - The Charter of Medina (622 AD).

Collection of Zakaat

An efficient economic welfare system constitutes as good governance. Zakaat is a wealth collection from Muslims in order to distribute wealth in the community so no one suffers from poverty. This includes a 2.5% on wealth or 62.5 ^{tolas} grams of silver or 7.5 tolas of gold or 40 goats ~~among~~ or 5% on unirrigated land or 10% of irrigated land among other methods. Zakaat is not burdensome and indicates welfare in society and the economy.

Looking after soldiers and military personnel

Hazrat Ali (R.A.) highlighted the 20 characteristics of good governance to Malik Ashtar (Governor of Egypt) one of them

was looking after the military which protected the people of society. This would be through providing good lodging and welfare as well as effective training and discipline to ensure they were in good shape.

General Rule of Law

Good governance in Islam includes accountability for all no matter the status of the individual. The importance of this can be seen by the fact that Hazrat Umar (R.A) also presented himself in front of the court on some occasions to defend himself. Moreover, the Prophet also promoted this by example saying on the incidence of stealing that "Even if Fatima, daughter of Muhammad, had committed theft, I swear by Allah, I would have cut off her hands".

Fairness in Trade Practices

Trade practices should be fair and reliable. The seller should not ask for a higher price and the buyer should not heckle the seller unreasonably. This would ensure a fair transaction and

adequate profit for the seller.

welfare of the many over the few

The welfare of the mass majority should take precedence over the few. When majority is satisfied, the community will thrive. However on the other hand, if only a few (particularly the elite) are the only beneficiaries of good governance, there will be instability and discontent.

Abiding by the Islamic teachings and principles

At all costs, good governance should follow the teachings of Islam and never stray away. For example, one must not legalize haram things for the sake of secularism or liberalism. Instead, strict abidance of Islamic teachings must be maintained. The Quran says:

"And be steadfast in prayer, pay regular charity and bow your heads with those who bow down"

"No women should be married without consulting her..."

(Sahih Bukhari)

Right to life and sui of female infanticide

Since the time they are born, women have rights. ~~then~~ Baby girls cannot be killed based on their gender and must be raised properly and in parallel to the sons in the family.

"And when the female (infant) buried alive - is questioned, for what crime was she killed..."

(81: 8-9)

Right as mother

A mother is granted certain privileges and rights in Islam. Their position is upheld in Islamic society. For example when a companion asked the Prophet (SAW) who is worthy of his companionship, the Prophet replied 'mother' twice and then father. This shows the rights of a mother.

Right of wife

Islam grants rights to women as wife. The wife is to be loved and respected. The husband must help her in ~~her~~ easing her burden and emotionally fulfil her needs. The Holy Prophet (SAW) used to help in the home by doing the household chores and ease the burdens of his wives.

Status of women in Islam

Parallel to men

Muslim women have a status parallel to men. They are granted right to own property, seek education and employment. The Holy Prophet (S.A.W) also said that if a father took

case of his daughters the same as men, ~~that~~ ^{he} and the Prophet (S.A.W) would enter ~~paradise~~ ^{Day of Judgement}, like this (he held up two fingers) indicating together.

Status

Above men in some contexts

In parenthood, women are granted a status over men. As the previous example states: Mothers were granted worthy of company twice before fathers. Hence, mothers are elevated in status in some contexts.

Role of women

As social support for men

Women's ~~are~~ ^{role} is to provide companionship and emotional support to their husbands. Hazrat Hawa (R.A) was created out of the rib of Hazrat Adam (A.S) and provided support for him. Similarly, Hazrat Khadija provided support to Hazrat Muhammad (S.A.W).

Producing future generation that is pious

As mothers, women's role is to teach their children in Islam and provide

the Muslim Ummah with pious Muslims.

Thus, the women in Islam are charged with the duty to inculcate Islamic morals and teachings in their children.
