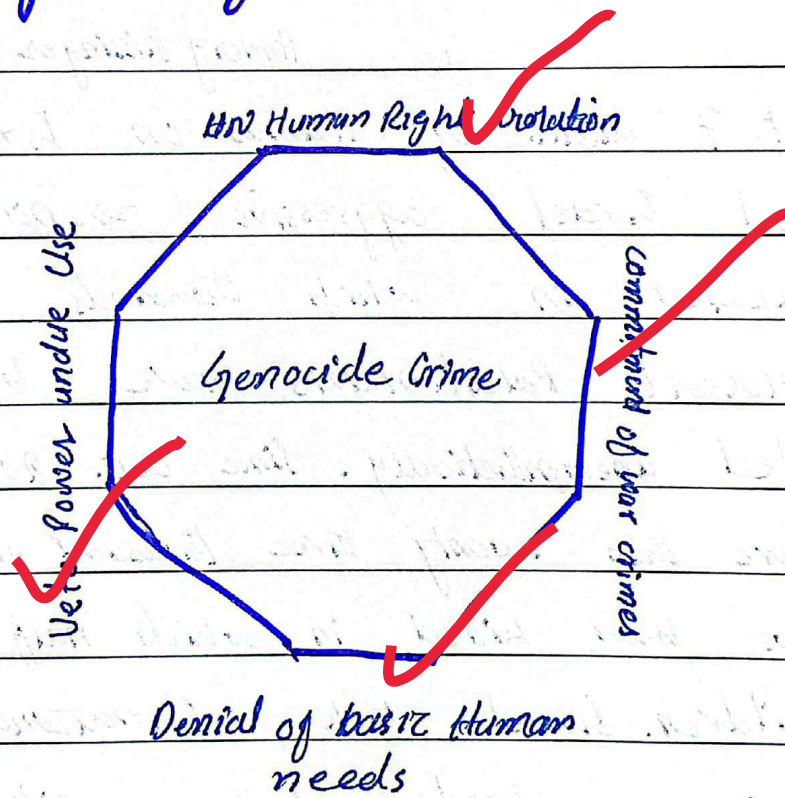

country which comes in favour of Palestine.

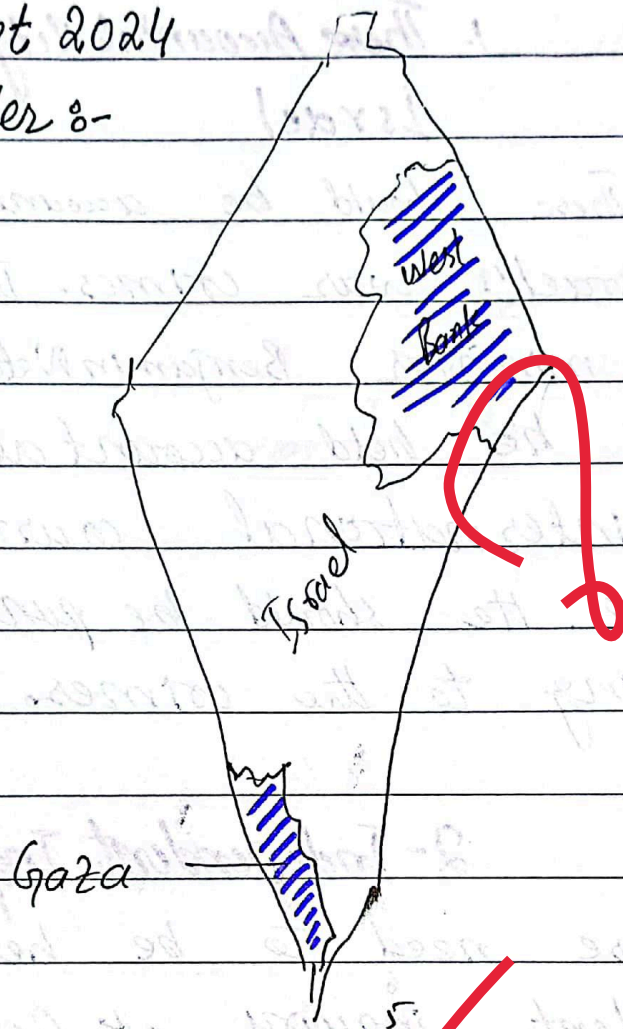
4- Denial of Basic Human needs

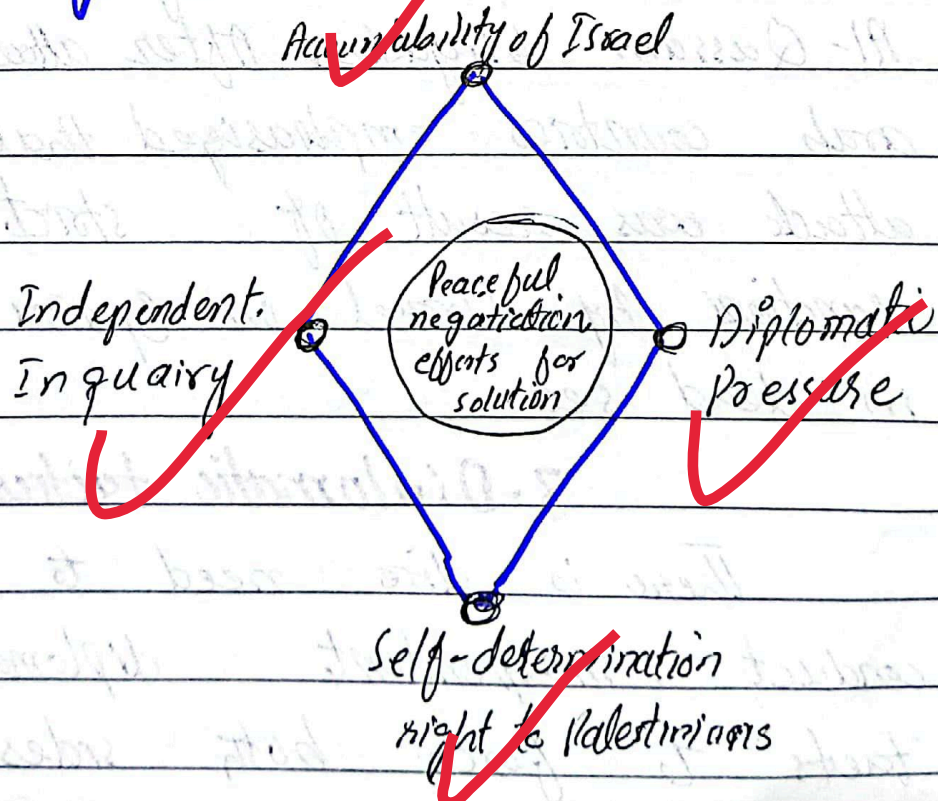
5- War Crimes Commitment

5- Palestine Independence Efforts.

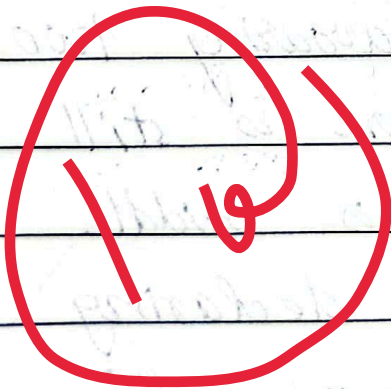
United states of America

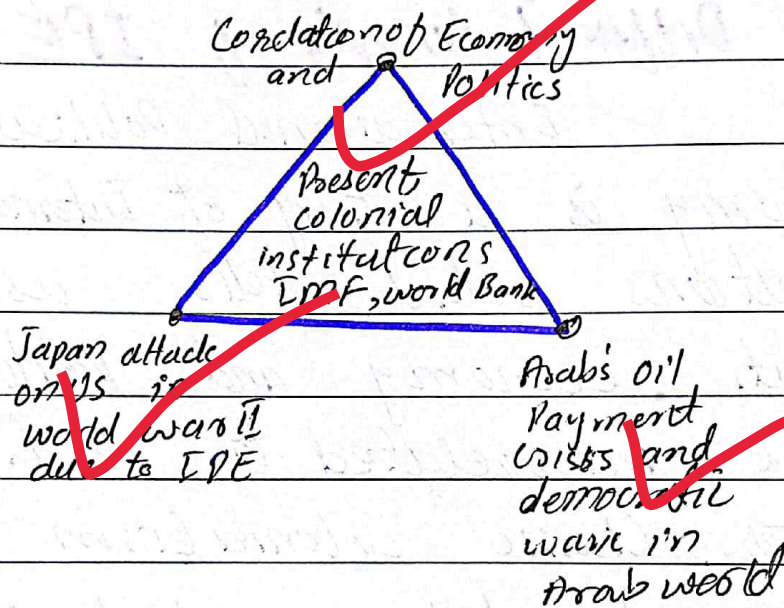

By using International Political

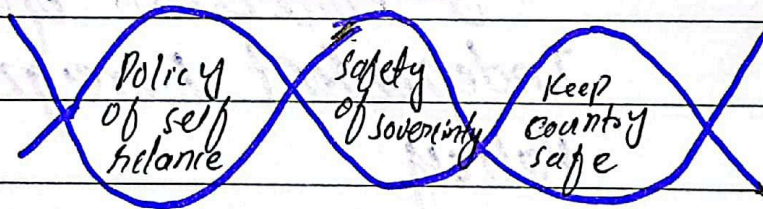

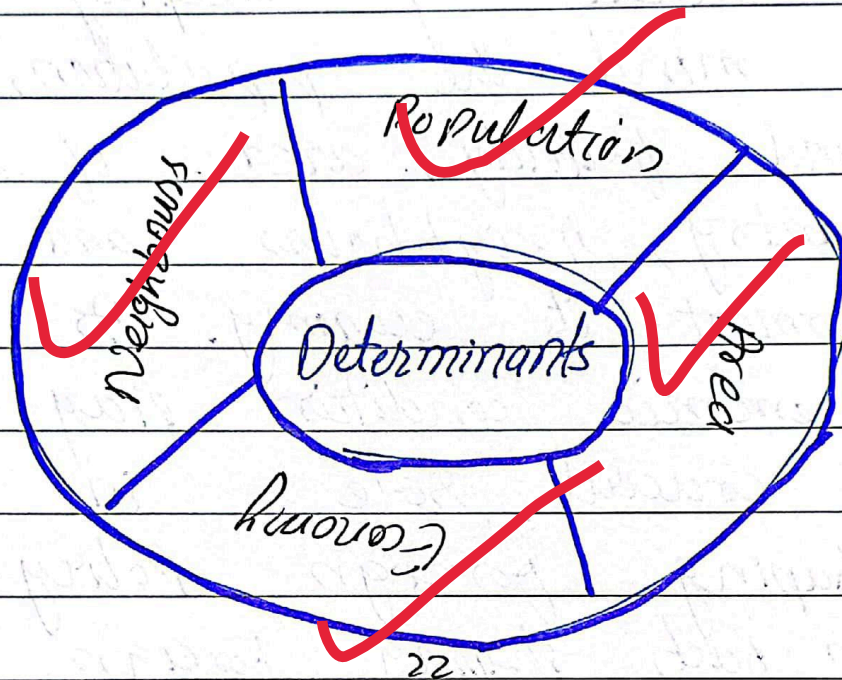
Introduction; Foreign Policy a complex process

3- Neighbour countries

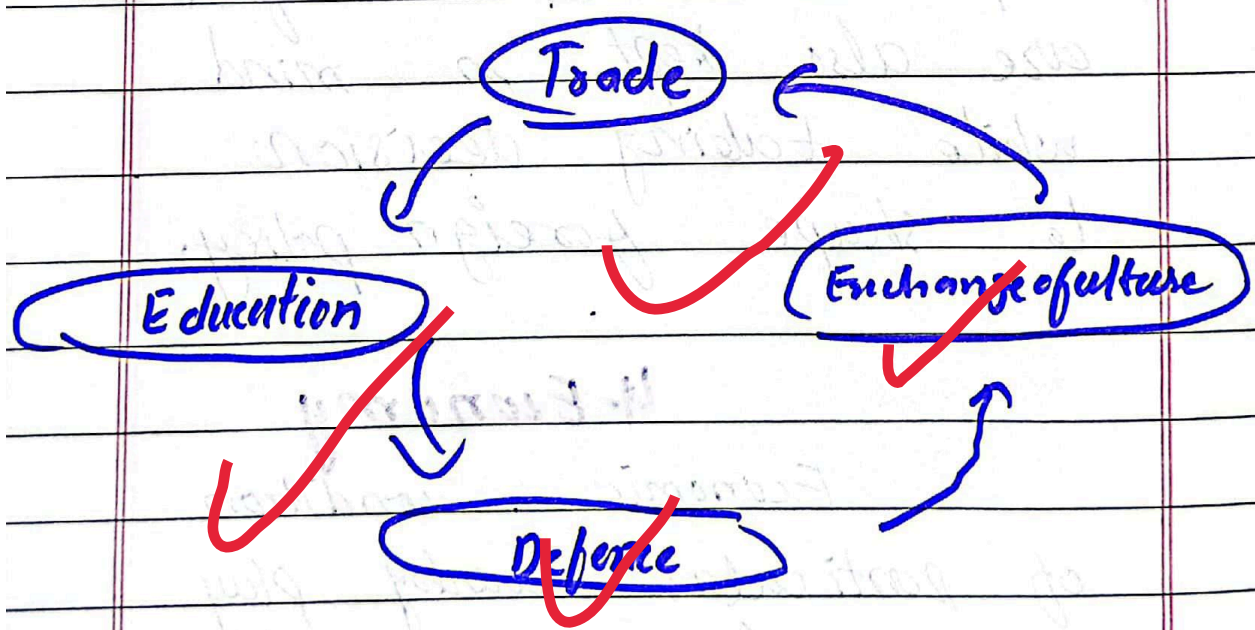
Neighbouring countries behavior and rivalry and cooperation in various parts are also kept in mind while taking decision to shape foreign policy.
