China •

- He threatened to cut intelligence sharing if they did not exclude 5G equipment made by Huawei from their telecoms networks.
- He is likely to press the EU and the UK to align with his policies on China, including restricting exports of sensitive technology.

Climate Politics •

- Trump withdrew from the Paris Climate Agreement.
- He boasts that he would reverse many of Biden's measures to decarbonize the US economy and withdraw from the Paris Climate Agreement again.
