### Strategic Interest:

US has many strategic interests in the region. That's why the US is silent on this issue. US maintained a rift in the region and constantly supplied weapons to the Israel. Like Israel, Kashmir is an historical zone of contention of Britain. ## Contain Influence of Russia and China:

US wanted to maintain an iron clad relation with Israel to counter the influence of China and Russia. Although both countries have shown a soft stance even in the UN but the US vetoed it. By maintaining friendly relations with Israel - US will be in better position to contain Russia and China.

## Strong Influence of Israeli Lobby on American Foreign Policy:

## Affect of US Policy on the Relation with the Muslim World:

### Relations with Egypt:

Egypt was the first Muslim country to recognize Israel and build relations. But now due to Israel-Gaza conflict the US has repeatedly called on Egypt to open its crossing but Egypt denied. When almost every Palestinian is frozen in taking refuge in Rafah and the Israel starting bombing Gaza. Rafah.

In this situation Egypt warned US of deploying its nuclear weapons when Israel proceeds further.

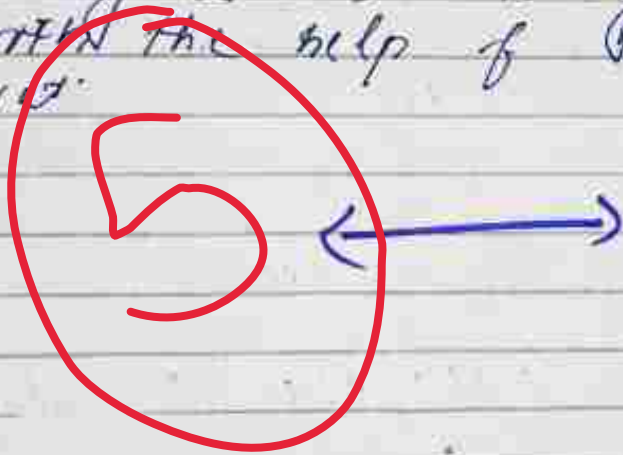
Apply for the membership of EU:

### Introduction:

CPEC is a \$66 billion investment of China in Pakistan. signed in 2013 and started the construction of infrastructure. CPEC has divided into the three developmental phases. First phase has been completed and now the second phase has started started with a greater pace but now the projects have become increasingly slow. Slowing down of these projects finds the root causes in the political instability, economic crisis and security concerns. So certain steps should be taken to tackle these issues.

### Reasons of slow Progress of CPEC projects:

#### 1. Political Instability

Political instability in the country leads to the slowing of CPEC projects. As the first phase has been ended in the 2020 and the second phase started in 2024 with 4 years late.

This happens because of political turmoil in the country as the PTI Khan's government was toppled and a new PPP government took power with weak mandate to negotiate the Chinese government.

## 2. Economic Crisis

Pakistan's economy was on the brink of default. It seeks loans from the IMF with the tough conditions and already a debt ridden economy. So the because of above mentioned reasons Pakistan was not able to take the projects at greater pace. It is negotiating many projects like CPEC due to economic recession.

## 3. Terrorism

Terrorism has been a major issue in slowing the projects of CPEC. Due to this workers are not willing to work at the sites. Recent attack on the Chinese workers in the Daska Dam and in Gwadar makes urge the Chinese authorities to express concerns to Pakistan. As the communist leader on his recent visit expressed concerns only on terrorism.

## 4. Bureaucratic Hurdles:

CPEC projects have witnessed a slow in their pace because of the bureaucratic hurdles also and red-tapism. Late approval came from the bureaucracy and land acquisition issues are common. As one recipient that when a foreign investor came to Pakistan and go to DC office for approval. After waiting for 2 hrs he left the country.

## 5. Blasphemy Related Issues:

Some Chinese workers are involved in the blasphemy. Some of them were indicted from the courts also. This poses a major halt in the progress because the work at these sites. Recent incident came at the site where a Chinese worker was rescued after from the site in fear of mob attack.

## 6. Soaring Debt of these projects

As the US once said that the Chinese BRI is the debt trap strategy of China. As it seized the Sri Lanka Hambantota port because of the default of Sri Lanka because of its debts. So Pakistan should re-negotiate some of the projects as these projects are increasing debt paving the way for other projects to go on.

## Solutions to increase the pace of CPEC Projects:

### 1. Bring Political stability

Political stability is necessary for the greater pace of the projects. Therefore all the political parties should find a consensus and like SIFC form a body to only monitor the issues related to CPEC. Without the consensus and political stability the projects of CPEC would not complete on time.

## 2. Bring Economic Prosperity:

Economic prosperity is essential for the actual going of CPEC projects. Therefore, to bring economic prosperity it is necessary to increase exports and earn foreign exchange reserves. Not only the infrastructure will improve but also go at greater pace.

## 3. Combat Terrorism:

Combating terrorism is one of the biggest challenge to the Pakistani government. Recently many terrorist attacks are carried out by the TTP and the Chinese government termed it one of the biggest challenge to CPEC. So the government has started Azm-e-Istehkam operation to combat it.

## 4. Remove Red Tapism:

Remove the bureaucratic hurdles and red tapism because these hurdles are the delaying tactics. CPEC should be free from any such difficulties and form an independent and neutral body to look in these projects.

## 5. Acclimatize the Chinese Workers:

Before going the site Chinese workers should be educated about the basic Islamic principles and norms which hurt the feelings of common citizen. So that the smooth working should be ensured.

## 6. Restructure Debt:

A committee should be formed to re-negotiate the debt which are soaring. This will ensure the less economical debts also easing the economy. A recent example is ML-04, whose initial estimate was \$9b which brings down to \$6-7b after negotiation. Easing the economy and projects.

## Conclusion:

Although there are certain challenges related to the political instability, economic crisis, terrorism, red tapism and ~~huge~~ debt soaring, yet the government is striving to address these challenges like to combat terrorism. Govt. started ALM-i-Intisam. We hope for the best in future.
