Introduction:

The Government of India Act 1935, was promulgated in 1937. As per the Act, it was decided that Elections to the provincial and central Assembly would take place in the first weeks of 1937. Muslim League and Congress, though both were critical of the Act yet they decided to participate in the upcoming Elections. The results of the elections were disappointing for the Muslim League and it dealt a death blow to the any effort for united India - the atrocities perpetrated by the Congress ministries expedited the freedom movement and ultimately Pakistan emerged on the global on August 14, 1947.

Elections of 1939

The Elections of 1939 were fought by the Muslim League and the Congress on different objectives. Muslim League wanted to replace the current provincial and central constitution with democratic political system. Congress fought for the welfare and well-being of the Indians.

Outcome of the Elections:

The outcome of the elections was quite astonishing. It created unprecedented ground in the Congress circle and shattered the hopes of the Muslim League. As per 1937, Congress formed ministries in 7 out of 11 provinces. Muslim League formed government in Punjab, Bengal, Sindh and Assam.

Congress Ministries:

Following activities were perpetrated during Congress rule of 1937-39.

1. Abolition of Zamindari Bill

in Punjab:

In Punjab the Zamindari Bill was abolished. Because in the Punjab majorities of the cultivators is Muslims while landlords were Muslims. The abolition of Bill exempted landlords from paying agriculture tax.

2. Retainment of Zamindari Bill

in Bengal:

In Bengal, the Zamindari Bill was retained because here the situation was contrary to that of Punjab. Here majority of cultivators was Hindus, whereas, landlord class was Muslim.

3. Verdu Scheme:

Verdu scheme of education was introduced in schools and colleges, where Hindu religion and culture was preserved. It debarred Muslims from getting their religious education.

4. Bande Mataram as National Song:

Bande Mataram, the Hindu Patriotic song which is offensive to Muslims was declared as the national song and was sung on the occasion of all official meetings and in Assemblies. Gandhi declared

Bande Mataram was declared to Bharat Mata ki Jai.

5. Ban on Cow Slaughtering:

Hindus put a Ban on the sacrifice of the cow. For them "the slaughtering of cow was tantamount to the dissection of India".

6. Vidya Mandir Scheme:

Vidya Mandir Scheme introduction caused muslim students to learn about the Hindu culture to no oblivion of their own culture.

7. Glorification of Hindu Heroes:

Congress rule glorified the Hindu Heroes to the extent of worship. The Rama, Krishna, Lakshmi and many other heroes were praised as gods.

8. Ban on Muslim Religious Rites:

Muslims' religious rites were not celebrated during the atrocious rule of congress ministries of 1937-39. Drums were beaten when they congregated in mosques to perform obligatory prayers etc.

Way for Pakistan's Emergence:

The congress rule of 1937-39 opened the eyes of muslims to the ill-will of the congress, and paved the way for Pakistan. After the resignation of congress ministries, as a result of forced inclusion of India in WWII, between Oct-Nov 1939, a day of deliverance on 22-Dec-1939 was celebrated for the freedom from the

Demerits of Presidential System:

1. Political Gridlock:

2. Nepotism / Spoils system

3. Authoritarian Tendency:

The president is solitary in the exercise of powers that lead him to adopt authoritarian and aggressive foreign policy.

4. Removal of the President:

The president is removed by the cumbersome process of impeachment. Up till now not a single president in US is impeached which gives him the leverage to adopt cruel and aggressive policies.

Merits of Parliamentary system:

1. Result of consensus across the Political spectrum:

Parliamentary system is the outcome of wider political consensus. Although Mr. Bhutto tried to adopt presidential system but failed owing to opposition from his own party members.

2. NO Despotic Tendencies:

The PM cannot adopt despotic tendencies because he can be removed from his office through a vote of no confidence once sensed adopting despotic tendencies.

3. Qualification to become a Minister:

There is a condition to be a member of Parliament to become the ministers. It does away with nepotism or spoils system in Parliamentary form of government.

4. Tilt towards Harmony:

The PM steers the ship of government by tilting towards the harmony. He cannot ignore the will or ill-will of Parliamentarians in the adoption of the policies.

Demerits of Parliamentary System:

1. Parochial Politics:

Parliamentary system breeds parochial politics. MNAs and MPs show inclination towards their areas. They prefer parochial interests at the expense of national interests.

2. PM under undue Pressure:

PM can be easily blackmailed in the parliamentary form of Govt if he goes against the wishes of the Parliament.

3. No security of Tenure:

Vote of no confidence renders PM to at tenterhook, as he can be removed anytime by simple majorityes.
