Special Investment Facilitation Centre (SIFC) is introduced by the **SECP (The Securities and Exchange Commission of Pakistan)**.



Israel-Hamas war one of the leading issues circulating across the globe with term named as "massacre". Massacre of about **37,000 innocent civilians of bleeding Gaza** most of them are children, women and elderly people. The war started by the Hamas attack now engulfed whole Palestine in its flames. Israel atrocities are still going on despite of the legal notices from **ICJ (International Court of Justice)** because of back of major power named as **USA**. The ongoing genocide in Palestine started from **Oct 7**, region of Gaza strip reached to Rafah recently and vowed by Israel to end up on **Hamas**. The Israel with back of **hegemonic power (USA)** is showcasing its brutality across the globe. While the anger rifts are blowing across the globe due to unaccepted brutal behavior Israel is showing. that ongoing fire of Israel will cover the whole region because of her fierce flames. Israel is now independent enough due to back of USA that she is not ready to follow the guidelines and resolutions of internationally accepted peace forum (**UN-UNITED NATION**) without fear of being sanctioned.

This atrocity of Israel is provoking the rages among the communities and leaders of various countries that may cause an event in near future that will spread this war. **Iran** entered the war by opening the missiles towards Israel but back out due to some political causes.

Moreover, it will be possible that other countries having **nuclear capabilities** may intervene in the war which poses permanent footprints of destruction across the whole region. The expansion of war would cause the situation in which

global alliances will reshape, influencing energy markets and challenging the current international order. The dire need is to stop ongoing assault in Palestine by diplomatic talks with Israel and increased intention of world towards escalating issue so that a wider and more destructive conflict can be resolved.

History of Israel - Hamas War -

The war started by the attack of Hamas on Israel's territory resulting in the killing of **13000 civilians and some security personnel**. In return, Israel opened the mouths of their tanks and rockets at Palestine on **Oct 7, 2023**.

That assault continued to the current time zone with mortality rate reaching up to **37000 civilians** including majority of children, women and elderly people. Israeli President **Benjamin Netanyahu** & unaccepted all the calls of ceasefire by international forum of peace; **UN-NITED NATION** with a stance that war will continue to maintain the integrity of Israel and will be ongoing until the end of **HAMAS**.

Involvement of Various International Players

UN (ICJ) → called for ceasefire but Israel denied b/c of veto of US.

→ **UN-**
United Nation called for ceasefire which was denied by Israel.

→ **South Africa-**
took the case of brutality in **ICJ** - as per "dawn editorial"

Chances of Expansion:-

Regional Alliances and Hostilities:-

1- Arab States:-

Various Arab states (ie UAE and Bahrian) have normalized relations with Israel but public opinion in these states is pro-palestine. That may cause internal rifts and damage these new alliances.

2- Iran:-

Iran's support for Hamas and Hezbollah raises the risk of a wider regional confrontation, especially if Israel targets Iranian interests or Iran responds directly to Israeli actions.

3- Hezbollah:-

The Lebanese militant group Hezbollah aligned with Iran, has the potential to open a northern front against Israel.
→ Clashes along the Israel-Lebanon border could escalate, drawing Lebanon into the conflict.

Impact on Global Power Politics :-

1- US Role:-

• Mess in Diplomatic ties

The unwavering support of US towards Israel result in messing of diplomatic relations with other states across the globe whose vision are pro-Palestinian.

• Energy Security:-

Escalating situation might cutoff oil supplies, affecting global energy markets and leading to higher prices, thereby influencing global economic stability.

2- Iran's Role:-

• Challenging US influence:-

Iran's with its support towards Israel might strengthen its position as a regional power by supporting Hamas and other anti-Israel entities, challenging US influence.

Possibility of escalating ^{war} in the region is influenced by the historical animosities and geopolitical interests that can lead to reshape the US position in world order and international energy market.

(Historical Background)


Afghanistan and Pakistan have had a complex and often contentious relationship since Pakistan's independence 1947. The Durand Line, a border
