# The Essay"

The statement means that sometimes the actions taken with good intentions can lead to negative outcomes. During WW-II the United States relocated hundreds of Japanese Americans to internment camps after the Pearl Harbor attack. Despite being born in the United States and being loyal citizens were forcibly relocated to internment camps. Many families were uprooted from their homes, and businesses and placed in remote and hard conditions. The internment camps, though formed with the good intention of national security, were a violation of the civil rights and caused lasting trauma. This shows how even in times of war, the road to hell can be paved with good intentions, as the national security led to the widespread violation of rights and dignity of entire community. Therefore, this essay would prove the veracity of the statement by the examples of individuals, on national and community, international level.

On the international level, first came the the great, biggest partition of India (1947).

The partition plan was implemented under the rule of Britishers to create separate homelands for Hindus and Muslims. The aim and good intention was to provide separate states so that political, ~~reg~~ religious, ethnic and socio-cultural conflicts can be

controlled. As a result the partition of sub-continent resulted in one of the largest mass migration in history. This leads to a widespread communal violence, killing and bloodshed. Especially women suffered greatly through abduction, and rape cases. This impact badly on the social fabric of both nations leading to regional tensions and mistrust. Similarly, ~~during~~

after WW-I, the league of nations was established through collective diplomatic efforts. The objectives of the forum were to promote peace and prevent future conflicts but unfortunately, the league failed to prevent world powers. Due to its failure WW-II came into exist that leads to huge bloodshed and community demolishing such as Hiroshima and Nagasaki bombing.

Moreover, with the similar positive intentions and objectives United state invades Afghanistan to eliminate terrorism and promote regional stability, however the invasion led rise of other non-state actors within Afghanistan and neighbouring states i.e (TTP) in Pakistan as well.

Second comes on community level where world's communities tried to bring state friendly resolutions or laws that leads nation-wide conflicts. Such examples include the Iranian compulsory Hijab law. The law was intended to enforce Islamic dress codes and promote modesty among women but resultantly the

The enforcement has led to widespread protests, and social ~~protests~~ unrest among women who view it as a violation of their personal freedoms. It has also resulted in significant legal and physical punishments for those who resist the dress code. The similar case is seen in 2022 Amini a 22 year girl faced to death on violating the hijab rules.

Moreover, the international polio vaccination campaigns in Pakistani communities faced more reliable setbacks. The intention<sup>s</sup> to eradicate the disease through proper vaccination in early ages, but some backward communities believe conspiracy theories that the vaccines are harmful. This leads to resistance and low vaccination rates, risking the spread of polio and hindering efforts to protect public health.

Third comes on national level where different nations worldwide proposed laws for community and national interest, which resultantly face failures. For example During Atab Khan's era, family law ordinance was introduced in Pakistan to reform and improve family laws especially women's rights in marriage, divorce and inheritance. While the law introduced progressive changes, yet it faced strong opposition from conservative and religious groups. This shows that how good intentions can lead legal and social pushback that limits the

effectiveness. The same scenario is seen in the Benazir Income Support program (2008) which was introduced to support low income families financially, but due to
