Pakistan needs to bring elites under tax in order to improve economic growth. Another report in Express Tribune, government tax revenue is below than government spending. This reflects that major portion of elites are exempted from the taxes whose position is being held by the poor.

Some recommendation that the government needs to exercise for economic growth which will alleviate the pressure imposed by heavy taxes on the poor are extending tax network. Extending or broadening tax is what Pakistan needs today for its economic

growth. Many retailers and business are exempted from taxes. These people must be brought into taxes. Pakistan is facing a lot of smuggling issues. especially the border with Iran and Afghanistan. Many vendors do not pay taxes by using smuggled goods. Government of Pakistan needs to extend its tax network and bring these people under tax.
