2) **Unimaginative**: Not showing creativity or original thought in their rulings.

3) **Not active**: Being passive

and not taking initiative in their judicial functions.

01 4) **Not creative**: Failing to think outside the box or innovate in legal interpretations.

5) **Orthodox**: Adhering strictly to traditional methods or beliefs.

6) **Conventional**: Following established practices and norms without deviations.

7) **Conservative in law making**: Reluctant to make progressive or radical changes in the law.

8) **Over-practicing Judicial self-restraint**: Excessively limiting their own power and scope of influence.

**Titles bestowed upon Judges Include:**

1) **“Socially Reactionary”**: Indicating that the Judges

decisions or attitudes are perceived as opposing social progress or reform.

2) "The high priest of Rigid stare Decisis and the limited Role for the Judiciary": Referring to a Judge's strict adherence to precedent and a conservative view on the Judiciary's role. This title was specifically conferred on Viscount Simond.

Certain Judicial rulings might become controversial for several reasons:

01 i) Divergence from public sentiment:

when judicial decisions are out of step with prevailing public opinion or societal values, they can spark

Controversy. Decisions that seem to go against deeply held beliefs or emotional responses can lead to public outcry.

## 2. Ideological and political

**Factors:** Rulings that touch on hot-button issues such as civil rights, immigration, or other politically and ideologically charged matters can become flashpoints for controversy. These causes often reflect broader societal conflicts and can polarize public opinion.

## 3. Media amplification:

The media plays a significant role in shaping public opinion/perception. High profile causes are often sensationalized, and the nuances of judicial reasoning can be lost in the process.
