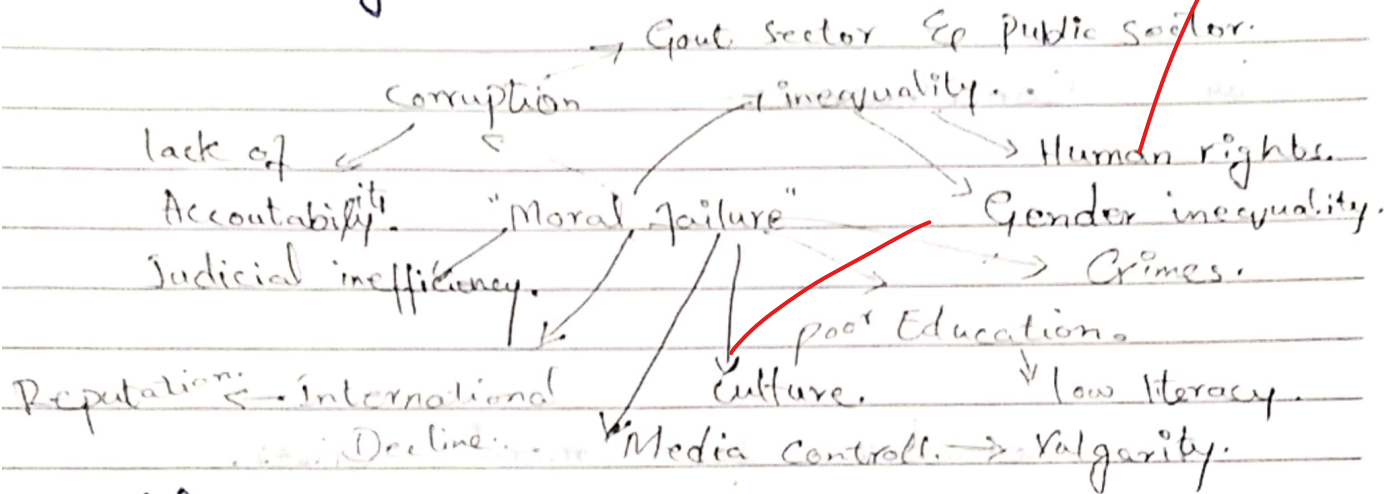

A brief view of Pakistan's socio-economic status and historical context reveals that a rich nation in potential is yet weak due to moral decline and internal decay.

Moral decline refers to the deterioration of ethical standards, values, cultural decline and principles in a society. Indicators of this decline is due to corruption, lack of accountability, social injustice, and lack of civil sense. These elements contribute to a society where trust is diminished, and the rule of law is compromised. Political corruption is the major issue of economic as well as moral decline in Pakistan. In Pakistan, government officials are frequently engage in practices that prioritize their personal gains rather than public services. This corruption diminished the trust between masses and government. The judiciary also plays a major role in this decline; inefficiencies and corruption with the judicial system injustice, compromised rule of law and moral crises. In the public sector, corruption affects common people through bribery, mismanagement.

Economic injustice is severe in Pakistan, with significant disparities between many social groups which is leading the

the society to social tension. Human rights are always violating, including no permission of free speech, killings, taking the innocent peoples to jails, harrasing them, enforced disappearance, etc. These abuses erode the fabric of society. Additionally, gender discrimination remains a critical issue which is still unsolved. The status of women in society, marked by limited opportunities, highlights the moral implications of gender-inequality in society.

The educational system in Pakistan fails to in ethical values, focusing instead on learning and exam-oriented system. According to economic survey of Pakistan, literacy rate of Pakistan is 62.3%. Approximately, 20m children are out of school between 5 to 16 years. This failure to critical thinking contributes to the border moral decline.
